PRELIMINARY OBJECTIONS.

**Khyber Pakhtunkhwa

1. That the appellant has got no cause of action.
2. That the appeal is bad for mis-joinder and non-joinder of necessary parties.
3. That the Appellant has been estopped by his own conduct to file the appeal.

FACTS.

1. Pertains to record.
2. Correct to the extent that Senior Member, Board of Revenue is the Competent Authority for service matters of the officers / officials under the control of Board of Revenue.
3. The tentative joint seniority list of Assistant/Senior Scale Stenographer offices of the Commissioners and Deputy Commissioners as stood on 31.12.2022 (**Annexure-A**) was issued after incorporating the name of the appellant in the joint tentative seniority list in light of Notification dated 01.07.2022 (**Annexure-B**).
4. Incorrect. The name of the appellant is included in the tentative joint seniority list of Assistant/Senior Scale Stenographer offices of the Commissioners and Deputy Commissioners as per Notification dated 01.07.202 which is still intact. Being different cadre he has no right for insertion in the tentative joint seniority list from the date of his initial appointment.
5. Incorrect. His objection / appeal (**Annexure-C**) was regretted by the Competent Authority (**Annexure-D**) being merit less and against the law/rules.
6. Incorrect. Section-8 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion & Transfer) Rules, 1989 (**Annexure-E**) are not applicable upon the appellant as he was merged in the tentative joint seniority list of Assistant / Senior Scale Stenographer offices of the Commissioners and Deputy Commissioners from different cadre therefore he has no legal right to disturb the seniority list of other officials.
7. Incorrect. The final joint seniority list of Assistant/Senior Scale Stenographer offices of the Commissioners and Deputy Commissioners was issued (**Annexure-F**) as per law/rules and no discrimination have been done with the appellant.

GROUND

- A. Incorrect. As the appellant belong to other cadre therefore, his name is included in the joint tentative seniority list of Assistant/Senior Scale Stenographer offices of the Commissioners and Deputy Commissioners from 01.07.2022 (From the date of Notification) **(Annexure-G)**.
- B. Incorrect. As mentioned in the Para-6 of the prayers.
- C. Incorrect. The Notification dated 01.07.2022 is still intact, through which the name of the appellant was incorporated in the joint tentative / final seniority list of Assistant / Senior Scale Stenographer offices of the Commissioners and Deputy Commissioners .
- D. Incorrect. The appellant is neither Senior Scale Stenographer nor Assistant rather he is Computer Operator / Computer Assistant which is a different cadre and has rightly been incorporated in the joint tentative/final seniority list of Assistant / Senior Scale Stenographer offices of the Commissioners and Deputy Commissioners from 01.07.2022 i.e. (with immediate effect).
- E. Incorrect. The appellant has been treated according to law/rules. The appellant concealed the facts from the Hon'ble Court as the appellant is a Computer Operator / Computer Assistant and not Senior Scale Stenographer / Assistant.
- F. Incorrect. As explained in Para-E of the grounds.
- G. The respondents will also argue other additional grounds at the time of arguments.
- H. No comments.

Keeping in view the above, the appeal of the appellant having no legal grounds may very graciously be dismissed with costs.





ASSISTANTS AND SENIOR SCALE STENOGRAPHERS (BPS-16) OFFICES OF
THE COMMISSIONERS AND DEPUTY COMMISSIONERS IN THE
PROVINCE AS IT STOOD ON 31.12.2022.**

Respected Sir,

The undersigned objector seeks to submit that the subject list has been published for circulation by the Board of Revenue, Revenue & Estate Department Khyber Pakhtunkhwa (hereinafter referred as Department) vide notification dated 08.12.2023 bearing No. Estt:/S.L/Astt/SSS/27168-27210 inviting objection within 15 days; and the same has been circulated with endorsement of even number and date. The name of the objector appears at Sr. No. 535 without mentioning date of birth i.e 23.05.1985 and Qualification of the objector i.e MA (IR), in the said list, which is not correctly allocated, if regard is had to the law contained in Section-8 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 17(4) of the Khyber Pakhtunkhwa Civil Servants (APT) Rules, 1989, and precedents of the department itself in previous similar cases. Therefore, insertion of objector's name in the subject list at wrong place is challenged with the submissions as follow:-

- 9. That undeniably, issuing of Joint Seniority List by inclusion of names of the objector and others was pending after Notification of the Department bearing No. Estt:/WP/3087-P/19/Azhar Iqbal Mughal/18628-35 dated 01.07.2022. and in the meanwhile, advice of the Establishment Department was sought vide letter No. Estt:/Azhar Iqbal/3928 dated 09.02.2023 (Annexure-A) about relevant place of their names in the list to be issued. In response to the said letter, the Establishment Department (Regulation Wing), Govt. of Khyber Pakhtunkhwa confirmed the advice given previously by it vide letter No. SOR.IV(ED)11-1/2023 dated 21.03.2023 (Annexure-B) with reaffirmation to settle the issue at department own level under Section-8(3) of Khyber Pakhtunkhwa Civil Servant Act-1973 read with Rule-17 of Khyber Pakhtunkhwa Civil Servants (APT) Rules, 1989; which is clear on the subject issue and leave no ambiguity.

10. That the Board of Revenue was required to issue the Joint Seniority List in accordance with advice of the Establishment Department but it was inordinately delayed. So, the objector resorted to filing of Service Appeal No. 1863/2022 dated 23.12.2022 before the Khyber Pakhtunkhwa, Service Tribunal, Peshawar. Said Service Appeal was disposed off in the terms as copied below.

"In this respect it is observed that the department shall make promotion from the seniority list which is prepared in the light of Notification dated 01.07.2022 and ultimately finalized. Copy of the same be handed over to all the persons so listed in the list"

11. That the Seniority list was not issued even after disposal of the Service Appeal No. 1863/2022 dated 23.12.2022 in light of the given terms; and the objector was compellingly filed Implementation Petition before the Hon'ble Service Tribunal. The Department was directed by orders passed in Implementation Petition to submit the compliance report and presumably, the subject disputed list has been issued to comply with the directions of Hon'ble Tribunal but in glaring violation of the advice of the Establishment Department issued vide No. SOR.IV(ED)11-1/2023 dated 21.03.2023.

12. That it is very much obvious from the advice of Establishment Department that the objector and others Computer Assistants were to be enlisted having regard to the provisions of Section-8(3) of Khyber Pakhtunkhwa Civil Servants Act-1973 and with Rules-17 of APT-1989. Needless to say that Section 8(3) of the Civil Service Act-1973 provides that Seniority shall be determine as may be prescribed. On the other hand, Rule-17 of APT Rules-1989 prescribed the factors for determination of Seniority.

13. That in Notification bearing No. Estt:I/S.L/Ast/SSS/27168-27210 dated 08.12.2023 where-under the disputed Seniority list has been issued, there is reference of Section-8 of the Civil Servant Act-1973 for eyewash but the procedural provision i.e. Rule-17 of APT Rules-1989 was completely ignored. Therefore, the disputed list has not been issued having regard to the advice of Establishment Department letter No. SOR.IV(ED) 11-1/2023 dated 21.03.2023, which is liable to be corrected in light of

the procedure provided by aforementioned Rule-17 under advice of the Establishment Department issued vide No. SOR.IV(ED)11-1/2023 dated 21.03.2023.

14. That Sub Rule-4 of Rule-17 of APT Rule-1989 is very much clear regarding determination of *inter se* seniority of the Civil Servants of different cadres carrying the same pay scale. Accordingly, the date of regular appointment / promotion of the Civil Servants in the lower post is determinative factor. However, the said factor has not been taken into consideration while issuing the disputed Tentative Joint Seniority List.

15. That Senior Scale Stenographers were previously included in the joint seniority list alongwith Assistants, maintained for promotion quota in the posts of Tehsildar; and in their case, regular initial date of appointment / promotion was considered as determinative factor but the same precedent has not been given effect in case of the objector. Therefore, enlistment of the objector in the disputed seniority list w.e.f. the date of Notification at 01.07.2022 in not correct and does not fulfill the requirements of Rule 17 of APT Rules, 1989.

16. That the objector reasonably believes that he has not been treated in accordance with law in the matter of his enlistment in the disputed seniority list. As far as his enlistment in the disputed list is concerned, the same in view of the foregoing submissions is wrong, erroneous, arbitrary, perverse and liable to be corrected in accordance with law and advice of the Establishment Department.

It is most respectfully requested that on acceptance of this objection petition, the name of objector may be inserted in the final seniority list at appropriate place in light of his undisputed initial appointment i.e. 25-09-2006

(2) A civil servant promoted to a post ¹{ } on regular basis shall be eligible for confirmation after rendering satisfactory service for the period prescribed for confirmation therein.

(3) There shall be no confirmation against any temporary post.

(4) A civil servant who, during the period of his service, was eligible to be confirmed in any service or against any post retires from service before being confirmed shall not, merely by reason of such retirement, be refused confirmation in such service or post or any benefits accruing there-from.

(5) Confirmation of a civil servant in a service or post shall take effect from the date of occurrence of permanent vacancy in that service or post or from the date of continuous officiation, in such service or post, whichever is later.

8. Seniority:- (1) For proper administration of a service, cadre or ²{post}, the appointing authority shall cause a seniority list of the members for the time being of such service, cadre or ³{post} to be prepared, but nothing herein contained shall be construed to confer any vested right to a particular seniority in such service, cadre or ⁴{post} as the case may be.

(2) Subject to the provisions of sub-section (1), the seniority of a civil servant shall be reckoned in relation to other civil servants belonging to the same service or ⁵{cadre} whether serving the same department or office, or not, as may be prescribed.

(3) Seniority on initial appointment to a service, ⁶{cadre} or post shall be determined as may be prescribed.

⁷(4) Seniority in a post, service or cadre to which a civil servant is promoted shall take effect from the date of regular appointment to that post;

Provided that civil servants who are selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter-se-seniority as in the lower post."

⁸(5) The seniority lists prepared under sub section(1), shall be revised and notified in the official Gazette at least once in a calendar year, preferably in the month of January.

9. Promotion:-(1) A civil servant possessing such minimum qualifications as may be prescribed shall be eligible for promotion to a ⁹{higher} post for the time being reserved under the rule for departmental promotion in ¹⁰{ } the service or cadre to which he belongs.

(2) A post referred to in sub-section (1) may either be a selection post or a non selection post to which promotion shall be made as may be prescribed-

(a) in the case of a selection post, on the basis of selection on merit; and

(b) in the case of non-selection post, on the basis of seniority-cum-fitness.

10. Posting and Transfer:- Every civil servant shall be liable to serve anywhere within or outside the province, in any post under the Federal Government, or an

PART-VI

SENIORITY

17. **Seniority :-** (1) the seniority inter se of civil servants ⁴⁷(appointed to a service, cadre or post) shall be determined:-

- (a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission ⁴⁸[or as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; and
- (b) in the case of civil servants appointed otherwise, with reference to the date of their continuous regular appointment in the post, provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter se seniority as in the lower post.

Explanation-I:- If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher post, it would not adversely effect the interest of his seniors in fixation of his seniority in the higher post.

Explanation-II:- If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently, provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incomplete record or for any other reason not attributing to his fault or demerit.

Explanation-III:- A junior person shall be deemed to have superseded a senior person only if both the junior and the senior persons were considered for the higher post and the junior person was appointed in preference to the senior person.

(2) Seniority in various cadres of civil servants appointed by initial recruitment vis-à-vis those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.

⁴⁹(3) In the event of merger/restructuring of the Departments, Attached Departments or Subordinate Offices, the inter se seniority of civil servants affected by the merger/restructuring as aforesaid shall be determined in accordance with the date of their regular appointment to a cadre or post.

⁵⁰(4) The inter-se-seniority of civil servants in a certain cadre to which promotion is made from different lower posts, carrying the same pay scale shall be determined from the date of regular appointment/promotion of the civil servants in the lower post.

Provided that if the date of regular appointment of two or more civil servants in the




