### PRELIMINARY OBJECTIONS.

- 1 That the appellant has got no cause of action locus standi.
- 2 That the instant Service appeal is badly time barred.
- 3 That the appellant has concealed material facts from the Hon'able Tribunal in the instant service appeal.
- 4 That the instant service appeal is against the relevant provisions of law.
- 5 That the appellant has not come to this Hon'able Tribunal with clean hands.
- 6 That the instant appeal is liable to be dismissed for mis-joinder & non-joinder of the necessary parties to the present appeal.
- 7 That the appellant is estopped by his own conduct to file the instant appeal.
- 8 That the instant service appeal is not maintainable in the present form & circumstances of the case.

## FACTS.

- 1 That Para-1 of the fact is pertains to record, the appellant has concealed the important material fact and thus has got appointment order vide this office No3101-06/Apptt Lab Asstt/Deceased quota dated 22.04.2021 (Copy annexed as annexure A).
- 2 That Para-2 of the fact is in correct. The father of the appellant namely Mr. Shoukat Hayat was serving as PST teacher and died while in service in the year 2010. The mother of the appellant (widow of deceased) submitted an application in the year 2011 with the request to appoint her against deceased quota as due and admissible to her (Copy of the application of the widow is annexed as annexure B). Consequently the Executive District Officer Elementary & Secondary Education Kohat vide his office No: 9508-12 dated 16.08.2012 appointed Mst

Farhat Begum W/O Late Shoukat Hayat against the caller (sweeper) post at GGPS Behzadi Chikarkot Kohat against deceased quota (Copy of the appointment order is annexed as annexure C). Further added that the Government segregated the Executive District Offices Elementary & Secondary Education in between Male & Female offices. That after have passed a sufficient time the son of the late Shoukat Hayat lodged an application on judicial stamp paper duly signed by the Notary Public stating that the deceased son/daughter/widow quota has not been availed by his family members/legal heirs (Copy of the stamps paper is annexed as annexure D). there the appellant has concealed the important fact and thus got appointment vide this office No: 3101-06/Apptt Lab Asstt/Deceased quota dated 22.04.2021(Copy already annexed as annexure A) purely on deceased quota basis as stated in the appointment order. Thus the bereaved family got the deceased quota twice by submitting false information to the department. However while serving as a lab assistant at GHSS Surgul Kohat, a complaint received in this office stating that the appellant has concealed the material/important fact and thus has availed the deceased quota twice. Therefore an enquiry officer was authorized to investigate the matter and submit finding/report in the instant case. Having gone through the record the enquiry officer submitted his report and deemed it, appropriate to remove the appellant from service (Copy of enquiry report is annexed as annexure E). Therefore this office issued a show cause Notice to the appellant (Copy of show cause Notice is annexed as annexure F). Resultantly this office was not satisfied from the reply of the appellant and thus removed from service (Copy of removal notification is annexed as annexure G).

- 3 That para-3 of the fact pertains to record.
- 4 That Para-4 of the fact pertains to record.
- 5 That Para No: 5 of the fact are legal.

## GROUNDS.

- A. Incorrect & not admitted, the appellant was treated as per law.
- B. <u>Incorrect & not admitted.</u> The appellant was treated as per law/rules everyone is equal in the eyes of law.
- C. Incorrect & not admitted. Already explain vide Para No: 2 of the fact above.
- **D.** <u>Incorrect & not admitted.</u> Proper show cause notice was issued to the appellant and other codal formalities in the instant case according to the policy/rules are full filled.
- E. <u>Incorrect & not admitted</u>, As proper opportunity was offered to the appellant and all codal formalities in respect of inquiry has been fulfilled, hence denied.

Furthermore it is worth mentioning here that by quoting citation in pleading is bed in eye of law as well as every case has its own crux's and merits.

- F. Incorrect & not admitted. Already explained vide Para No. 2 of the fact above.
- G. Incorrect & not admitted. That the appellant was treated as per law, proper show cause notice was issued to him.





#### PREAMBLE:

Some residents of village Surgul Kohat tabled a complaint application against Mr. Gohar Hayat (Lab: Assistant) GHSS Surgul Kohat regarding double utilization of deceased son quota for appointment. The District Education Officer (Male) Kohat notified me as inquiry officer vide office order No: 5951 dated: 1st Aug 2023 to probe the matter.

#### PROCEEDINGS:-

Mr. Gohar Hayat S/o Shoukat Hayat (Late) Lab: Assistant GHSS Surgul Kohat and Mst: Farhat Begam Widow of Shokat Hayat (Sweeper) GGHS College Abadi Kohat were required to submit their written reply as per questionnaires served to them.

The District Education Officer (Male) Kohat was also approached to facilitate the inquiry officer with the following record.

Minutes and recommendations of the selection committee constituted for appointment of Mr. Ghar Hayat (Lab: Assistant) of GHSS Surgul Kohat on deceased son quota.

1st appointment order of Mr. Gohar Hayat s/o Shoukat Hayat (Late). ii.

1st Appointment order of Mst. Farhat Begam widow of Shukat Hayat (sweeper) iii. GHSS College Abadi Kohat.

#### FINDINGS:-

After go through their written reply, scrutinizing and analyzing the record provided by District Education Officer (male) Kohat, I, the inquiry officer, found that:

Mst. Farhat Begam widow of late Shoukat Hayat was initially appointed as "CALLER" at GGPS Behzadi Chikarkot Kohat Vide Executive District Education Officer Kohat order No: 9508-12 dated: 16/08/2012 on deceased quota after the inservice death of her husband Mr. Shoukat Hayat. Later her Designation/ Nomenclature of the post was changed as, SWEEPER, and she was adjusted at GGMS College Abadi Kohat through "Corrigendum" NO: 10027-31 dated: 01/09/2012.

The committee was tasked to check/ scrutinize the record of the candidates who had applied for appointment against the post of Lab: Assistant on deceased son quota. The committee submitted its report/ recommendation on 15/06/2021.

iii. As per recommendation of the District Selection Committee, the said Mr. Gohar Hayat S/o Shoukat Hayat (Late) was appointed as Lab: Assistant (BPs-07) at GHSS Surgul vide District Education Officer (Male) Office order No:3101-06 dated: 22-06-2021.

iv. The 1<sup>st</sup> appointment order No: 9508-12 dated: 16/08/2012 and the letter written by DEO (F) Kohat to anticorruption clearly indicate that Mst. Farhat Begam (Sweeper) GGHSS College Abadi was appointed against deceased quota on 16/08/2012 by virtue of in-service death of her husband, but submitted a false declaration regarding non utilization of deceased quota by any of her family member including herself in the past. This false declaration paved way for her son's appointment against deceased son quota.

The committee should have asked the following documents from the mother of the applicant i.e. Mst. Farhat Begam (Sweeper) GGHS College Abadi Kohat.

i. Family Registration Certificate (FRC) from NADRA.

ii. Appointment record of each member (reflected in FRC) from District Account Office Kohat.

It is very surprising that one member of District selection Committee was Mst. Bibi Rizwana [DEO (F)] Kohat, and Mst. Farhat Begam was her subordinate, therefore she [DEO (F)] should have asked for the appointment record of Mst. Farhat Begam (Sweeper) GHSS College Abadi but no attention was given towards this very important point. This negligence led to the double utilization of deceased quota by Mr. Gohar Hayat (Lab: Assistant) GHSS Surgul Kohat.

#### CONCLUSION:-

It has been proved that Mr. Gohar Hayat (Lab: Assistant) GHSS Surgul Kohat has doubly utilized the deceased son quota through fraudulent manner. Both Mr. Gohat Hayat S/o Shoukat Hayat (Late) and Mst. Farhat Begam widow of Shoukat Hayat had submitted false Affidavit and declaration and deceived the committee.

According to KP civil Servant Act 1989, Para 10, sub-para4, which states that: [Where a civil servant dies or is rendered incapacitated or invalidated permanently during service or retired on medical board, notwithstanding the procedure provided for sub-rule (2), the appointing authority may appoint one of the children of such civil servant or if the child has not attained the age prescribe for appointment in government service, the window or wife as the case may be, of such civil servant, to a post in any of the basic pay scale 03 to 11 in provincial cadge post and basic pay scale 03-to 12 in District cadre post]

#### RECOMMENDATION:-

The appointment of Mr. Gohar Hayat (Lab: Assistant) GHSS Surgul Kohat is severe violation of 1989 Civil Servant appointment, Promotion & Transfer rule.

Therefore, it is recommended that:

1. The appointment of Mr. Gohar Hayat should be declared null and void ab-initio and his

salary should immediately be stopped.

2. Mst. Farhat Begam (Sweeper) GGHS College Abadi Kohat has committed fraud by submitting false declaration that none of her family member (Son/Daughter/She herself) has never availed deceased son quota for all sorts of employment in Elementary & Secondary Education Department in past. Her false deceleration has caused a financial loss/damage to the national exchequer; therefore District Education Officer (Female) Kohat should take appropriate action against her.

To avoid unnecessary litigation the following documents should always be asked from

the candidates who apply for appointment against deceased son quota.

i. Family Registration Certificate (FRC) from NADRA.

Appointment record of each family member (reflected in FRC) from District ii. Account Office Kohat.

1st appointment letter, if appointed, in Education Department. iii.

Affidavit regarding non utilization of deceased son quota by any member of iv. his/her family (Brother/Sister/Mother).

WHEREAS, a complaint received from public regarding concealment of facts to the effect that the deceased son quota has already availed by his mother (widow) and was appointed vide No.9508-12 Dated 16-08-2012 against Caller post at GGPS Behzadi Chikar Kot, Kohat WHEREAS, in the light of complaint an inquiry was constituted to probe into the matter and

dig out the facts for onward proceeding into the matter vide this office No.5951 Dated 01-08-2023.

WHEREAS, report of inquiry officer vide No.655/Inquiry file Dated:18-09-2023 received to this office with the recommendation that the appointment of Mr. Gohar Hayat, Lab Assistant at GHSS Surgul, Kohat was severe violation of 1989 civil servant APT rules and his appointment should be declared null and void ab-initio and his salary should be immediately stopped.

WHEREAS, in the light of inquiry report a show cause notice in dispense of formal inquiry vide this office No.6933, Dated:18-09-2023 issued and addressed to the Principal GHSS Surgul Kohat with the directions to deliver Mr. Gohar Hayat Lab Assistant and a certificate / receipt as a token be submitted that show cause notice has been delivered.

WHEREAS, a certificate / receipt as a token received from the Principal GHSS Surgul, Kohat vide No.1886-87 Dated: 19-09-2023.

WHEREAS, he (Mr. Gohar Hayat Lab Assistant GHSS Surgul, Kohat) was intimated in show cause notice whether you desire to be heard in person if no reply is received to this effect within seven days ex-parte action shall be taken against him.

WHEREAS, he (Mr. Gohar Hayat Lab Assistant GHSS Surgul, Kohat) submitted his reply to show cause notice on 26-09-2023 and failed to come for personal hearing.

WHEREAS, 2nd notice for personal hearing issued vide this office letter No.7707, Dated:12/10/2023 and he appeared before the undersigned for personal hearing on 20/10/2023. Mr.Gohar Hayat Lab Assistant (BPS-7) GHSS Surgul Kohat failed to defend himself.

WHEREAS, the charges and evidence of misconduct and concealment of facts have been proved through proceeding under Khyber Pakhtunkhwa Government servants (Efficiency and Discipline) rules 2011.

NOW THEREFORE, in the light of inquiry report, evidences and unsatisfactory reply of show cause notice the competent authority is satisfied enough to impose major penalty of removal from service under Khyber Pakhtunkhwa (E & D) Rules 2011 under Section 4(b) iii upon Mr.) Gohar Hayat Lab Assistant GHSS Surgul, Kohat with immediate effect.
