Respectfully Sheweth:

#### PRELIMINARY OBJECTIONS:

1. That the appellant has got no cause of action as well as locus standi to file the instant appeal.
2. That the instant appeal is badly time barred.
3. That the appellant has not come to this Honorable Tribunal with clean hands, hence the appeal is liable to be dismissed.
4. That the appellant has concealed the material facts from this Honorable Tribunal, hence the appeal is liable to be dismissed.
5. That the appellant has appointed vide order No 6702/G dated 26/06/2019 by the respondent department.

(Copy of appointment Order is as Annexure -A)

6. That the appellant has taken over charge in the Education Department as PST on 27/06/2019, and she has placed at serial No 1143 in the Seniority List. The Seniority has been reckoned from the date of joining of the Post.

(Copy of Relevant Seniority List is as Annexure -B)

#### FACTS:

1. Para No 1 related her applied for the post, hence needs no comments.
2. Para No 2 is Incorrect & not admitted. As the appellant was not malafidely left out from the appointment order and the respondent No 3 has accommodated against one seat of PST at Union Council Narai for the

appellant. The respondent has been issued appointment order of the appellant since 20019, hence denied.

3. Para No 3 is Correct, hence needs no comments.
4. Para No 4 is related to her joining of the post, hence needs no comments.
5. Para No 5 is Incorrect & not admitted. As the appellant has taken over charge in the Education Department as PST on 27/06/2019, and she has placed at serial No 1143 in the Seniority List. The Seniority has been reckoned from the date of joining of the Post, hence denied.

6. Para No 6 is Incorrect & not admitted. As the candidates have been appointed in the year 2017 by the respondent department, and the respondent department has been issued the appointment order of the appellant in the year 2019. The name of the appellant is not missing because her name is placed at Serial No 1143 in the Seniority List, hence denied.
7. Para No 7 is Incorrect & not admitted. As the appellant has taken over charge in the Education Department as PST on 27/06/2019, and the name of the appellant is not missing because her name is placed at Serial No 1143 in the Seniority List. The Seniority has been reckoned from the date of joining of the Post, hence denied.
8. Para No 8 is Incorrect & not admitted. As the act is legal, justified and according to the principles of natural justices, hence denied.

#### **GROUND:**



- A. Para A is Incorrect & not admitted. As the candidates have been appointed in the year 2017 by the respondent department, and the respondent department has been issued the appointment order of the appellant in the year 2019. The name of the appellant is not missing because her name is placed at Serial No 1143 in the Seniority List, hence denied.
- B. Para B is Incorrect & not admitted. As the respondent department has been issued the appointment order of the appellant in the year 2019 on the basis of the decision of the Peshawar High Court Peshawar while the other candidates has already been appointed before the appellant, hence denied.
- C. Para C related her Court case and the respondent department compliance the judgment of the WP- No 4229/P 2017 and issued appointment order of the appellant, hence denied.
- D. Para D is related her appointment order, hence needs no comments.
- E. Para E is Incorrect & not admitted. As the appellant is not condemned unheard by the respondent department and the respondent department has

been issued appointment order of the appellant and she has also placed in the correct seniority No 1143 in the seniority List, hence denied.

- F. Para F is Incorrect & not admitted. As the seniority of the appellant has considered from the date of her appointment order and joining of the PST pos. The respondent department can not consider the seniority of the appellant from the date of the other applicants, because their appointment order has issued before the appellant, hence denied.
- G. That the respondents seek permission to raise additional grounds at the time of arguments.





In the light of judgement of Honorable High Court Peshawar in writ petition No.4229/P 2017, Appointment of the following candidate is hereby ordered against the post of Primary School Teacher on school & U/c based in BPS-12 (Rs.13320-960-42120) fixed plus usual allowances as admissible under the rules on adhoc/contract basis for a period of one year under the existing policy of the Provincial Government in teaching cadre, under the terms and conditions given below with effect from their taking over charge in the best interest of public service.

**CONDITIONS**

1. No TA/DA is allowed.
2. Charge report should be submitted to all concerned in duplicate.
3. Appointment is purely on temporary and contract bases initially for one year Wef date of taking over charge.
4. She should not be handed over charge if she exceeds 35 years or below 20 years except those whom have been granted relaxation in upper age limit by the being competent authority.
5. Appointment is subject to the condition that the certificate/documents must be verified from the concerned boards/universities/authorities.
6. If any valid appeal received regarding the appointment against any post, after proper inquiry the appointment order of candidate will be withdrawn.
7. Their services are liable to termination on one month's notice from either side. In case of leaving the department without prior notice their one-month pay/allowances shall be forfeited to the Government.
8. Health and Age Certificate should be produced from the Medical Superintendent concerned before taking over charge.
9. They will be governed by such rules and regulations as may be issued from time to time by the Government.
10. Their services shall be terminated at any time; in case their performance is found unsatisfactory during contract period. In case of misconduct, they shall be proceeded under the rules framed from time to time.
11. Their appointment is made on adhoc and School based, they will have to serve at the place of posting, and their services are not transferable to any other station.
12. Before handing over charge, once again their document may be checked by the Headmaster/Principal concerned and if they have not the required relevant qualifications as per rules, they may not be handed over charge of the post, and the case may be reported to the District Education Office (Female) Mardan for withdrawal of order.
13. Before handing over charge once again their documents will be checked by the concerned SDEO(F)/ASDEOs. If they have not the required relevant qualifications, they will not be handed over charge.
14. They should join their post within 15 days of the issuance of this notification. In case of failure to join the post within 15 days, their appointment will stand expired automatically.
15. In case any candidate refused her appointment/recruitment after issuing appointment order, opportunity will be given the next eligible candidate on merit of that union council.

1. No TA/BDA etc is allowed.
2. Charge report should be submitted to all concerned in duplicate.
3. Appointment is purely on temporary and ad-hoc basis initially for one year w.e.f. the date of their taking over charge.
4. They should not be handed over charge if they exceed 35 years or below 20 years except those who have been granted relaxation in upper age limit by the being competent authority.
5. Appointment is subject to the condition that the degrees/certificates/documents must be verified from the concerned Board.
6. If any valid appeal received regarding the appointment against one p.s. after proper hearing the appointment order of that candidate will be withdrawn.
7. Their services are liable to termination on one months prior notice from either side. In case of revocation without notice their one month's pay allowances shall be adjusted as of last month.
8. They should join their post within 15 days. In case of failure their appointment will be expired automatically and no subsequent appointment shall be entertained.
9. Health and Age Certificate should be produced from the Medical Superintendent concerned before taking over charge.
10. They will be governed by such rules and regulations as may be issued from time to time by the Govt.
11. Their services shall be terminated at any time, in case their performance is found unsatisfactory during their tenure period. In case of misconduct, they shall be proceeded under the rules framed from time to time.
12. Their appointment is made on school based, they will have to work at the place of posting and their services are not transferable to any other station.
13. Before handing over charge once again their documents will be checked by the concerned SEDO & LSEDO if after seeing no the required relevant qualifications they will not be handed over charge.
14. In case any candidate who submit appeal later on after the issuing of appointment order for her appointment being on merit her appeal will be honoured after observing the proper procedure and the lowest scored candidate of that U.C. will be appointed.
15. In case any candidate refused her appointment/Recruitment after issuing appointment order, opportunity will be given to the next eligible candidate on merit of that Union Council.
