**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED INACTION OF THE RESPONDENTS BY NOT ADJUSTING THE APPELLANT AGAINST HIS POST OF DRAWING MASTER AND AGAINST THE INACTION BY NOT DECIDING THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD ON NINETY DAYS.**

**PRAYER:**

That on acceptance of this appeal the respondent may please be directed to adjust/ post the appellant as Drawing Master in GHS Chail District Swat. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

**R/SHEWETH:**

**ON FACTS:**

- 1- That appellant is initially appointed as Drawing Master in the respondent department vide order dated 01.04.1987. Copy of the appointment order is attached as annexure .....A.
- 2- That in pursuance to the order ibid the appellant started performing his duties and his service book was also prepared by the concerned officer. Copy of the service book is attached as annexure .....B.
- 3- That since his appointment the appellant had performed his duty with zeal and zest and up to the entire satisfaction of his superior.

- 5- That it is pertinent to mention here on the expiry of the leave period the appellant did not join the duty due to enmity and frequent threats from the Taliban groups in the locality and in the year 2017 the appellant submitted his arrival report and an application for the grant of EOL and his adjustment. Copies of the arrival report and application are attached as annexure .....E.
- 6- That since the application mentioned above no order of adjustment was made by the competent authority, however the appellant was assured that his matter would be resolved soon but nothing has been done by the competent authority, hence feeling aggrieved from the inaction of the competent authority the appellant preferred departmental appeal before the appellate authority. Copy of the departmental appeal is attached as annexure .....F.
- 7- That vide letter dated 15.09.2023 comments were asked from the respondent No. 2 but till date no order has been made. Copy of the letter dated 15.09.2023 is attached as annexure .....G.
- 8- That appellant having no other remedy but to file the instant appeal on the following grounds inter alia.

#### **GROUND:**

- A- That the impugned inaction of the respondents by not adjusting/ posting the appellant is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B- That the appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondent department acted in arbitrary and mala fide manner while not posting/ adjusting the appellant against any post of DM.
- D- That the impugned inaction of the respondents by not adjusting/ posting is affecting the right of pay of the appellant as he will withdraw pay against a post but respondents are reluctant to adjust/ post the appellant and such act of the respondent are in violation of Section 17 of the K.P Civil






