- This petition has been filed on 14.10.2022 for implementation 2. passed in Service Appeal judgment dated 14.09.2021 of No.983/2004. On its first day of hearing, request for adjournment was made by the representative and after that, series of adjournments were made on the requests of this judgment debtors. On 23.01.2024, last chance was given, which was further extended in the shape of warning for coercive steps. Again last opportunity was granted on 08.05.2023 and on 09.06.2023, respondents were warned that in case of non-submission of implementation report, no lenient view would be taken but the respondents got the matter adjourned for 18.07.2023. On 18.07.2023, representative of the respondents stated that the department had submitted summary for approval to the Chief Minister, which was lying on his table, but on the next two dates, they made requests for adjournment, which resulted into attachment of salaries of respondents No.3 & 4. However, the matter was adjourned on different dates but respondents No.3 & 4 did not bother comply with the Court order or to submit any progress report. In the meanwhile, the respondents filed 12(2) against the judgment in question, which was dismissed and a cost of Rs.20,000/- was imposed upon one Shagufta Naveed, the then Secretary to Government of Khyber Pakhtunkhwa for rendering opinion compelling the Government to enter into frivolous multifarious litigations and direction was issued for her

SC \_\_\_\_D K\_\_\_I Peshawari personal appearance. On 03.06.2024, Miss. Shagufta Naveed had appeared in person and requested for adjournment and on the subsequent date too, adjournment was made. Today, the situation is, as it was. This shows their casual and lathergic attitude towards the compliance of the order of this Tribunal. Therefore, the Tribunal is constrained to impose cost of Rs.50,000/- upon each of the respondent. Ms. Shagufta Naveed is also not in attendance, who had to pay the amount of costs, nor anyone else is present on her behalf, therefore, her salary is also attached. She and all the reepsondents shall appear in person on 31.07.2024 along with implementation report. P.P given to the petitioner's counsel.
