Learned counsel for the petitioner (Mst. Qurat Ul Ain) present and submitted an application for setting aside ex-parte proceedings alongwith application for suspension of source form issued by respondent No.2. This Tribunal vide order dated 03.05.2024 suspended the operation of impugned order dated 28.02.2024 vide which the transfer order dated 30.05.2023 of the appellant (Nida Afreen) was withdrawn. He produced a copy of order dated 14.04.2023 vide which private respondent No. 3 was posted to GHSS Hassa D.I.Khan but despite posting of respondent No.3, respondent department issued another order dated 30.05.2023 vide which appellant was posted showing post of SST-IT as vacant.

When appellant filed appeal her grievance was redressed as a result of which order dated 30.05.2023 of the appellant was withdrawn by the competent authority vide order dated 28.05.2024. He further argued that present private respondent No.3 assumed the charge of the post of SST-IT on 07.03.2024 and is performing her duty regularly till date. Order was suspended by this Tribunal subject to the condition if same is not already acted upon. As impugned order dated 28.02.2024 has already acted upon, therefore, he requested that there is no need to implement the same by the respondent No.2 who issued letter dated 28.05.2024 in consequence of which concerned Head Mistress issued source form for activation of the pay of appellant Mst. Nida Afreen which in other words means stoppage of salary of private respondent No.3 because only one post of SST-IT is available in GHSS Hassa D.I.Khan under DDO Code 6115. He further argued that respondents

in the garb of order of this Tribunal dated 03.05.2024 are going to stop the salary of the private respondent No.3 which is not in accordance with order of this Tribunal dated 03.05.2024, therefore, he requested for suspension of operation of order dated 25.07.2024 and source form issued on the basis of it by the Head Mistress on concerned school 29.07.2024 for activation of pay of appellant (Mst. Nida Afreen). Notice of these applications be issued to the parties. In the circumstances operation of order dated 25.07.2024 and all the proceedings initiated on the basis of said letter is hereby suspended till date fixed i.e 09.08.2024. To come up alongwith main appeal on 09.08.2024 before S.B.
