

#### **Background History**

The complainant, Miss Noreena Headmistress GGHS Abdullah Jan Bara Khyber, has registered various complaints of harassment against the defendant Mr. Muhammad Ayub PSHT GPS Noor Haidar Bara, District Khyber. The list of complaints registered by the complainant against the defendant is given below;

- The complainant lodged the complaint against the defendant at Hayatabad Police Station on 7th October 2020.(Annex B)
- 2. The complainant also registered a complaint against the same defendant at the office of District Education Officer Khyber on 9th October 2020. (Annex C)
- 3. Again, she approached and registered a complaint at the office of District Police Officer on 13th October 2021 (Annex D)
- 4. During the ongoing series of complaints, she also registered an FIR against the defendant at Bara Police Station on 4th October 2021. (Annex E)
- 5. The complainant has registered two complaints against the defendant. The first one has been dispatched to DEO Male Khyber through DEO Female Khyber (Annex F) whereas she dispatched the second complaint directly to the office of DEO Female (Annex G).

#### Procedure Adopted

The concerned committee visited GGHS Abdullah Jan Bara Khyber and GFS Noor Haidar Bara on 3rd June 2023. During the visit, both the officials (complainant and defendant) were served with the respective questionnaires in their concerned institutions. Meanwhile, the complainant responded the questionnaire accordingly on the spot, while the defendant is reluctant to respond the official questionnaire till date. (Annex H)

## **SHOW CAUSE NOTICE**

I, Muhammad Uzair Ali, the District Education Officer (M) Elementary & Secondary Education Khyber, Khyber Pakhtunkhwa as Competent Authority under the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 do hereby serve you Mr. Muhammad Ayub PSHT GPS Noor Haider Bara District Khyberas follows:

- 1. That you have been reported by DEO (Female) District Khyber vide letter No.4302 dated 19/05/2023 for harassment of Miss Noorina Syed, Headmistress GGHS Abdullah Jan Bara, on her complaint dated 02.05.2023, which is a gross misconduct as well as a criminal act against a serving government official.
- That accordingly an inquiry committee, comprising of Mr. Rifaqat Ali Shah Principal GHS Alam Gudar Bara and Mr. Abdul Nawaz SDEO Jamrud, was constituted vide No.4845-52 dated 23/05/2023 to probe into this harassment case and submit comprehensive report.
- 3. That the inquiry committee submitted its report vide No.1053 dated 05/07/2023 which proved the case against you.
- 4. That you were previously also proceeded for the similar harassment of the similar official but you still did not mend your conduct and continued harassing the mentioned Headmistress after you somehow got away with the proceedings.
- 5. That after going through the inquiry report and other material on record, I am satisfied that you have committed acts/omission mentioned in Rule 3 (b) of the aforementioned Rules.
- 6. That in exercise of powers conferred under the Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011, I as the Competent Authority have tentatively decided to impose upon you any of the major penalties mentioned in Rule-4 (b) of the ibid rules.

7. You are, therefore, required to show cause as to why the aforementioned penalty should not be imposed upon you and also intimate whether you desire to be heard in person.

8. If no written reply to this show cause is received within 15 days of its receipt it shall be presumed that you have no defense to put in and, in that case, an Ex-Parte decision shall be taken against you.

Respected Sir,

I am Ms. Noorina Syed, CNIC: 21302-1012110-4 currently posted as Head Mistress, at Government Girls High School (GGHS) Abdullah Jan, District Khyber. From the last three years, Muhammad Ayub, posted as Primary Secondary Teacher, at Government Primary School (GPS), Soorkas No. I has been continuously stalking, harassing, and threating me. Not only, he is deterring me from discharging my official duty properly- as he has many times followed my vehicle on route to my school- but has also been criminally inducing me for marriage and has been reaching my siblings through his acquaintances for the same. In this process, he has been defaming me in front of his friends, and colleagues.

I had hired his services as a driver on the recommendation of my niece's husband when I was posted as Assistant Education Office (Female), Bara, Khyber Agency and then as Headmistress, Government Girls High School, Pirwelkhel, Dara Adam Khel- at that time he was suspended from service of which I did not the reason of. After I changed my driver, he started contacting me on my number, started threatening me, started stalking me and followed me on my route to school many times for which I blocked his number, but he continued harassing me from other numbers and due to this reason, I changed my number. During this time, I was transferred to Government Girls High School (GGHS), Abdullah Jan, District Khyber, which is my current posting. Since then, he has been continuously stalking me, following me on my route to school, and has been found near my residence at Hayatabad multiple times.

Initially his elders were informed about his advancements, and in response they assured us that he will not create any disturbance and will not show up near my residence. However, after some time he continued following me and once followed me to my home and give a verbal threat. I then launched a complaint with Tatara Police Station, dated October 8, 2020 on which the police responded that it was not their jurisdiction but that of Khyber police. After that my nephew launched a complain on Pakistan Citizen Portal, Complaint Number KP141020-87460478 on which the police responded that he was not found at his Hayatabad residence, and his neighbors said that his family had shifted to District Khyber. The case was forwarded to DPO Khyber, where he was summoned under the supervision of DSP Nawaz. He affirmed that neither he will stalk me, nor harass me in future, but despite that he continued with his actions. Thereafter, I filed a complaint dated September 20, 2021, at Tatara Police Station, Phase 4, and at Police Station Bara, Khyber dated October 4, 2021, who forwarded us to Takya Police Chowk, where SI Sher Haider was given the report, however, he was completely biased in his conduct, and was not cooperative at all. After three days, he was found once again at street end and his vehicle, numbered: M9343,

upon seeing my nephews he ran away, showing them inappropriate gestures, immediately police were informed, he was chased and his vehicle was found at front of his relatives' house, but his cousins told the police that he wasn't in the premises of the house. Thereafter, the police confiscated his vehicle, which is parked at Tatara Police Station Phase 7.

Because of his actions, he has made it very difficult for me to carry official duties – I have applied for two-months leave for the same reason- and lead a normal life, and has given me severe mental torture, defamed me in front of my colleagues, and harmed my professional dignity. I urge you to file an FIR against Muhammad Ayub under sections of stalking, harassment, defamation, criminally inducing for marriage, creating hindrance in the discharge of my official duty, and giving life threats because.

I am writing to bring a serious and ongoing issue to your attention. As the Headmistress of GGHS Abdullah Jan school, I have been experiencing harassment and threats from Muhammad Ayub, a primary school teacher at GPS Noor Haider, tehsil Bara in District Khyber. I fear for my safety and wellbeing due to his continuous stalking, harassment, and false rumors he is spreading about me. I am submitting this complaint in hopes that appropriate action can be taken to protect me from further harm.

I have previously filed complaints against him in the education office as well as in the police station. In October 2020, I filed a complaint on Pakistan Citizen Portal, on which office of the District Police Officer Khyber summoned him. He affirmed that neither he will stalk nor harass the undersigned in the future, but after a year, he resumed his behavior, leading me to file another complaint in September 2021 at Bara Police station and Tatara Police Station in Hayatabad.

Despite my best efforts to avoid him and his actions, his behavior has caused me significant stress and anxiety, making it challenging for me to perform my job effectively.

I request that you take appropriate action to ensure my safety and prevent any further incidents from occurring. I have attached all previous records with this application. In addition, I have attache i pictures of him, chasing my school vehicle while coming from the school.

#### Brief of the Case

One Miss.
