**Respectfully Shewith**

**Preliminary Objections**

1. That the Appellant is not an aggrieved person within the meaning of section 4 of the Service Tribunal Act, 1974.
2. That the Appellant has no cause of action / locus standi.
3. That the Appellant has not come to this Honorable Tribunal with clean hands.
4. That the Appellant has filed this instant Service Appeal just to pressurize the respondents.
5. The present Service Appeal is liable to be dismissed for non-joinder/mis joinder of necessary parties.
6. That the instant Service Appeal is against the prevailing law and rules.
7. That the Appellant has filed this instant Service Appeal on malafide motives.
8. That the instant Appeal of the Appellant is **badly time barred**.
9. That the instant Service Appeal is not maintainable in the present form, and above in the present circumstances of the issue.
10. That the departmental appeals annexed with instant Service Appeal has not been found in official record as it is without any diary number and date.
11. That the Appellant has estopped by his own conduct by not resuming his duty after expiry of his sanctioned medical leave w.e.f 05.12.2022.
12. That the Appellant has concealed the material facts from this Honorable Tribunal.

**FACTS**

- i. Pertains to record, hence, no comments.
- ii. Pertains to record, hence, no comments.
- iii. That this para is irrelevant to the respondent, hence no comments.
- iv. Correct. However, it is worth to mention here that the Appellant did not resume his duty after the expiry of his sanctioned medical leave w.e.f 05.12.2022
- v. That this Para is incorrect and not admitted. On expiry of medical leave the Appellant should have resumed his duty but the Appellant admittedly did not resume his duty and remained absent for a long time. Furthermore, the Appellant submitted application direct to the Secretary Elementary and Secondary Education Department for his transfer instead of joining his duty to GHS Shin on the post of Naib Qasid but his application was not

entertained as the respondent cannot change his post from Chowkidar to Naib Qasid as per rules. (**Application of Appellant & letter of DEO annexed as annexure A & B**)

- vi. That this para is quite astonishing, the Appellant being a civil servant should have abide by the rules. The Appellant should have joined his duty after the expiry of leave.
- vii. That this Para is misconceived one. The Appellant remained absent for a long time and did not even report to his duty station or leave sanctioning authority and is trying to get sympathy of this Tribunal. It is quite astonishing that how can a civil servant wait for his transfer and remains absent from his original duty station. Furthermore, the Sub Divisional Education Officer male Bahrain Swat/DDO reported the Appellant absent from duty w.e.f 05.12.2022 dated 21.02.2023. (**Report of SDEO Bahrain annexed as annexure C**)
- viii. Incorrect and denied. The annexed departmental appeal of the Appellant has not been found in official record as it is without any diary number and date.
- ix. Incorrect and denied. The Appellant wants to get benefit of the order dated 07.011.2023 of this Honorable Tribunal to safeguard his instant Service Appeal from the issue of limitation I,e time barred. In fact, the Appellant was removed from service vide order dated 03.05.2023 after fulfilling all codal formalities. As far as the unawareness of the Appellant about his removal order, the Appellant's statement is absolutely incorrect and false. He has properly been informed by the concerned SDEO through Primary School Head Teacher. According to the written statement of the head teacher, the Appellant was informed through WhatsApp as well as he also received his luggage and utensils from the school. It clearly means that the Appellant was well aware of his removal order. Now, the instant Service Appeal of the Appellant is **badly time barred** and is liable to be dismissed on this score alone. It is further clarified that the Appellant had filed Service Appeal No 1493/2023 on 19.07.2023 whereas he was already removed from service on 03.05.2023. It means that the Appellant has even filed his previous Service Appeal No 1493/2023 for release of salary after about two and a half months later than his removal order. The Appellant has even concealed this very important aspect of the case from this Honorable Tribunal while submitting his earlier Service Appeal duly on sworn affidavit. Therefore, he should be punished by this Honorable Tribunal for incorrect and false statement. (**Head teacher and SDEO statement & Form of order sheet annexed as annexure D1 & D**)
- x. Incorrect and denied. Call notice under the rules was issued to the Appellant on his home address dated 01.03.2023 through registered post vide RGL 105856990 dated 02.03.2023 to attend the office of the respondent within 07 days but he neither bother to attend the office nor did he resumed his duty. On the basis of the call notice, the SDEO concerned again reported the Appellant absent from duty dated 25.03.2023. As required under E&D Rules 2011 a notice mandatory under article 9 was also published in two leading newspapers "**The Daily Ajj and The Daily Azadi**" dated

14.04.2023 to resume his duty within 15 days but the Appellant failed to do so. Therefore, being competent authority under the E&D Rule 2011, the respondent impose upon the Appellant the major penalty of "removal from service" dated 03.05.2023. (Call Notice, Registry receipt, SDEO's Report & Publications annexed as annexure E, F, G & H)

- xi. Incorrect and denied. The annexed departmental appeal of the Appellant has not been found in official record as it is without any diary number and date.
- xii. The instant Service Appeal of the Appellant is bereft of any merit, hence, liable to be dismissed inter-alia following grounds.

**GROUND**

- a. Incorrect and not admitted. The Appellant has been issued Call Notice under the rules and finally notice was also published in two leading newspapers "The Daily Ajj and The Daily Azadi" dated 14-04-2023. ~~competent authority can disposed with equi~~
- b. Detail reply has given in above paras.
- c. Incorrect and denied. That the respondent has acted under the rule, law and policy.
- d. Incorrect and denied. That the respondent has acted under the rule, law and policy. No discrimination whatsoever has been made to the Appellant.
- e. That the Appellant has estopped by his own conduct by not resuming his duty after expiry of his sanctioned medical leave w.e.f 05.12.2022.
- f. That this Para is the repetition of above paras, hence, no comments.

It is therefore very humbly prayed that the instant Service Appeal of the Appellant may be dismissed with cost in favor of the respondents.
