RESPECTFULLY SHEWETH:

PRELIMINARY OBJECTIONS:

- 1. That the Appellant has already filed a Service Appeal No. 15/2024 on some cause of action, which is pending before this Hon'ble Tribunal (Annex-A).
- 2. That the instant Service Appeal is not maintainable in the eyes of law
- 3. That the Appellant has got no Cause of Action.
- 4. That the Appellant has concealed material facts from this Honourable Tribunal.
- 5. That the Appellant has challenged the promotion order dated 21.11.2023, with no realistic/cogent grounds.
- 6. That the Appellant is estopped by his own conduct to bring the present Appeal before this honourable Tribunal.
- 7. That the appeal is barred by law and limitation.

REPLY ON FACTS:

- Pertains to record. However it is clarified that Appellant qualified Secondary School Certificate examination in year 2022.
- Incorrect hence denied. Name of Appellant was inadvertently reflected at Serial No. 02 2. of tentative Seniority list (not final Seniority list) of class-IV, which was circulated to all the district formations of province, for objections/corrections, if any. After circulation of the tentative seniority list, some objections were received to the Directorate of Prosecution from field formations, against the position awarded to Appellant, on the ground that Appellant acquired the minimum qualification of Secondary School Certificate later than them i.e. in the year 2022. It is pertinent to mention here that as per Service Rules of Directorate of Prosecution, as amended in the year 2018 (Annex-B), a common seniority list of Naib Qasid, Chowkidar etc. is maintained with reference to the date of acquiring Secondary School Certificate. A Departmental Committee was constituted to discuss the objections/representations on tentative seniority list of Class-IV (Naib Qasid), which held that objections of officials against the Appellant are genuine and hence they were placed at their due positions in Final Seniority list as per rules. (Minutes of the Departmental Committee is Annex-C). The Appellant was correctly placed at serial No.86.
- Incorrect hence denied. The Departmental Promotion Committee made its recommendation and promoted the respondents No.05 to 33 purely on merit on the basis of Service rules of Directorate of Prosecution amended in the year 2018 (Annex-D).
- 4. Pertains to record. As replied above.
- 5. As replied vide para 02 of para-wise reply.

- That the respondent No. 3 issued another list of seniority on 09.0812023 where the appellant has been placed at serial No. 86 of the list (Copy of the list is attached as annexure "C")
 - That appellant filed departmental appeal against the above mentioned seniority list before the learned respondent No. 2 who vide order dated 17.10.2023 filed the same without providing any opportunity of learing, nor the same order has been communicated to appellant but precured the same today i.e. 16.11.2023, (Copy of appeal & order are attached as annexure. "D" & appeal & order are attached as annexure.
 - That appellant is at serial No. 2 of the seniority list but has been placed at wrong place and now the department making process of promotion and appellant being on the verge of retirement will be badly effect from the whole process, hence having no other remedy approach this Hon'ble court on following amongst other.

SUPERINTENDENT OF THE STATE OF

- That the act of the respondents is the violation of Article
 25 of the Constitution of Islamic Republic of Pakistan,
 1973 wherein it is directed that all persons should be
 treated equally in accordance with law.
- B. That the act of the respondents violated the Article 4 of the Constitution of Islamic Republic of Pakistan, 1073, and all persons exercising the authority must do only is accordance with law.
- C. That the petitioner has the requisite qualification and most senior as per the seniority list of class IV prepared by the respondents department, therefore, eligible for promotion as Junior Clerk from Naio Qasid, thus now changing the seniority is based on malafide.
- D. That as it is very much clear that officials appointed in first batch will be rank senior to the official(s) appointed in the subsequent batch, irrespective of the date of acquisition of SSC, which was the clear cut directions of the additional Registrar (admin) Peshawar High Court but still Appellant has be placed at wrong place in seniority list.
- E. That respondents have not adopted proper procedure by subsequently changing the seniority list.
- F. That changing of seniority list once corrected is totally illegal & without adopting codal formalities.

That this Hon'ble Tribunal has got ample jurisdiction to entertain and disposed off the instant Service appeal according to the facts and circumstances of the case in hand.

H. That any other ground or reasons if not mentioned at the time of hearing will be argued with the permission of this Hon'ble Tribunal.

It is therefore, most humbly prayed that on acceptance of instant service appeal, the respondents may graciously be directed to promote the petitioner to the post of Junior Clerk (BPS-11) by making correction in the seniority list (as corrected seniority list issued on 17.02.2023) and the action of respondent by issuing wrong seniority list on 09.08.2023 be declare Illegal, void and without authority, as well as order dated 17.10.2023 be declare as illegal, void and without authority, hence liable to be set aside and the appellant being senior most is liable to be promoted.

Any other relief, if not specifically prayed, may also graciously be granted, if appears just, necessary and appropriate.
