JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENTS NO. 01 and 02

PRELIMINARY OBJECTIONS

- i. That the appeal is not maintainable.
- ii. That the appellant has no cause of action and locus standi.
- iii. That the appeal is liable to be rejected on ground of mis-joinder and non-joinder of necessary parties
- iv. That the appeal is barred by law and limitation.

FACTS

- 1. Mr. Muhammad Zaka Khan was appointed as Sub Engineer in C&W Department and subsequently promoted to BS-17 on 01.04.2022.
- 2. As explain in para-1 above.
- 3. As explain in para-1 above.
- 4. Incorrect. In this regard, it is submitted that Mr. Muhammad Zaka Khan (BS-17), while working as SDO O/O XEN Building Division Abbottabad transferred and posted as SDO O/O XEN C&W Division Kohistan Lower on 17.11.2023 on administrative grounds, as his tenure at the referred post is more than 02 1/2 Years. However, the appellant filed writ petition in Peshawar High Court (Abbottabad Bench) to set aside his transfer order dated 17.11.2023 (Annex-I). The court has disposed of his writ petition petition converted "so this verdict appeal/representation and sent to respondent No.2 to decide the same within 30 days from receipt of this order" (Annex-II). On the direction of Peshawar High Court Abbottabad Bench, the

Appeal/Representation of the appellant processed and forwarded to Chief Secretary Khyber Pakhtunkhwa to decide the said appeal. The Chief Secretary Khyber Pakhtunkhwa has returned the case with the directions that as per rules of business the Posting/Transfer of the appellant is within the competency of the Administrative Secretary who may dispose this case on merit. Accordingly, the case was re-examined and the appellant (Muhammad Zaka Khan) SDO O/O XEN C&W Division Kohistan Lower has been transferred and re-posted as SDO O/O XEN Building Division Abbottabad on 08.03.2024 (Annex-III).

- 6. As explained in Para-4 above.
- 7. As explained above.

GROUNDS

- a. Incorrect and misconceiving, as the appellant has been treated as per law/rules and regulations laid down by the Government.
- b. As explained in Para-4 of the Facts.
- c. Incorrect, although, the appellant has no inherited right for his posting against the post of SDO (BS-17) O/O XEN Building Division Abbottabad as he has served in the said Sub Division w.e.f 28.04.2021 to 17.11.2023 as SDO (In his own pay & scale).
- d. Incorrect. As per section 10 of the Khyber Pakhtunkhwa Civil Servant Act, 1973, "Every civil servant shall be liable to serve anywhere within or outside the province, in any post under the Federal Government, or any Provincial Government". Furthermore, Section-4 of the ibid Act is also provides that "Every Civil Servant shall hold office during the pleasure of the Governor".
- e. Pertains to record needs no comments.
- f. Incorrect, as explained in para-4 of the Facts.
- g. Incorrect, as per Rules of Business as well as APT Rules, Secretary of the Department is vested with lawful authority to transfer staff in the Department. The appellant was transferred under the referred authority from Abbottabad to Kohistan Lower on 17.11.2023. However, the appellant has been again posted as SDO O/O XEN Building Division Abbottabad on 08.03.2024, as he filled W.P before the PHC (Abbottabad Bench).
- h. No comments.
- i. Pertains to record.
- j. Incorrect. The transfer/posting of the appellant has been made in the best public interest, as there is no mala-fide intension of the respondents, no discriminatory action and no violation of the rights of the appellant has been made.

- Incorrect. The impugned posting/transfer Notification has never violated any of the right of the Appellant, similarly he has got no right whatsoever to claim posting of his choice
- Incorrect as explained in para-d of the grounds. Furthermore, there is Ι. no mala-fide intension of the respondents, no discriminatory action and no violation of the rights of the appellant has been made. The action taken by the respondents are strictly in accordance with law/ regulations and under the existing rules.
- Incorrect, the appellant has been dealt with as per law & rules.
- Incorrect, as explained in para-4 of the Facts.
- Incorrect, although the Posting/Transfer policy provides for a tenure Ο. vet the section 10 of the Khyber Pakhtunkhwa Civil Servant Act, 1973, provides that "Every civil servant shall be liable to serve anywhere within or outside the province, in any post under the Federal Government, or any Provincial Government or Local authority, or a corporation or body set-up or Established by any such Government".
- Pertains to record..
- The aggrieved officer approached the Peshawar High Court q. Abbottabad Bench for cancellation of impugned/premature transfer. The court while hearing the case on 21.11.2023 converted the petition into appeal/representation and sent to Respondent No.2 to decide the same within 30 days from receipt of this order". On the Peshawar High Court Abbottabad direction of Appeal/Representation of the appellant processed and forwarded to Chief Secretary Khyber Pakhtunkhwa to decide the said appeal. The Chief Secretary Khyber Pakhtunkhwa has returned the case with the directions that as per rules of business the Posting/Transfer of the appellant is within the competency of the Administrative Secretary who may dispose this case on merit. Accordingly, the case was reexamined and the appellant (Muhammad Zaka Khan) SDO O/O XEN C&W Division Kohistan Lower has been transferred and re-posted as SDO O/O XEN Building Division Abbottabad on 08.03.2024.
- The Respondents would like to seek permission of this Hon'able r. Tribunal to advance more grounds during the time of arguments.

In view of the above, it is submitted that the Appeal may kindly be dismissed with cost.

- 3. That the petitioner has served the department more than 35 years with devotion, dedication and honestly for the satisfaction of his high-ups and has left no stone unturned for the betterment of the department during his service.
- 4. That the respondent No. 2 vide impugned order No. SOP/C&W D/4-7/2023 dated 17/11/2023 transferred and posted the present petitioner from C&W Department Building Division, Abbottabad to C&W Department Kohistan. Copy of impugned order dated 17/11/2023 is annexed as Annexure "C".
- 5. That, the petitioner has tried his best to convince the respondents for redressal of his grievances and for cancellation of the impugned order but in vain.
- 6. That, feeling aggrieved the petitioner seeks indulgence of this Honourable Court for setting-

aside the impugned order dated 17/11/2023, interalia on the following grounds.

GROUNDS;-

- a) : That, the impugned act/order dated 17/11/2023 is illegal, unlawful, without arbitrary, lawful authority, perverse, discriminatory and politically motivated, against the public interest consequently of no legal effects upon the rights of petitioner. Copy of the policy is annexed as Annexure "D"
- b) That the petitioner has served the department with zeal and zest and for the satisfaction of their superiors.
- c) That the petitioner has almost completed his service and is attaining the age of superannuation and is going to retire from service on 18/04/2025.
- d) That one Hilal Hussain adjusted on 03/11/2023 and soon after the adjustment he was transferred on his choice in his local area just because he is a blue-eyed of the concerned minister.
- e) That it is pertinent to mention here that petitioner has already served one and half year in a far-flung/unattractive area of District Kohistan, Mr. Muhamamd Naeem is Sub-Engineer BPS-16 who has been transferred at Abbottabad as SDO OPS and

petitioner is senior most SDO BPS-17 and some important projects are under process under the supervision of petitioner. therefore, the impugned order is liable to be set-aside.

- f) That the petitioner is ill and his spinal cord is not stable, disk are dis-located therefore, the petitioner is unable to travel for far-flung area of District Kohistan. Furthermore, the doctor has advised the petitioner for complete rest. Hence, the impugned order is liable to be set-aside. Copies of medical reports are annexed as Annexure "E".
- g) That about 1710 leaves are on the credit of petitioner and the petitioner has availed only
 35 leaves which was Ex Pakistan leaves.
 - That it is well settled by now that Article 199 casts an obligation on the High Court to act in Aid of law, protect the rights of the citizens within frame work \mathbf{of} Constitution against infringement of law and constitution by the executive authorities, strike a rational compromise and fair balance between the rights of the citizens and action of the state functionaries, claimed to be larger interest of the society. A power is conferred on the High Court under the constitution and is to be exercised subject to constitutional controlled executive action so as to bring it inconformity with the law. Whenever, the executive acts in violation of

the law an appropriate order can be granted, which will relieve the citizen of effects of illegal action. It is an omnibus article under which relief can be granted to the citizen of the country against infringement of any provision of law or of the constitution. If the citizen of this country are deprived of the guarantee given to them under the constitution, illegally or, not accordance with law then Article 199 can always be invoked for redress.

- i) That even otherwise, there was no lawful justification with the respondent No.2 to transfer/adjust the petitioner. This act of the respondents depicts sheer misuse of powers on their part. Hence, the impugned office orders are liable to be set-aside.
- j) That, the respondent No.2 transferred/posted/adjusted the petitioner without mentioning any reasons by ignoring all the rules, regulations and policy on the subject, hence, the impugned office order is liable to set-aside/cancelled.
- k) That the respondents have not treated the petitioner in accordance with law, rules and policy on the subject and acted in violation of Article-4 of the Constitution of Islamic Republic of Pakistan 1973 and unlawfully transferred/ adjusted the petitioner which is unjust, unfair, illegal, hence not sustainable in the eye of law.

PHEABBOTTABAD BENCH

- Act, 1897, where any authority is vested with the power to make any order, such power shall be exercised reasonably, fairly, justly and for the advancement of the purposes of the enactment under which the power is conferred but in the case in hand the power was not exercised as such, rather, the same was misused arbitrarily to the detriment of petitioner without any rhyme or reason, therefore, the impugned act of respondents is not legally maintainable.
- m) That it is inalienable right of every citizen to be treated in accordance with law and especially when placed in similar position with the other persons, thus, the impugned act being nullity in the eye of law is liable to be struck down.
- n) That the impugned order if seen from any angle, both factually and legally is not maintainable, hence, liable to be set-aside.
- o) That there is no other efficacious, speedy or adequate remedy available to the petitioner except the instant constitutional petition.
- p) That the addresses of the parties are correctly mentioned in heading of writ petition.
- q) That the court fee stamp paper wroth of Rs. 500/- is affixed.
