



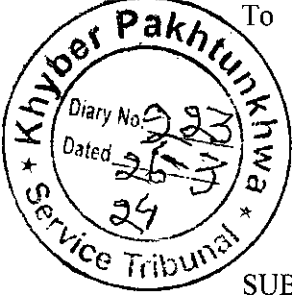




On the above it is, therefore, requested that the Show Cause Notice against this office may kindly be set aside.
