**WRITTEN REPLY ON BEHALF OF RESPONDENTS NO. 1 to 3**

**PRELIMINARY OBJECTIONS**

1. That the appellant has no cause of action/locus standi to file the instant appeal in the Tribunal.
2. That no legal right of the appellant has been infringed, therefore, the appeal is neither competent nor maintainable.
3. That the appellant is estopped by his own conduct to file the present appeal.
4. That the appellant has not come to the tribunal with clean hands.
5. That the appellant's claim is based on misstatement to misguide the Tribunal, therefore, his appeal is liable to be dismissed.

**RESPECTFULLY SHEWETH:**

**REPLY ON FACTS**

1. That Para 1 of the appeal is correct to the extent that the appellant is serving as Assistant Director Information (BPS-17) in the Directorate General Information & Public Relations (DGIPR), Khyber Pakhtunkhwa. Rest of the Para is incorrect as the appellant has proved himself as a nuisance for the department and the DGIPR through his unruly conduct and insubordination during his service career spanning over six years. Disciplinary actions initiated against the appellant on numerous occasions speak volumes of his misconduct and disobedience (Copies of Complaint/Inquiry Report are enclosed as **(Annexure-I)**, explanations as **(Annexure-II)**, warning as **(Annexure-III)**, charge sheets and statement(s) of allegations as **(Annexure-IV)**, Non Compliance of official orders as **(Annexure-V)**, Advice as **(Annexure-VI)**, Adverse Remarks recorded in his PER as **(Annexure-VII)**.

2. That para 2 of the appeal is totally incorrect as posting/transfers are part and parcel of civil service and always carried out in the best public interest. The appellant, being hailing from South Waziristan Tribal District, was initially transferred to Pakhtunkhwa Radio Wana after serving for more than six years at one station (HQ Office Peshawar) **(Annexure-VIII)**. The said notification of posting/transfer was

later on revised by the Competent Authority while honoring the written request (Annexure-IX) of the appellant wherein he pleaded for reversion of the order citing family issues. He was then transferred to Pakhtunkhwa Radio FM 92.2, Peshawar (Annexure-X). As far as the matter of cross cadre post of Producer is concerned, the statement of the appellant is totally misleading as all employees recruited/ promoted against the post of Assistant Director, Assistant Registrar, Producer, Station Manager and Information Officers have the same cadre and have the same qualification and method of recruitment as per rules. (Copy of Service Rules as Annexure-XI). Similarly, the Assistant Director Information/ Information Officer/ Station Manager/ Assistant Registrar/ Producer (BPS-17) have joint seniority for promotion against the post(s) of Deputy Director Information/ Public Relations Officer to Governor/Station Director (BPS-18) (Annexure-XII). Being sharing the same cadre, the Assistant Directors Information have been posted against the post of Producers and vice-versa on multiple occasions and performed their duties proficiently. Therefore no question of injustice with the appellant or violation of the prevailing laws and rules arise while transferring the appellant. Moreover, the respondent No. 3 Mr. Sajid Mehmood, Assistant Director Information (ACB), is a regular employee of the DGIPR and has been performing his duties as PRO with the Chief Secretary Khyber Pakhtunkhwa with utmost dedication.

3. That Para-3 of the appeal pertains to the privileges of the appellant and order of the Peshawar High Court, Peshawar, hence no comments.
4. In response to Para-4 of the appeal, it is submitted that the appellant has been treated as per law and rules, hence his appeal is not maintainable. It is purely the conduct of the appellant that may cause problems for him in the long run.

**ON GROUNDS:**

- A. Ground A of the appeal is incorrect as the notification dated 08/12/2023 is totally in consonance with the law and rules. Hence there is no need for interference by the Hon'ble Tribunal.
- B. Ground B of the appeal is also incorrect as no rights of the appellant guaranteed under Articles 4 & 25 of the Constitution of the Islamic Republic of Pakistan have been usurped. Rather the appellant has been treated precisely in accordance with the law.
- C. Ground C of the appeal is also incorrect as the notification of posting transfer dated 08/12/2013 is in consent with the Khyber Pakhtunkhwa Civil Servants Act 1973/ Posting transfer policy of the Provincial Government.

- D. Ground D of the appeal is misleading as the appellant has been treated purely according to law and no right, as enshrined in the Constitution of Pakistan, violated. His initial transfer to his home district was revised on humanitarian basis following his formal request for reversion due to family issues.
- E. Ground E of the appeal is also incorrect as the appellant was transferred to FM92.2 Peshawar, against his cadre post, after serving for more than six years in the HQ office.
- F. As Ground C above.
- G. Ground G of the appeal pertains to the judgment of the Tribunal which is not similar to the instant appeal. Hence no comments.

It is, therefore, most humbly prayed before this Hon'ble Tribunal to dismiss the instant appeal of the appellant with costs in favor of the government.

## INQUIRY REPORT

The undersigned was appointed as Inquiry Officer vide Administrative Department's Notification No. SO.Estt:(INF)1-45/2017/PF dated 02-04-2019 to probe the allegations/charges levelled by Section Officer (Schools Male), Elementary & Secondary Education Department, Government of Khyber Pakhtunkhwa against Mr. Habib Ullah, Assistant Director Information, Directorate General Information & PRs, Khyber Pakhtunkhwa vide letter No. SO(SM)E&SED/11-1/2019/Complaint dated 20-03-2019 (F/A). The allegations/charges pertain to interference in the official business of the department and behaving rudely with the staff.

2. In pursuance of the Administrative Department's notification, the officer under inquiry was directed vide letter No. INF/Estt:/PF/1922 dated 03-04-2019 to attend office of the undersigned on April 04, 2019 at 10:00 AM for personal hearing/written defence, if any, in connection with the inquiry (F/B).

3. In compliance, the officer under inquiry met the undersigned and also submitted his written reply on 04-04-2019 (F/C) wherein he termed the allegations/charges levelled against him as untrue. He rather accused the staff of the office of the Section Officer (Schools Male) for misbehaving and hurling extremely abusive language against him. Narrating the incident, he stated that he visited office of the section officer twice during the second and last week of February 2019 in connection with knowing the status of NOC required for M. Phil by his relative but every time he was told to come next week. He further said that he visited the said office on March 08, 2019 during the morning but the relevant official was not available on his seat. Then he again took a visit of the office after Friday prayer and requested for information in the case but the staff there remained busy in chitchat with each other for quite long. On his interruption, the staff got infuriated and besides using abusive language uttered the words like "TA YE SOK CHE TA MA NA DA TAPOS KAY", "You will not get the requisite information even if you approach the minister and secretary". He went on to say that despite their offensive behaviour, he left the said office without reporting the incident to higher authorities. He lamented that the staff of the SO's office illegally refused sharing the required information and later played to be the aggrieved party by levelling false allegations.

4. The Section Officer (Schools Male) was also asked vide letter No. INF/Estt:/PF/4510 dated 22-05-2019 to advise the concerned staff of the section, with whom Mr. Habib Ullah Khan, Assistant Director Information has reportedly mis-behaved, to attend office of the

undersigned on May 24, 2019 at 10:30AM for personal hearing/written statement, if any, in support of their allegations/ charges (F/D).

5. As advised, Mr. Asad, Assistant and Muhammad Javed, Senior Clerk working in office of the Section Officer (Schools Male) met the undersigned on the fixed date and time with a written statement/letter (F/E) wherein they stated that Mr. Habib Ullah, Assistant Director Information misbehaved with the staff when he visited their office on 08-03-2019 at 01:30 PM in pursuance of ex-post facto NOC of his relative. They said that the department had already issued letter to the concerned authority to fulfil the deficiency and re-submit the same for further processing but the officer (Mr. Habib Ullah) resorted to interfering in the official business of the department and also used abusive language. However, they verbally informed that they didn't want to inflict any harm to the officer under inquiry.

### FINDINGS

After going through the available record/documents, it has been found that both the officer under inquiry as well as the concerned staff of the office of the Section Officer (Schools Male) lacked the spirit of accommodation and have resorted to the exchange of harsh words/offensive language against each other, which is in no way in consonance with the good order/service discipline. The option of obtaining the required information under the Khyber Pakhtunkhwa Right to Information Act 2013 was also available with the officer under inquiry but he didn't resort to utilize it.

### RECOMMENDATIONS

The officer under inquiry may be cautioned to avoid such acts in future and behave like a gentleman as rude behaviour demonstrated by any government employee results only in tarnishing the image of the department concerned.

He has further requested that another officer may be provided to the Pakhtunkhwa Radio to fill the vacancy and ensure its smooth functioning.


