Respectfully Sheweth:-PRELIMINARY OBJECTIONS:

- i. That the present service appeal is incompetent in its present form.
- ii. That the appellant has got no locus standi to file the instant appeal.
- iii. That the appellant is been estopped by his own conduct to file appeal.
- iv. That the appellant has not come to this Honurable Service Tribunal with clean hands.
- v. That the present appeal is bad for mis-joinder and non-joinder of necessary parties.
- vi. That the present appeal is badly Time-barred.
- vii. That the present appeal is not based on solid ground liable to be dismissed with cost.

OBJECTION ON FACTS:

- 1. Pertains to record.
- Incorrect and not admitted. Actually if look into his past service history, a 2. number of penalties has been awarded to him on account of his willful absence from official duties time and again while posted at different jails in the province of Khyber Pakhtunkhwa. Detail of penalties (Annex-A). The appellant while attached to Central Prison Mardan was caught red handed by the Incharge of Dewdi gate by smuggling of 02 Android phones inside the jail premises which is prohibited under the Rule of 690 of Khyber Pakhtunkhwa Prison Rules 2018 (Annex-B) and accordingly proceeded departmentally and ultimately awarded him the Major penalty of Removal from Service vide Superintendent Headquarter Prison Mardan office order No.382-86 PB dated 01/02/2024. The Prison services is a sensitive force service and his misconduct in such situation is highly undesirable, unacceptable by rendering himself for departmental proceedings. His previous service history is full of red entries and a number of punishment till date has been awarded to him while posted at different jails of KPK the details of penalties is hereby reproduced as under:-
 - Placed under Suspension in a disciplinary case vide Superintendent HQs Prison Haripur order No. 1078 dated 14.06.2013 and upon completion of inquiry proceedings the concerned official is hereby Re-instated into Service w.e.f 15.06.2013 with immediate effect with further order that he is hereby awarded the penalty of "CENSURE" vide Superintendent HQs Prison Haripur order No. 1408 dated 11.07.2013.

- against him while attached to Central Prison Peshawar vide office order No. 6064 dated 06.01.2016, upon completion of proceedings under KPK Government Servants (Efficiency & Discipline Rules 2011), initiated vide this HQs endorsement No.76-78 dated 07.01.2016 is hereby Re-instated into Service with immediate effect with further order as under:-His period of absence from 28.12.2015 to 03.01.2016 (06 Days) is hereby treated as leave on medical grounds on full average pay while his further absence w.e.f 04.01.2016 to 06.01.2016 (03 days) is hereby treated as extra ordinary leave without pay vide Superintendent HQs Prison Peshawar office order No. 249 dated 15.01.2016.
- c) Awarded the minor penalty of "One increment stopped for one year". The period of absence w.e.f 03.10.2016 to 03.11.2016 thirty two (32) days is hereby treated as extra ordinary leave without pay vide Superintendent HSP Mardan order No. 3601.04 dated 25.11.2016.
- d) The Absence period w.e.f 31.01.2017 to 08.03.2017 thirty six (36) days is hereby ordered to be treated as **leave without pay** and is hereby awarded the minor penalty of "CENSURE" vide Superintendent HQs Prison Mardan No. 946-49 dated 18.03.2017.
- e) The absence period w.e.f 04.04.2017 to 07.04.2017 three (03) days is hereby treated without pay vide Superintendent HQs Prison Mardan No. 2029-30 dated 03.05.2017.
- The absence period w.e.f 27.05.2017 to 01.06.2017 five (05) days is hereby treated as **leave without pay** vide Superintendent HQs Prison Mardan No. 3484-85 dated 02.06.2017.
- The competent authority Inspector General of Prisons KPK Peshawar vide order No. 10875 dated 18.03.2022, have been guilty of inefficiency and negligence in performance of their official duty of the said warder under suspension with immediate effect, the competent authority is hereby please to "Exonerate" him from the charges levelled against him and warm him to be careful in future. He is also re-instated into service with immediate effect vide I.G Prisons office order No. 15798 dated 17.05.2022.
- h) In exercise of powers conferred under Rule-14(5) of Khyber Pakhtunkhwa Government Servants (E&D) Rules 2011, the absence period w.e.f 11.03.2022 to 15.03.2022 five (05) days is hereby treated as leave without pay vide Superintendent HQs Prison Peshawar order No. 5084-87 dated 01.06.2022.
- i) The appellant was awarded the major penalty of "Removal from Services" for his misconduct/unlawful act of smuggling of two (02) Android phones inside the Jail through Dewry gate of the Jail vide Superintendent Circle Headquarter Prison Mardan Order No. 382-86/PB dated. 01-02-2024, after observing proper procedure and completion of all legal formalities.
- j) The appellant departmental appeal is hereby partially accepted and his major penalty "Removal from Service" is hereby converted into minor penalty "Withholding of Increments for three years". The Intervening period i.e. from the date of removal from service to the date of re-instatement in service is hereby treated as leave without pay vide Inspector General of Prisons Khyber Pakhtunkhwa office order No. 15082 dated 26.03.2024.
- 3. Incorrect and not admitted. A proper legal formalities have been fulfilled under the KP E&D Rules 2011. Statement of allegation (Annex-C) as well as charge sheet (Annex-D) was properly served upon him. Moreover, a regular inquiry (Annex-E) was also conducted against him before awarding major penalty a proper Show Cause Notice (Annex-F) was also served upon him but the reply on the part of appellant was found unsatisfactory.

Opportunity of personal hearing (Annex-G) was also provided to the appellant to prove himself innocent but he could not did so. Resultantly, major penalty in shape of Removal from Service was awarded to him vide Superintendent HQ Prison Mardan No.382-86 PB dated 01/02/2024 (Annex-H).

- **4.** Details of this Para is elaborated in Para-03 above.
- 5. Admitted to the extent that the appellant preferred Departmental Appeal to the Inspector General of Prisons being respondent No.01 in the instant service appeal (the appellate authority) feeling aggrieved from the office order of respondent No.02 (the appellate authority) after examining all the record/evidence against him took lenient view with the appellant and partially accepted his departmental appeal(Annex-I) and converted the Major Penalty of Removal from Service into Minor Penalty "withholding of increments for 03 years" and treated intervening period from the date of Removal from Service i.e 01/02/2024 to Reinstatement into Service i.e 26/03/2024 vide IG Prison office order No.15082 dated 26/03/2024 (Annex-J).
- 6. Incorrect, misleading as the appellant has been treated in accordance with the Law and rules.

OBJECTION ON GROUNDS.

- i. Incorrect and misleading, as the order of the Competent Authority and Appellate Authority are in accordance with the Law and Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules 2011.
- ii. Incorrect and misleading, as the Appellant has been treated in accordance with the Law and as per procedure laid down in the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules and articles 4 and 25 of the Constitution of the Islamic Republic of Pakistan 1973 have not been violated by the respondents and are not liable to be set aside.
- iii. Incorrect and not admitted. Detail of this Para is elaborated in Para-03 of facts.
- iv. Incorrect and not admitted. Detail of this Para is elaborated in Para-03 of facts.
- v. Incorrect and not admitted. Detail of this Para is elaborated in Para-03 of facts.
- vi. Incorrect and not admitted, as the mobiles phones were recovered from the appellant inside Jail i.e. (Dewhri) and the statements of Akmam Ullah (Head Warder) and Rustam Shah (Chief Warder) were not recorded as they were not allotted duty at Jail Dewhri.
- vii. Incorrect and not admitted. Detail of this Para is elaborated in Para-03 of facts.
- viii. Minor penalty was recommended to the appellant by the inquiry officer, but even though charges were also proved against him, so it's the jurisdiction of competent authority to impose any major or minor penalty to the defaulter concerned under the E&D Rules, 2011.
 - ix. Incorrect and misleading, as appellant was given proper opportunity of hearing on 01-02-2024.
 - x. Incorrect and not admitted. Detail of this Para is elaborated in Para-2 of facts.
 - **xi.** That the respondent departments would also seek permission of this Honorable Service Tribunal to raise additional objection at the time of arguments.

PRAYER.

Reference to your Office letter No. 3372-76 dated: 28-11-2023.

After having been appointed as an Inquiry Officer vide letter under reference, the undersigned adopted proper procedure as per rules mentioned in the Khyber Pakhtunkhwa Government Servants Efficiency & Discipline Rules 2011 (amended in 2021) for initiating Inquiry against accused Head Warder Muhammad Yaseen S/O Muhammad Mursaleen attached to Central Prison Mardan for recovery of Android Mobile/ Cell Phone concealed in his front pocket during body search at Main Dewry as specified in the Statement of Allegations.

PROCEDURE.

In order to find the factual position of the case, the undersigned fixed a date for inquiry proceeding and summoned the accused to appear for inquiry Proceedings proceeded on the date fixed. In this respect the undersigned proceeded to Central Prison Mardan and a thorough inquiry was conducted in to the matter. The accused official attended the Inquiry proceedings and submitted his written statement which is self-explanatory and attached as Annexure-A. An opportunity of hearing was given to him and he was cross examined. Similarly, other relevant staff were also interrogated and recorded their statements which are enclosed as Annexure-B1,B2,B3... In the light of written statement of the accused and other staff, following facts and findings were discovered: -.

FACTS & FINDINGS.

As per statement of allegations "during body search in Dewry, the accused handed over one Android Mobile voluntarily to Warder Usman (Talashi Gate) white another Android Mobile Phone was recovered from his possession". In this respect the accused Head Warder admitted that he handed over one mobile phone voluntarity to Talashi Gate

while the 2nd Mobile Phone was recovered from his possession which he purchased in Peshawar for his wife and forgot in his pocket.

During cross examination, he did not provide receipt/any documentary evidence of the Mobile Phone which he purchased, thus the burden of proof lied on him to defend himself.

During Course of inquiry proceedings and verbal discussion, the undersigned felt that his statement is not based facts as such if he purchased the Mobile Phone then he was required to: -

- 1. Keep the phone in his Home at Peshawar and hand over the Mobile Phone to his wife.
- 2. Hand over the Mobile Phone to his colleagues/roommates till his duties timing.
- 3. Hand over the Mobile Phone to Talashi Gate like he handed over the other one.

Therefore, statements/defense reply of the accused Head Warder is not satisfactory and seems nothing instead plethora of verbose.

Likewise, from the perusal of statements of other staff members i.e. Talashi Gate, Line Muharrar, Line Officer, it is also evident that Mobile Phone without SIM was recovered from his possession. As per statement of Line Muharrar, neither was he granted any leave nor rest/Bachat on the same day then how can it possible that he purchased the mobile in Peshawar, which also generate question mark on his statements. Hence charge proved against him.

Anyhow, the Mobile Phone was recovered from his front pocket of his shirt which create a little bit doubt.

Moreover, previous service record of the accused Head Warder was also checked wherein it was observed that he was never involved in smuggling of Mobile Phone or other contrabands to inside the Jail during his service.

CONCLUSION:

In view of the above narrated facts and findings, the undersigned concluded that the accused Head Warder did not submit any documentary poof in his defense to justify his innocence. Therefore, the undersigned recommended minor penalty of Stoppage of Three Annual Increments for the period of Three Years or any other punishment as the competent authority deemed appropriate, please.

SUBJECT: REPLY OF FINAL SHOWCAUSE NOTICE OF LUNDER SUSPENSION HEAD WARDER MUHAMMAD VASEEN S/O MUHAMMAD MURSALEEN ATTACHED TO CENTRAL PRISON MARDAN

*As per report of Superintendent Central Prison Mardan that Head Warder (BPS-09) Muhammad Yascen S/O Muhammad Mursaleen, while entering inside the jail for his allotted duty at Sector No. 05 as relief from lockout to 08:30 AM. He handed over one Android mobile phone to Warder Usman (Talashi Gate) and another Android mobile/cell phone was recovered from his possession without sim card concealed by him in his front pocket of his Qamecz by Warder Usman (Talashi Gate) at about 06:31 AM on 28.11.2023 during routine search at Dewri. The recovery was made in the presence of Warder Shahid Masih (Talashi Shab) and Warder Saleem (Chubi Mute) at Dewri of the jail. The Superintendent Jail requested for the suspension of the accused Warder with immediate effect and necessary disciplinary action may be taken against him under E&D Rules 2011.

The concerned head warder was suspended on the request of Superintendent Central Prison Mardan vide this office order Endst No. 3367-70 dated 28.11.2023 and inquiry was initiated against the accused Head Warder and Mr. Amin Shunib while Superintendent District Jail Timergara and now Commandant Prisons Staff Training Academy Haripur was appointed as inquiry officer vide this office letter Endst No. 3372-76 dated 28.11.2023. Accordingly he furnished the inquiry report and his findings and recommendations vide his office letter No. 194/WE dated 17.01.2024 which are as under:-

FINDINGS & FACTS;

As per statement of allegations during body search in Dewry, the accused handed over one Android Mobile voluntarily to Warder Usman (Talashi Gate) while another Android Mobile Phone was recovered from his possession". In this respect the accused Head Warder admitted that he handed over one mobile phone voluntarily to Talashi Gate while the 2nd Mobile Phone was recovered from his possession which he purchased in Peshawar for his wife and forgot in his pocket.

During cross examination, he did not provide receipt/any documentary evidence of the Mobile Phone which he purchased, thus the burden of proof lied on him to defend himself.

During Course of inquiry proceedings and verbal discussion, the undersigned felt that his statement is not based facts as such if he purchased the Mobile Phone then he was required to:-

- 1. Keep the phone in his Home at Peshawar and hand over the Mobile Phone to his wife.
- 2. Hand over the Mobile Phone to his colleagues/roommates till his duties timing.
- 3. Hand over the Mobile Phone to Talashi Gate like he handed over the other one,

Therefore, statements/defense reply of the accused Head Warder is not satisfactory and seems nothing instead plethora of verbose.

Likewise, from the perusal of statements of other staff members i.e. Talashi Gate, Line Muharrar, Line Officer, it is also evident that Mobile Phone without SIM was recovered from his possession. As per statement of Y Line Muharrar, neither was he granted any leave nor rest/Bachat on the same day then how can it possible that he purchased the mobile in Peshawar, which also generated question mark on his statement. Hence charge PROVED against him.

Anyhow, the Mobile Phone was recovered from his front pocket of his shirt which create a little bit doubt. Moreover, previous service record of the accused Head Warder was also checked wherein it was observed that he was never involved in smuggling of Mobile Phone or other contrabands to inside the Jail during his service.

CONCLUSION:

in view of the above narrated facts and findings, the undersigned concluded that the accused Head Warder did not submit any documentary proof in his defense to justify his innocence. Therefore, the undersigned recommended minor penalty of Stoppage of Three Annual Increments for the period of Three Years or any other punishment as the competent authority deemed appropriate, please.

Pinul Showcause notice was issued to the concerned (Under Suspension) Head Warder vide this office letter No. 192-94-WE dated, 20,01,2024.

In the reply the Heat Warder Stated that "On the relevant day he was in possession of two Android cell phones which he handed over to warder namely Usman (Talashi Cate). The Android Cell Phone was cell phones which he would be welcomed over to the warder. It is incorrect that the same



ORDER:

WHEREAS, Ex-Head Warder Muhammad Yaseen S/o Muhammad Mursaleen, while attached to Central Prison Mardan was awarded the major penalty of "Removal From Service" by Superintendent HQs Prison Mardan vide order No. 381-86 dated 01-02-2024 due to his misconduct / recovery of mobile phone inside the Jail's main gate.

AND WHEREAS, the said Ex-Head Warder preferred his departmental appeal for setting aside the penalty awarded to him and also requested for reinstatement.

AND WHEREAS, he was afforded an opportunity of personal hearing on 14-03-2024. His appeal was examined in light of the available record of the case and it was observed that keeping in view the nature of case, the inquiry officer recommended the minor penalty of withholding of three increments, but the competent authority awarded him the major penalty without recording any cogent reason. During the course of hearing, the appellant produced the cash memo of mobile phone as a proof which showed that the appellant had purchased the mobile phone for himself which recovered from him. Moreover, the cash memo and the recovered mobile has similar IMEI Number which endorsed plea of the appellant. Going through his 18 years service history, it was found that his service record is reasonably clean. Hence, plea of the appellant is partially justified and the penalty is found too harsh.

NOW THEREFORE, having considered the charges, evidences/facts on record as well as the provision of rules in vogue and in exercise of powers conferred under Rule-17 of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 read with Rule-05 of Khyber Pakhtunkhwa Service Appeal Rules 1986, appeal of the appellant is hereby partially accepted and his major penalty of "Removal from Service" is hereby converted into minor penalty "Withholding of Increments for three years". The intervening period i.e. from the date of removal from service" to the date of re-instatement in service is hereby treated as leave without pay.
