Respectfully Sheweth:

The Applicant humbly submit as under

(3)

1. That the appellant is law abiding and peaceful citizen of Pakistan and permanently residing at District Chitral.

(Copy of Cnic is annexed as A

- 2. That the appellant was appointed on 26 November 2009 as a Key Punch Operator BPS-11 in prescribed manner in the office of the respondent No. 2 and is still serving over there as a computer operator (BPS-16). (Copy of appointment order is annexed as B).
- 3. That the services of employees in the office of the respondent No 4 is regulated by the KPK Civil Servants (Appointment, Promotion, Transfer) Rules, 1989, herein after referred to as the rules and kpk Civil servant Act 1973 according to which for proper administration of service, cadre or Post appointing authority shall cause as seniority list which would be effected from the date of regular appointment to the post and similarly, the seniority list prepared under the relevant rules shall be revised and notified in the official Gazette at least once in a calendar year.
- 4. That after one years of the appointment of the Appellant in the office of the respondent No. issued a revised seniority list in the year 2010, according to which the appellant was standing in the serial No. 4 of the seniority list as he was senior amongst his junior colleagues as per his date of birth,04-09-1982. (Copy of the revised Seniority list year 2010 is annexed as c.)
- 5. That in the aforesaid manner the respondent Now being a competent authority issued various revised seniority lists of computer operators of his good office from year 2010 to 2022 and similarly the order of the appellant in the said seniority lists were not disturbed and he was standing at serial No 07 according to the last correct seniority list issued by the office of the respondent No 2. (Copy of the Seniority list from year 2010 to 2022 as annexed D,1,2,3,4,5,6,)
- 6. That on 06-01-2024 through office order No 9411-12/SL-V/DCLC/Estt the respondent No office issued another final seniority list of the computer operators, where by new improvement was made as the previous correct seniority list was altered and modified by the respondent no being a competent authority, due to which the status of the appellant got changed as he was demoted from serial No. 07 to serial No. 12 of the impugned seniority list, directly effecting and changing the status of the appellant from senior to junior and one Rafiq Ahmad baig, computer operator, who was senior to the appellant replaced him in the said seniority list, thus

junior and one Rafiq Ahmad Baig computer operator who was senior to the appellant replaced him in the said seniority (Copy of impugned disputed seniority list is annexed as E).

7. That soon after the issuance of the ibid impugned disputed seniority list the appellant approached the office of the Respondent No 2 being a competent authority by filling a departmental representation through diary No 5055 Dated 16-02-2024 for rectification in the impugned seniority list as it was issued against the prevailing seniority list, since the appointment of the appellant in the good office of the respondent No 2 but he never entertained the said departmental representation as per prevailing rules. (Copy of departmental Appeal is annexed as F).

8. That on 17-04-2024 Respondent No 2 in response to the departmental representation of the appellant issued another final seniority list through order No 9411-12/SL-V/DCLC/Estt. In this way he upheld the previous seniority list issued on 06/02/2024 without any correction and gave it the status of final seniority list without following the appeal of the status of final seniority list

without following the prevailing rules in this regard.

(Copy impugned disputed seniority list is annexed as G)

That feeling aggrieved and having no other remedy except to approach this honorable tribunal on the following amongst other grounds.

Grounds;

9.

- (a) That the appellant is peaceful and law abiding citizen of Islamic republic of Pakistan and is fully entitled to all the basic and fundamental rights as enshrined in the fundamental law of the state, interpreted and guaranteed by the law of the land.
- (b) That the impugned final seniority list dated 17-04-2024 and 06-02-2024 are illegal, has no effect upon the appellant rights and issued in violation of services rules as well against the principle of natural justice.
- (c) That total length of appellant service performed till date is more than 14 years, most importantly the appellant performed his duties with care and efficiency, till date there is no complaint against the performance of the appellant neither by the competent authority nor from the locality.
- (d) That the respondent No. 2 deliberately, intentionally, purposefully, and illegally placed the name of the most juniors before the name of the appellant in the impugned seniority list

before the name of the appellant in the impugned seniority list which will adversely affect the appellant in future promotion matters, thus the name of the appellant is liable to be placed before the name of all junior candidates.

- (e) That according to the KPK civil servant act,1973 the respondent No being a competent authority is authorized only to revised annual seniority list of the appellant but the said respondent has illegally and without any lawful excuse has altered and modified the said seniority list thus there by changing the position of the appellant from senior to junior.
- (f) That according to the prevailing act it is provided that the concerned authority has no power to alter, modify or to change the status of the seniority list without observing the chronological order maintained by the office since the appointment of appellant and his other colleagues.
- (g) That it is provided in the KPK Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 that if the date of regular appointment of two or more civil servants in the lower post is same, the civil servant older in age, shall be treated senior. Similarly in this way the appellant is one of the senior employee as per his date of birth mentioned in impugned seniority list and the same fact and rules has been ignored by the respondent No 4 just to give favor to his liked persons in the said seniority list.
- (h) That the appellant has right and entitlement to stand in his own correct serial No 2 in the final seniority list as issued earlier to the disputed one, If not done so his departmental promotion will be directly affected and will act as a bar on his promotion in near future.
- (i) That the appellant has been discriminated, which is against the provision of article 25 & 27 of the constitution of 1973.
- (j) That the appellant has been not treated in accordance with the law as against the provision of Article 4 of the constitution.
- (k) That due to the illegal and unlawful act of the Respondent No 2.

 (k) the professional future of the appellant is at stake as the employs of the same cadre junior to him have been listed as a senior, which is against the laws rules and natural justice.

- (I) That all of the above mentioned facts and laws clearly suggest that a discrimination, nepotism and favoritism has been exercised by depriving the appellant from his legal rights. which needs to be rectified.
- (m) That any other grounds with the leave of this honorable services tribunal, will be raised at the time of arguments.

PRAYERS

It is therefore most humbly prayed that on acceptance of this service appeal the respondent may kindly be directed to place the appellant name before all junior candidates i.e Fahad Jalal at serial No. 07 and others in seniority list issued by the respondent 4 and further to direct the respondents to consider the final list for seniority and promotion which this honorable tribunal direct to act upon.

Any other remedy to which the appellant is found fit in law, justice and equity may also be granted.





- 3. Misinterpretation of Policies: It appears that certain governmental policies or guidelines were misinterpreted or overlooked in the compilation of the seniority list. This has led to discrepancies that unfairly disadvantage certain employees, including the undersigned.

We request that kindly initiate a thorough review of the seniority list to rectify these errors and ensure its accuracy. It is imperative that the seniority list reflects the true tenure and experience of each employee to uphold fairness and transparency within the Department.

Furthermore, we have previously objected the Seniority List. We are committed to ensuring that our rights as an employee(s) are upheld and that all relevant factors are taken into account in determining our seniority status.
