DATED 12/02/2014 OF THE APPEAL WITHIN THE
STATUTORY PERIOD OF 90 (NINETY) DAYS.

PRAYER:

That on acceptance of this appeal the act & omission of the respondent by not counting the previous service of the appellant served since 01-12-2014 for the purpose of pay, pension & promotion including seniority may very kindly be declare as illegal, void abi initio & unconstitutional. That the respondent may further please be directed to count the previous service of the appellant served since 01-12-2014 for the purpose of pay, pension & promotion including seniority by following the PRINCIPLE OF PARITY. Any other remedy which this Tribunal deems appropriate and has not specifically been asked for that may also be awarded in favor of the appellant.

Respectfully Sheweth:;

FACTS:

Brief facts giving raise to the instant appeal are as under:

1. That appellant is a regular employee of the respondent Department and was initially appointed as PST (BPS-12) school based policy vide order dated 01-12-2014 for the said appointment the respondent has issued an advertisement wherein the last for submission of application form was 31-05-2012 and accordingly the appellant applied and was selected to the post.
Copy of Advertisement & Appointment Order dated 01.12.2014 is attached as ANNEXURE A.
2. That after receiving the appointment order dated 01-12-2014 the appellant was medically examined and was declared medically fit for government job; accordingly the appellant submitted his arrival/charge report on 03-12-2014.
Copy of Medical Certificate & Charge Report dated 03.12.2014 is attached as ANNEXURE B.
3. That respondent announced other PST posts through NTS in the year 2015 for which the appellant also applied, became successful and was accordingly selected to the post after fulfilling all the codal and legal requisite formalities vide appointment order dated 26-03-2016.
Copy of Appointment Order dated 26.03.2016 is attached as ANNEXURE C.
4. That the appellant tender resignation on stamp paper, got relieved from the post of 2014 and submitted his joining report on the same day for availing the charge of the post dated 26-03-2016, hence the continuity in the service between 2014 and 2016 remain intact with no break in both the services.
Copy of Resignation & Charge Report dated 28.03.2016 is attached as ANNEXURE D.
5. That service of the appellant was regularized vide order dated 12-03-2018 and as such similarly employees who are appointed in other District of the department are given benefit of FR-22 (b) by counting their previous service but the appellant has been deprived from such benefits and the previous service served since 2014 has not been counted towards pay, pension & promotion including seniority.
Copy of Regularization order dated 12.03.2018 Orders & Appellant Pay Slip is attached as Annexure E.
6. That feeling aggrieved from the acts & omission of the respondent by not counting the previous service served since 2014 towards pay, pension & promotion including seniority the appellant filed Department Appeal dated 12-02-2024 ..

which was forwarded to the respondent vide letter dated 12-02-2024 but no response has been received after lapse of statutory period of 90 days.

Copy of Departmental Appeal dated 12.02.2024 & Letter is attached as ANNEXURE F.

7. That the appellant feeling highly aggrieved and is left with no other remedy but to file the instant service appeal before this Tribunal on the following grounds:

G R O U N D S:

- A-That act & omission on the part of the respondents by not counting the previous service served since 2014 towards pay, pension & promotion including seniority is against the law, rules, facts, void ab initio, Norms of Natural Justice and materials available on the recordhencenot tenable in the eye of Law and is liable to be set aside to the extent of the appellant.
- B- That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C-That the respondents acted in an arbitrary and malafide manner by not counting the previous service served since 2014 towards pay, pension & promotion including seniority.
- D- That act & omission on the part of the respondents by not counting the previous service served since 2014 towards pay, pension & promotion including seniority is against Article 38 (e) of the Constitution of Pakistan, 1973 which is as:
"state is bound to reduce disparity in the income and earning of the individuals including persons in the various services of Pakistan.
- E- That act & omission on the part of the respondents by not counting the previous service served since 2014 towards pay, pension & promotion including seniority is a clear violation of Article-37 of the Constitution of Islamic Republic of Pakistan which is regarding the eradication of social evils in the society and promotion of social justice.
- F- That act & omission on the part of the respondents by not counting the previous service served since 2014 towards pay, pension & promotion including seniority is a clear violation of the Fundamental Rights as enshrines the Constitution of Pakistan & also against various judgments passed by the Apex Supreme Court of Pakistan.

- G-That act & omission on the part of the respondents by not counting the previous service served since 2014 towards pay, pension & promotion including seniority hence the same is against the norm of Natural Justice.
- H-That act & omission on the part of the respondents by not counting the previous service served since 2014 towards pay, pension & promotion including seniority is against CSR-418 as the resignation does not fall within the meaning of the parameters required for tendering of resignation from the post and as such the same also does not fall in the ambit of breakage in service.
- I- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

TERMS & CONDITIONS.

1. NO TA/DA etc is allowed.
2. Charge reports should be submitted to all concerned in duplicate.
3. Appointment is purely on temporary & contract basis initially for one year.
4. Appointment is subject to the condition that the certificate/documents must be verified from the concerned authorities by the DEO . Anyone found producing bogus Certificate will be reported to the law enforcing agencies for further action.
5. His services are liable to termination on one month's notice from either side. In case of resignation without notice his one-month pay/allowances shall be forfeited to the Government. Pay will not be drawn until and unless a certificate to the effect by DEO(concerned) is issued that his certificates are verified.
6. He should join his post within 10 days of the issuance of this notification. In case of failure to join their post within 10 days of the issuance of this notification, his appointment will expire automatically and no subsequent appeal etc shall be entertained.
7. Health and Age Certificate should be produced from the Medical Superintendent concerned before taking over charge.
8. Before handing over charge he will sign an agreement with the department, otherwise this order will not be valid.
9. He will be governed by such rules and regulations as may be issued from time to time by the Govt.
10. His services shall be terminated at any time, in case his performance is found unsatisfactory during his contract period. In case of misconduct, he shall be preceded under the rules framed from time to time.

The employees whose services are regularized under The Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education (Appainment and Regularization of Services) Act, 2017 (Khyber Pakhtunkhwa Act No.1 of 2018) or in the process of obtaining service at the commencement of The Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education (Appainment and Regularization of Services) Act, 2017 (Khyber Pakhtunkhwa Act No.1 of 2018) shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis, on the commencement of The Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education (Appainment and Regularization of Services) Act, 2017 (Khyber Pakhtunkhwa Act No.1 of 2018), and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.
- 9.) The seniority inter-se of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officiation in such service or cadre.




