


Respected Sir,





**That the brief facts of the case are as under:**

1. That the Appellant was appointed initially as IT Teacher (BS-16) and later on regularized vide order dated 04-07-2017 w.e.f his date of first appointment i.e 09-02-2008. Copy of regularization order is Annexure A.
2. That appellant was promoted as SS-IT (BS-17) vide order dated 04-02-2021. Copy of promotion order is Annexure B.
3. That respondent issued Tentative Seniority list of SS-IT (BS-17) Male as stood on 31-12-2023 in which the petitioner was wrongly placed at serial no 82 instead of 78. Copy of tentative seniority list is Annexure C.

4. That feeling aggrieved from Seniority list dated 31-12-2023, the appellant filed an appeal for correction of seniority list through proper channel on 20-01-2024 which was forwarded by the Director DPD on 30-01-2024. Copy of Appeal, Covering Letter and Postal receipt are annexure D.
5. That feeling aggrieved from above said office orders & no response of the departmental appeal with in requisite period, the appellant is constrained to approach this honorable court on the following amongst others:

GROUNDS;

1. That the appellants are not treated in accordance with law and rules of seniority framed by the Govt of KPK and malafidely being discriminated.
2. That as per Section 17 of Khyber Pakhtunkhawa Civil Servants (Appointment, Promotion & Transfer) Rules 1989, provides that *"if the date of regular appointment of two and more civil servants in the lower post is the same, the civil servants older in age, shall be treated senior"*, but while issuing seniority list the respondent completely ignored this rule and appellant is being placed at serial No 82 while as per date of birth of the petitioner is entitled to be mentioned at serial No 78 as per ibid rule.
3. That the respondent wrongly placed the appellant at serial No 82 in the seniority list presume ably due to any other reason which is not a correct criteria for determining the inter-se-seniority of civil servants while the rule provides clear direction to the department that two civil servants in continuous service the older in age shall rank senior to the younger one so the seniority list issued by the department is wrong against law & rules and natural justice.

In view of the above, It is, therefore, most respectfully prayed that on acceptance of this appeal the honorable court may pleased to declare the Seniority list dated 31-12-2023 being void, illegal, without lawful authority and of no legal effect & the appellant may kindly be placed at serial No 78 of seniority list as per ibid rule.



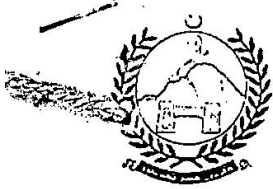


