





PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL, APPOINTMENT/ PROMOTION ORDER OF RESPONDENTS NO. 4 & 5 MAY BE SET ASIDE AND RESPONDENT NO. 3 MAY BE DIRECTED TO PROMOTE THE APPELLANT AS JUNIOR CLERK W.E.F THE DATE OF PROMOTION OF RESPONDENTS NO. 4 & 5 WITH ALL SERVICE BACK BENEFITS. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEMS APPROPRIATE IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE GRANTED TO THE APPELLANT.

Respectfully Sheweth:-

That facts forming the backgrounds of the instant service appeal are arrayed as under:-

1. That the appellant is serving in the respondents department as class-IV employee since 1995 onward. Copies of papers showing the date of appointment of the appellant are attached as Annexure "A".
2. That as per law, the appellant is to be promoted/appointed as Junior Clerks against 33% reserved quota without conducting test and interview. The sole criteria of appointment/

promotion of Class-IV to the post of Junior Clerk against 33% quota on the principle and qualification of seniority. The respondents department did not appoint/ promote the appellant on the basis of seniority cum qualification.

3. That respondent No. 3 without following the law on the subject, promoted respondents No. 4 & 5 who are juniors to the appellant and are not eligible for promotion on the principle of seniority cum qualification. **In this regard, impugned appointment/ promotion order dated 04/01/2023 of respondent No. 4 & 5 is attached as Annexure "B".**
4. That the appellant is senior to the respondent No. 4 & 5 as per seniority list. **Copy of seniority list of the appellant is attached as Annexure "C".**
5. That feeling aggrieved from the impugned promotion/ appointment orders of respondents No. 4 & 5, the appellant filed departmental appeals which is yet to be decided by the respondents' department. **Copies of departmental representation is attached as Annexure "D".** Hence, the instant service appeal is filed, inter-alia on the following grounds:-

GROUNDS; -

- a) That as per law, Class-IV employees are promoted to the designation of Junior Clerk simply on the basis of seniority cum qualification, but respondents with malafide

intention accommodated respondents No. 4 & 5 in place of the appellant which is illegal and there appointment order dated 04/01/2023 is liable to be set aside.

- b) That the appellant as per law was to proceed regarding the promotion of Class-IV, but intentionally violated the rules on the subject. **Relevant rules on the subject are attached as Annexure "E"**.
- c) That when law prescribe a thing which is to be done in a particular manner that must be done in that manner and not otherwise.
- d) That the respondents department has used a sledged hammer to crack the nut which shall destroy the savory of the nut when nut cracker is available to crack the nut. The appellant are eligible in all respect to be promoted/ appointed as Junior Clerk against 33% quota.
- e) That the act of the respondents towards the appellant is malafide, discriminatory, against the law. The appellant is entitled to be promoted as Junior Clerk in place of respondents No. 4 & 5. Therefore, appointment order of respondent No. 3 is liable to be set aside.
- f) That the matter relates to the term and condition of service. Hence this Honourable

Tribunal has jurisdiction to entertain the service appeal of the appellant.


- g) That the instant service appeal is well within the period of limitation.
- h) That the valuable rights of the appellant are involved.
- i) That other points shall be urged at the time of arguments.

It is therefore, most humbly prayed that on acceptance of instant service appeal, appointment/promotion order of respondents no. 4 & 5 may be set aside and respondent no. 3 may be directed to promote the appellant as junior clerk w.e.f the date of promotion of respondents no. 4 & 5 with all service back benefits. Any other relief which this Honourable Tribunal deems appropriate in the circumstances of the case may also be granted to the appellant.

The sole criteria of appointment/promotion of Class-IV to the post of Junior Clerk against 33% quota is the seniority as well as qualification. The respondents department did not appoint/promote the petitioner on the basis of seniority cum qualification.
3. That respondent No. 3 without following the law on the subject, promoted respondents No. 4 & 5 who are juniors to the petitioners and are not eligible for promotion on the principle of seniority cum qualification. In this regard,





impugned appointment/ promotion order dated 04/01/2023 is attached as Annexure "B".

4. That the petitioners are senior to the respondents No. 4 & 5 as per seniority list. Copy of seniority list of the petitioners is attached as Annexure "C".
5. That feeling aggrieved from the impugned promotion/ appointment orders of respondents No. 4 & 5, the petitioners filed departmental appeals which are yet to be decided by the respondents department. Copies of departmental representation are attached as Annexure "D". Hence, the instant writ petition is filed, inter-alia on the following grounds:-


GROUNDS; -

- a) That as per law, Class-IV employees are promoted to the designation of Junior Clerk simply on the basis of seniority cum qualification, but respondents with malafide intention accommodated respondents No. 4 & 5 in place of the petitioners which is



illegal and there appointment order dated 04/01/2023 is liable to be set aside.

- b) That the petitioner as per law was to proceed regarding the promotion of Class-IV, but intentionally violated the rules on the subject. **Relevant rules on the subject are attached as Annexure "E".**
- c) That when law prescribe a thing which is to be done in a particular manner that must be done in that manner and not otherwise.
- d) That the respondents department has used a sledged hammer to crack the nut which shall destroy the savory of the nut when nut cracker is available to crack the nut. The petitioners are eligible in all respect to be promoted/ appointed as Junior Clerk against 33% quota.
- e) That the act of the respondents towards the petitioners is malafide, discriminatory, against the law. The petitioners are entitled to be promoted as Junior Clerk in place of

respondents No. 4 & 5. Therefore, appointment order of respondents No. 4 & 5 are liable to be set aside.

- f) That there is no other prompt and efficacious remedy available to the petitioners except the invocation of writ jurisdiction of this Honourable Court.
- g) That necessary notices as per law has been served upon the respondents through registered mail. Copy of notice and registered receipts thereof are annexed as Annexure "F".
- h) That court fee stamp paper worth Rs. 500/- is attached.
- i) That the other grounds shall be urged at the time of arguments.

It is therefore, most humbly prayed that on acceptance of instant writ petition, appointments/promotion order of respondents No. 4 & 5 may be set aside and respondent No. 3 may be directed to appoint/
