Respected Sheweth,

- 1) That Mr. Imtiaz Hussain S/o Sajjad Hussain (presently Appellant) was initially appointed as a Junior Clerk in BPS-11 in District Judiciary Kurram on 16.05.2019 and was placed at Serial No. 2 in Seniority/Merit List.
- 2) That after three (03) years service length, Departmental Promotion Committee (DPC) was held on 21.05.2022, in which eight (8) Junior Clerks (BPS-11) were promoted to the eight (8) vacant positions of Senior Clerks (BPS-14).
- 3) That when the DPC was being conducted on 21.05.2022, as per "Tentative Common Seniority List of the Establishment of the District and Sessions Judge, Kurram as stood on June 30th, 2021", Mr. Imtiaz Hussain (Appellant) was placed at Serial No. 2 but the DPC/Committee deferred him from promotion from the post of Junior Clerk (BPS-11) to the position of Senior Clerk (BPS-14) without any reasons and no working papers available.
- 4) That when the DPC was being conducted on 21.05.2022, at that time Mr. Imtiaz Hussain (Appellant) was on Ex-Pakistan Leaves (at Iran).
- 5) That as per concerned Department, Mr. Imtiaz Hussain (Appellant) was deferred from the post of Junior Clerk (BPS-11) to the position of Senior Clerk (BPS-14) on the basis of adverse remarks in his ACR of 2019. Actually the ACR of 2019 of Mr. Imtiaz Hussain (Appellant) was misplaced from the office of the Superintendent of District Judiciary Kurram/District

Courts Kurram, in which an inquiry was also conducted against the said Superintendent and no reasons mentioned in DPC meeting held on 21.05.2022 regarding the adverse remarks of ACR or else. His ACR of 2019 was re-written by his reporting officer after the misplacement of original ACR of 2019 from the office of the said Superintendent.

- 6) That Mr. Imtiaz Hussain (Appellant) also preferred Departmental Appeal with in time before the Competent Authority/concerned Department as he returned from Ex-Pakistan Leaves (Iran), which is still pending before the competent Authority/concerned DPC and up to date no order or else has been passed.
- 7) That Mr. Imtiaz Hussain (Appellant) was also awarded with two (02) "Certificate of Appreciation" and also have two (02) Good ACRs of 2020 and 2021.
- 8) That when the DPC was being conducted on 21.05.2022, the last ACR of 2021 of the official namely Mr. Gul Zaman S/o Abdul Mat Khan appearing at Serial No. 08, his reporting Officer considered him as NOT FIT FOR PROMOTION but despite with such adverse remarks in his ACR of 2021 the DPC promoted him from the post of Junior Clerk (BPS-11) to the position of Senior Clerk (BPS-14) and Mr. Imtiaz Hussain (Appellant) has been deferred by the said DPC without any reasons also having last two (02) Good ACRs of 2020 and 2021 and two (02) "Certificate of Appreciations".

Prayer:

It is therefore, fervently prayed upon the gracious acceptance of the instant Cognovit to kindly accept the Appeal of Mr. Imtiaz Hussain and be promoted him to the position of Senior Clerk (BPS-14) at previous Seniority List i.e. at Serial No. 02 and I having no objection upon the acceptance of his Appeal.

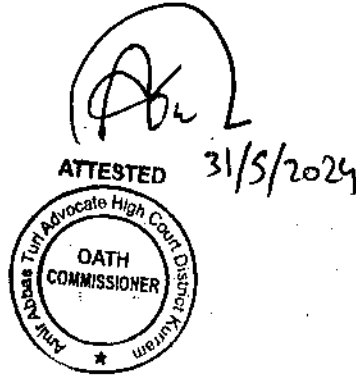
