

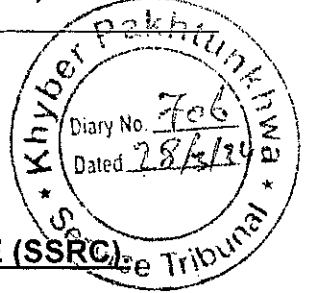



**SUBJECT: MINUTES OF THE MEETING OF STANDING SERVICE RULES
COMMITTEE (SSRC) HELD ON 10.01.2024.**

Dear Sir,

I am directed to refer to your letter No. SOE-III(E&AD)/S-1/KP-ST/SR-M/2024, dated: 08.03.2024, on the subject noted above, and to state that the proposed draft Notification, carrying amendments in the service rules of the Khyber Pakhtunkhwa Service Tribunal, has been examined, especially in light of the minutes of SSRC and existing service rules, and as such this Department has observed the following:

- (i) that the posts of Additional Registrar, Superintendent and Budget and Accounts Officer, reflected at Serial Nos. 2, 3 and 4 of the existing service rules, have been decided to be clubbed at Serial No. 2, as evident from the minutes of SSRC, enclosed with your above quoted letter, however, amendment in the draft Notification is only to the extent of Column No. 5, which needs rectification;
- (ii) that the posts of Additional Registrar, Superintendent and Budget and Accounts Officer, reflected at Serial Nos. 2, 3 and 4 of the existing service rules, after clubbing at Serial No. 2, as per minutes of the SSRC, equally requires necessary deletion of Serial Nos. 3 and 4, being redundant, however, it has been observed that no such deletion has been proposed in the draft Notification, hence, the same also needs rectification;
- (iii) that as a result of clubbing the posts of Additional Registrar, Superintendent and Budget and Accounts Officer, the Office Assistants, Assistant Registrars, Law Drafters and Cashier-cum-Assistants (BPS-16) shall become eligible for promotion to the posts of either Additional Registrar, Superintendent or Budget and Accounts Officer (BPS-17), whereas, it has been observed that the job descriptions of Law Drafter have no relevancy with the job descriptions of Superintendent and Budget and Accounts Officer



(BPS-17) and the same irrelevancy is also found in the post of Cashier-cum-Assistants (BPS-16), which needs reconsideration; and

- (iv) that the Store Keeper (BPS-14), as per existing service rules, is appointed by initial recruitment, having qualification of at least Diploma in Commerce or Business Administration and as such he is promoted to the post of Cashier-cum-Assistant (BPS-16) having at least five years service as such, so with this low qualification, would he be able to hold the post of Additional Registrar or Superintendent or Budget and Accounts Officer or otherwise.

2. Keeping in view the above, the Administrative Department is, therefore, advised that the matter may be placed before the SSRC for re-consideration, accordingly.
