Preliminary Objections:

- i. That the appellant has got no cause of action/locus standi.
- ii. That the instant appeal is badly time barred.
- iii. That the appellant has concealed the material facts from this Honorable Tribunal, hence liable to be dismissed.
- iv. That the appellant has not come to this Honorable Tribunal with clean hands.
- v. That the appellant has filed the instant appeal just to pressurize the respondents.
- vi. That the appellant has filed the instant appeal on malafide motives.
- vii. That the instant appeal is against the prevailing law and rules.
- viii. That the appellant is stopped by his own conduct to file this instant appeal.
- ix. That the present appeal is not maintainable in the present form and also in the present circumstances of the case.
- x. That the appeal is bad for misjoinder and non joinder of necessary parties.

OBJECTION ON FACTS:

- 1. Petains to record hence needs no comments.
- 2. Admitted to the extent that the appellant served in prison department. The appellant does not applied for leave nor he had admitted the leave. The appellant does not follow the Khyber Pakhtunkhwa, Prison Rules 1082 and 1083. There is no rules for verbal/oral leave. (Copy of Rules is attached as Annex-A).

- 3. Correct and admitted. Copy of Show Cause Notice is attached as "Annex-B".
- '4. Incorrect and not admitted. That the appellant does not submitted reply to the show cause notice issued by the competent authority. (Copy of impugned order dated 29-03-2022 is "Annex-C)".
- 5. Correct and admitted. That the appellant filed departmental appeal against the impugned removal order which was rejected by the competent authority. Copy attached as "Annex D".
 - 6. Incorrect and not admitted. That the appellant time and again absent himself from duty and line without the permission of competent authority, he remaind absent from duty and line w.e.f 09-12-2021 to 28-12-2021 and 01-01-2022 to 31-01-2022 (51 days) without the permission of competent authority. Show Cause notice is attached as "Annex-B".

OBJECTION ON GROUNDS:

- A. Incorrect and not admitted. That the appelant was proceeded under Rule-3 of Khyber Pakhtunkhwa, Government Servants (Efficiency and Discipline) Rule, 2011 amended in 2021 for the charges of his misconduct as mentioned in the show cause notice. The competent authority grant him the opportunity of personal hearing on 22-03-2022 but his reply was unsatisfactory. (Copy attached as "Annex-E). The competent authority in exercise of power conferred Rule-14(5) of Khyber Pakhtunkhwa, Government Servents (Efficiency and Discipline) Rule 2011 amended in 2021, having consider the charges, evidence on record and reports submitted by Superintendent Central Prison Haripur, except this instant case, an another report submitted by Superintendent Central Prison Haripur regarding his absent from duty w.e.f 11-02-2022 to 14-02-2022 (04 days) and 18-02-2022 to 29-03-2022 (39 days), non-serious in performance of assigned duties, his previous poor record wherein he remained absent from duty w.e.f 06-03-2021 to 04-04-2021 (29 days) and w.e.f 26-04-202 to 16-06-2021 (50 days), the competent authority award him major punishment of "Removal from Service". Removal order attached /impugned order is attached. Total absence period 173 days in 2 year service.
- B. Incorrect and not admitted. Show cause notice had been served upon the appellant for his misconduct and the principle of Audi Altrum partum is applied and the opportunity of personal hearing is provided to the appellant but his reply was unsatisfactory. Copy of personal hearing is attached as "Annex-E".
- C. Incorrect and not admitted.
- D. Incorrect and not admitted. That the appellant time and again absent himself from duty without the permission of competent authority, despite the seriousness of his job nature. The answers has been given in "para-a" above.

Incorrect and not admitted. That the appellant was proceeded under Rule-3 of Khyber Pakhtunkhwa, Government Servants (Efficiency and Discipline) Rules, 2011 amended in 2021 for the charges of his misconduct. The competent authority awarded major punishment "Removal from Service" to the appellant after completing all the codal formalities.

No.SO(P&R)HD/3-3/2018.-In exercise of the powers conferred by section 59 of the Prisons Act, 1894 (IX of 1894) and in supersession of rules issued in this behalf, the Government of the Khyber Pakhtunkhwa is pleased to make the following rules, namely:

THE KHYBER PAKHTUNKHWA PRISONS RULES, 2018.

Chapter-1 General Provision

- 1. Short title and commencement.---(1) These rules may be called the Khyber Pakhtunkhwa Prisons Rules, 2018.
 - (2) It shall come into force at once.
- 2. **Definitions.---**(1) In these rules, unless otherwise prescribed the following expressions shall have the meaning hereby respectively assigned to them, that is to say-
 - (a) "Act" means the Prisons Act, 1894 (Act IX of 1894);
 - (b) "Additional Inspector General" means Additional Inspector General of Prisons appointed by Government under these rules;
 - (c) "Assistant Superintendent" means Assistant Superintendent of the Prisons and includes Senior Assistant Superintendent or Senior Lady Assistant Superintendent appointed by Government;
 - (d) "Central Prison" means a Central Prison declared as such by Government;
 - (e) "Chief Warder" means Chief Warder either male or female, as the case may be, in respective ward in a Prison:
 - (f) "Code" means the Code of Criminal Procedure, 1898 (V of 1898);

- (2) The Deputy Superintendent shall not, without the sanction of the Superintendent, grant leave of absence to any subordinate officer, or permit any such officer to remain absent, for any period exceeding four hours at any one time.
- (3) Whenever any leave is granted by the Deputy Superintendent to any subordinate officer he shall, at the time the leave is granted, record the fact, and the period of leave in his report book.
- (4) Every subordinate officer shall immediately on return from leave report the fact to the Deputy Superintendent, who shall forthwith record his arrival in his report book.
- (5) The Deputy Superintendent shall similarly record in his report book, all leave granted by the Superintendent and all reports made of return from leave.
- (6) Fifteen (15) days recreation leave shall be granted to every employee of Department once in a calendar year on rotation basis.
- 1083. Absence caused by illness or other unavoidable cause.—Whenever any subordinate officer is at any time prevented by sudden illness or other unavoidable cause, from attending the prison or performing his duties he shall forth-with give notice to the Superintendent along with his reasons for absence. The Superintendent shall then make suitable arrangements for the due performance of his duties.




