





**SUBJECT: IMPLEMENTATION REPORT IN THE SUBJECT EXECUTION PETITION ON BEHALF OF OFFICIAL RESPONDENTS**

1. That this Honourable Tribunal passed Judgment dated 04/10/2023 in Service Appeal No.938/2020 (**copy enclosed**).The Honourable Service Tribunal remanded the matter to respondent department for conducting inquiry as well as also Reinstated the appellánt for the purpose of inquiry.
2. In compliance of this Honourable Court order, the appellant was Reinstated for the purpose of inquiry vide Superintendent District Jail Lakki Marwat office order dated 19/10/2023 (**copy enclosed**).
3. According to the direction of the Honourable Service Tribunal, a Departmental Committee was constituted on 23/10/2023 (**order enclosed**) in order to comply with this Honourable Tribunal Judgment ibid.
4. That on 27/02/2024 the Superintendent Central Prison Bannu being an inquiry officer has submitted their findings/report to the Inspector General of Prisons Khyber Pakhtunkhwa Peshawar for further course of action (**copy enclosed**).
5. It is pertinent to mention here that the inquiry committee declared the appointment order of the appellant is fake and bogus and recommended those officers/officials at fault involved in the issuance of fake and bogus appointment order for departmental proceedings against them.
6. That on 08/03/2024, the Inspector General of Prisons Khyber Pakhtunkhwa Peshawar forwarded the inquiry report to the office of Superintendent District Jail Lakki Marwat with the direction to register FIR against the appellant as well as the officers/officials at fault to the quarter concerned. Moreover, departmental proceedings are also under process against the officers/officials at fault.
7. That on 14/03/2024 the Superintendent District Jail Lakki Marwat being the competent authority as well as also respondent No.03 in the instant execution petition issued his office order No. 491 dated 14/03/2024 (**copy enclosed**) in which he withdrawn his earlier Reinstatement order of the appellant vide his office order No.1895-98 dated 19/10/2023 in the light of inquiry report/recommendations of the inquiry committee.

**PRAYER:-**

It is therefore most humbly prayed that on acceptance of this instant Implementation Report on behalf of the official respondent No.01 to 03, the execution petition filed by the appellant may please kindly be dismissed being devoid of merit and law.



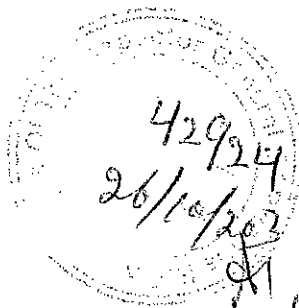

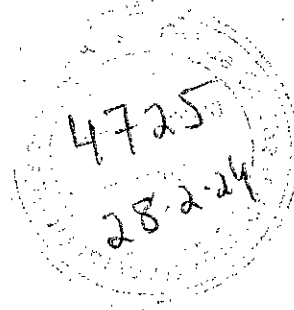

**FACT FINDING INQUIRY INTO THE APPOINTMENT/RESIGNATION OF  
CLASS-IV (COOK) QABIL JAN.**

An inquiry committee comprised of Mr. Tahir Shahbaz Khan Wazir Superintendent Central Prison Bannu (Convener) & Mr. Sulaiman Senior Instructor/Law Officer of Prisons Inspectorate (Member) constituted by the Worthy Inspector General of Prisons Khyber Pakhtunkhwa Peshawar office order No.38978 dated 23.10.2023 to conduct fact-findings inquiry, which was scheduled on 14.02.2024 in the office of Superintendent Central Prison Bannu vide Superintendent Central Prison Bannu office letter Endorsement No.808-11 dated 09/02/2024. Mr. Atiqullah Junior Clerk representative of District Jail Lakki Marwat put appearance and attended the proceeding along-with record. However, despite clear direction to Mr. Qabil Jan Ex-Cook vide Superintendent CP Bannu office letter Endst No.901-02 dated 15/02/2024 to appear before the inquiry committee on 19/02/2024 at 10:00 AM for the purpose of inquiry proceeding but he remained absent and did not bother to appear before the inquiry committee. However, Mr. Naveed Iqbal Pay In-charge representative of District Jail Lakki Marwat attended the office of Superintendent CP Bannu on 19.02.2024.

**GROUND:**

- i. To verify signatures and handwriting of the cook concerned from handwriting expert as well as Forensic Science Laboratory (FSL).
- ii. To inquire the genuineness of resignation tendered by the cook concerned.
- iii. To submit clear findings and recommendations to proceed further.
- iv. First time Source Form (Source-One) submitted to Local Audit office, if not available in officer record then which may be obtained from Local Audit office.
- v. Mention the specific names of the officers/officials they were posted at District Jail Lakki Marwat at the time of appointment/withdrawn of salary of Ex-cook (w.e.f 01-01-2018 to 08/2019).
- vi. To ascertain from the record of your Jail as to whether the Ex-cook concerned regularly performed his duties during the period from 01/01/2018 to 08/2019 or otherwise.

**PROCEEDINGS:**

According to the directions of Worthy Inspector General of Prisons Khyber Pakhtunkhwa Peshawar as contained vide its office letter referred to above as well as the direction given in Judgment dated 04/10/2023 of the Hon'ble Khyber Pakhtunkhwa Service Tribunal Peshawar, the inquiry committee approached the Director Forensic Science Laboratory Peshawar vide Superintendent Central Prison Bannu letter No. 6384/WE dated 06.11.2023 **(Copy attached as Annex-A)** with enclosures/provision of Resignation letter, Specimens Urdu signature, Specimen Urdu Hand Writing, Service Book & Statement, possessing routine Urdu signatures/Urdu hand writing of Ex-cook Qabil Jan for verification of signatures & Hand Writing & Genuineness of resignation tendered by the cook concerned namely Qabil Jan from Hand Writing Expert as well Forensic Science Laboratory (FSL). However, in response the Forensic Laboratory Department Peshawar requested the Superintendent Central Prison Bannu being convener of the inquiry committee to provide


specimen of Urdu Hand Writings on one sheet and 10/15 more fresh specimen of Urdu Hand Writings in three different modes i.e. slow, normal and fast, each on separate sheets with full dictation from the questioned body hand writings on the disputed Resignation Letter along-with sufficient more routine Urdu signatures/Urdu Hand writings, on Bank used Cheques, Bank SS Card, Application, letters, examination papers of some other documents vide his letter No. 90/FSL dated 16.11.2023. **(Copy attached as Annex-B)**. The convener of the inquiry committee called the Ex-cook (Qabil Jan) to write/provide the required documents as requested by the Director Forensic Science Laboratory Peshawar within 02 days positively in order to ascertain the veracity of the alleged/disputed signature whether genuine or fake vide Superintendent Central Prison Bannu office letter No.6716 dated 20/11/2023 **(Copy attached as Annex-C)**. However, the Ex-cook refused to write afresh resignation letter as a sample for Forensic Science Laboratory **(copy of the refusal is attached as Annex-D)**. Mr. Latif Khan now Office Assistant presently attached with Internment Centre Lakki Marwat while attached at that time as a Senior Clerk to DJ Lakki Marwat also attended the Inquiry Committee proceeding on due date and time and the committee recorded his statement and also cross examined him **(Copy attached as Annex-E)**. However, Mr. Qabil Jan Ex-Cook remained absent and did not attend the Inquiry Committee on scheduled dates and times for questioning and answering from him vide this office letters No.808-11 dated 09.02.2024 and Urdu letter No.900 dated 15.02.2024 **(copies attached as Annex-F&G)**. He was also informed through his WhatsApp and mobile call. However, he remained absent again.

#### **FINDINGS:**

**The Inquiry Committee reached to the following conclusions/findings: -**

1. When checked record of District Jail Lakki Marwat, it was observed that the appointment order of the concerned cook was totally bogus/fake as there is no entry found in the dispatch register nor any minutes of the appointing committee found/provided by the representative of District Jail Lakki Marwat. Furthermore, signature of appointing authority in service book/office order were found different and when the committee approached the appointing authority i.e. Mr. Ghulam Rabbani, the then Superintendent of District Jail Lakki Marwat (appointing authority), for verification/genuineness of his signatures on appointment order and in Service Book vide letter No. 7430/WE dated 20.12.2023, **(Copy attached as Annex-H)**, in response he replied that signatures on appointment order and in Service Book of Cook Qabil Jan are fake and not signed by him and the then Superintendent Mr. Ghulam Rabbani (now retired) clearly stated in his statement that the said cook was not appointed by him **(Copy attached as Annex-I)**
2. According to statement/verbal questions from representative of District Jail Lakki Marwat regarding Record of Arrival Report, Employment Exchange Card, Agreement deed, and Minutes of meeting, in reply he replied that all the said documents are not available in jail record.

- Clerk also stated that the District Accounts officer Lakki Marwat was approached vide Superintendent District Jail Lakki Marwat letter Endst: No.253-54 dated 12/02/2024 & No.292-93 dated 16.02.2024 (**Copy attached as Annex-J&K**) for provision of First-time source i.e., Source-1, which is attached as (**Annex-L**). He has also stated before the Inquiry Committee that other record related to appointment of Ex-cook is not available. (**Statement of Naveed Iqbal is attached as Annex-M**), as well as stated in his second statement on 19.02.2024 (**copy attached as Annex-N**) that the said Ex-Cook was neither reported for duty at District Jail Lakki Marwat, nor any attendance regarding his duty is found in attendance register, nor any entry found in 16 number register to show his presence in jail premises.
3. When the committee approached Mr. Asif Ali Superintendent District Jail Lakki Marwat regarding verification/genuineness of his signature on the order of resignation of Qabil Jan vide letter No. 7359/WE dated 18.12.2023 (**Copy attached as Annex-O**). Accordingly Mr. Asif Ali Shah Ex-Deputy Superintendent Jail who served that Jail from 26/01/2018 to 08/2019, replied that signature on resignation order is genuine (**Copy attached as Annex-P**).
  4. Qabil Jan Ex-Cook also refused to write afresh resignation letter as a sample required to Forensic Science Laboratory (FSL) for further investigation as directed by the Honorable Service Tribunal in Judgment (**Copy attached as Annex-D**).
  5. When a question was asked from Mr. Qabil Jan (Ex-cook) in the previous inquiry that who issued/delivered order of appointment to you, he replied that Mr. Latif Senior Clerk while attached to District Jail Lakki Marwat delivered order of appointment to him (**Copy attached as Annex-Q**).
  6. Mr. Qabil Jan remained absent and not appeared before the inquiry committee on scheduled date i-e 19/02/2024 and time at 10:00 AM with reference to the Superintendent CP Bannu office letter Endst: No.808-11 dated 09.02.2024 & Endst: No.901-02 dated 15/02/2024 (**Annex-F & G**) for inquiry proceedings and his this act of negligence shows that he is guilty.
  7. Mr. Muhammad Latif Assistant was responsible, and it was his official duty being Senior Clerk to reconcile reconciliation statement with Expenditure statement of local District Accounts office, but he shown ignorance/failed to do so, and he put his duty on the shoulder of another as stated in his statement (**statement is attached as Annex-R**).
  8. As provided by Superintendent District Jail Lakki Marwat copies of Service Book pages, Appointment order and letter of recovery addressed to Mr. Qabil Jan are also attached for ready reference as (**Annex-S**).



**RECOMMENDATION: -**

Keeping in view of the above Fact Findings, the following recommendations are hereby recommended that: -

1. Mr. Latif Khan the then Clerk are hereby recommended for **Major Penalty** for issuance bogus Appointment order to Mr. Qabil Jan Ex-cook according to statement of Mr. Qabil Jan Ex-cook as well as the then Superintendent District Jail Lakki Marwat Mr. Ghulam Rabbani (appointing authority) who also stated in his written statement that he did not appointed Mr. Qabil Jan as a Cook in his tenure.
2. Amounting to Rs. 546080/- may also be recovered from Mr. Qabil Jan through District Police officer Lakki Marwat as he was appointed bogusly and drew salaries illegally from the Government exchequer.
3. Administration of District Jail Lakki Marwat may also be directed to keep his record maintain to avoid later-on complications.



**OFFICE ORDER**

In the light of Judgement of Khyber Pakhtunkhwa Service Tribunal Peshawar Judgment dated 04-10-2023 in Service Appeal No.938/2020, an Inquiry Committee was constituted by the order of Inspector General of Prisons Khyber Pakhtunkhwa Peshawar vide order No.38978 dated 23-10-2023 in order to verify the signature and genuineness of the resignation of Mr. Qabil Jan (Ex Cook). The committee pointed out during course of inquiry proceeding that appointment of the Qabil Jan (Ex-Cook) is fake and bogus and found no official record pertaining to his appointment (inquiry report annexed). Moreover, the appellant also refused to give specimen signatures to the inquiry committee for investigation by the Forensic Science Laboratory.

In view of the above, the undersigned being the competent authority agreed with the report/recommendation of inquiry committee received vide Inspector General of Prisons Khyber Pakhtunkhwa Peshawar letter No.13079/we dated 08-03-2024, that the appellant (Mr. Qabil Jan) was not an employee of Prison Department at all. Therefore, no question arises about his retaining into service, hence his Reinstatement Order issued vide this office order No.1895-98 dated 19/10/2023 is hereby withdrawn. Besides, request for lodging of FIR against Mr. Qabil Jan (Ex Cook) as well as against officers/officials at fault have been made to the quarter concerned. Moreover, departmental proceedings are also under process against the officers/officials at fault.

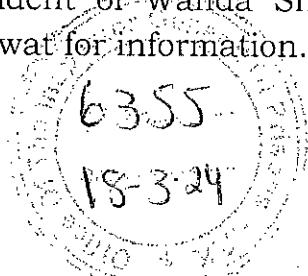


