PRELIMINARY OBJECTIONS

- 1 **That** the appellant has got no cause of action/locus standi to file instant appeal before this Honorable Tribunal.
- 2 **That** the appellant is not an aggrieved person within the meaning of Section-4 Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article-212 of the constitution of Islamic Republic of Pakistan 1973.
- 3 **That** the appellant has concealed material facts from the ambit of this Honorable Tribunal in the titled appeal.
- 4 **That** the appellant has not come to this Honorable Tribunal with clean hands.
- 5 **That** the appeal in hand is based on mala fide intentions for gaining illegal service benefits from the Department for the grant of promotion to the post of STT in BS-16 TC w.e.f 24-09-2020 instead of 01-12-2022 in violation of the rules & Policy.
- 6 **That** the appeal in hand is barred by law and limitation Act, 1908.
- 7 **That** the appeal in hand is bad for mis-joinder and non-joinder of the necessary parties to the titled appeal.
- 8 **That** the appeal is not maintainable & even incompetent in the eyes of Law, Rules & Policy in vogue.
- 9 **That** the Notification dated 01-12-2022 of the Respondent Department is legally competent & liable to be maintained of being the result of due process of Law, Rules & Policy in vogue.
- 10 **That** the appellant is not entitled for the grant of promotion w.e.f 24-09-2020 & has correctly promoted to the post of STT in BPS-16 vide Notification dated 01-12-2022 as per Law, Rules & Policy.

ON FACTS

- 1) That Para-1 pertains to the service record of the appellant to the extent of his appointment as IT Lab In charge purely on contract/adhoc basis vide Notification dated 14-10-2014 in the Respondent Department ***attached as Annex-A.***
- 2) That Para-2 is correct to the extent of notifying the service structure & Rules dated 24-04-2017, wherein the post of IT Lab In charge was re-designated as CT IT in BPS-12 with the prescribed qualification of FA, FSc at least in 2nd division with the professional qualification of CT (IT) or ADE from dully recognized institution/university with prescribed age limit of 18 to 35 on the basis of initial recruitment in the Respondent Department & pursuant to the afore said Service Rules dated 24-04-2017, the services of the appellant were regularized vide Notification dated 16-03-2019 ***Copy of service rules attached as Annex-B.***
- 3) That Para-3 is correct that vide Notification dated 28-05-2019, the Respondent Department has promoted some CT IT in BPS-12 to SST IT in BS-16 in view of the service Rule dated 24-04-2017, wherein, the appellant was not promoted to the post of SS IT in 1st DPC as well as in the DPC held on 29-09-2020 due to his ineligibility in terms of the CT/ADE Degree mandatory for promotion to the said post in terms of the afore said service rules & ***copy of the Notification dated 28-05-2019 attached as Annex-C.***
- 4) That Para-4 is correct to the extent of the said letter of the Respondent Department regarding seeking of guidance in the matter of CT IT promotion to the post of SST IT.
- 5) That Para-5 is correct in view of the minutes of the DPC meeting dated 11-06-2021, wherein, the promotion case of the appellant from CT IT to SST IT was rejected on the grounds of lake of the prescribed qualification of CT/ADE from the recognized institutions from the country, furthermore, the promotion orders of those CT IT promoted to the post of SST IT who have no qualification of CT/ADE were re-called by the Department, however, the same orders were restored vide Notification dated 03-08-2021 by the Department ***attached as Annex-D & E.***
- 6) That Para-6 is incorrect as no Departmental appeal has been filed by the appellant, whereas rest of the para pertains to the record of this Honorable Tribunal in pending S/A No. 7828/2021 of the appellant
- 7) That Para-7 is correct that vide Notification dated 1-12-2022 the appellant was promoted to the post of SST IT in BPS-16 under the relevant provision of APT Rules, 1989, therefore, the claim of the

appellant for his promotion to the said post w.e.f 24-09-2020 instead of 01-12-2022 & subsequent Departmental appeal are liable to be rejected in the above said terms **& Copy of the Notification dated 01-12-2022 is Annex-F**, hence the appeal in hand is liable to be dismissed on the following grounds inter alia: -


ON GROUNDS

- A. **Incorrect & not admitted.** The appellant is not entitled for the grant of promotion against the SST IT in BPS-16 w.e.f 24-09-2020 & has correctly been promoted w.e.f 01-12-2022 by the Department in view of his service record.
- B. **Incorrect & not admitted.** Strongly denied. The appellant has been treated as per Law & Rules by the Respondent Department in the titled appeal, wherein, he could not made out his case for promotion to the post of SST IT in BPS-16 w.e.f 24-09-2020 under the rules.
- C. **Incorrect & not admitted,** the act of the Department with regard to the Notification dated 01-12-2022 is in accordance with the provision of Articles-4 & 25 of the constitution of 1973.
- D. **Incorrect & not admitted,** the act of the Respondents cannot be declared against the law on any ground whatsoever as the Notification dated 01-12-2022 has been issued in terms of Article, 3 of the constitution of 1973 by the Department.
- E. **Incorrect & not admitted,** the act of the Respondents cannot be declared against the law on any ground whatsoever as the Notification dated 01-12-2022 has been issued in terms of Article,-25 of the constitution of 1973 by the Department.
- F. **Incorrect & not admitted,** the appellant could not made out his case for promotion against the SST IT w.e.f 24-09-2020 & rightly promoted to the said post on dated 01-2-2022 by the Department.
- G. **Incorrect & not admitted,** the plea of the appellant is in violation of the relevant rules of business in the Department, hence, liable to be rejected.
- H. **Incorrect & not admitted,** the appellant is not an aggrieved person within the meaning of Section-4 Khyber Pakhtunkhwa Service Tribunal Act 1974 read with Article-212 of the constitution of Islamic Republic of Pakistan 1973, however, the Respondent Department is also seek leave of this honorable Tribunal to submit additional-record, grounds & case law at the time of arguments.

PRAYER.

In view of the above made submissions, it is requested that this Tribunal may very graciously be pleased to dismiss the titled appeal in favor of the Respondent Department in the interest of justice.
