PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action/locus standi to file in the instant case before this Honorable Bench.
- 2 That the appellant is not an aggrieved person within the meaning of Section-4 of Khyber Pakhtunkhwa Service Tribunal Act-1974 read with Article 212 of the constitution of Islamic Republic of Pakistan, 1973.
- 3 That the Appellant has concealed material facts & record from the ambit of this Honorable Tribunal in the titled case.
- 4 That the Appellant has not come to this Honorable Tribunal with clean hands.
- 5 That the matter in hand is based on mala fide intentions for gaining illegal service benefits of selection grade from the Department against the principal in BS-18 post in violation of Rules & Policy.
- 6 **That** the titled case is not only barred by law and limitation Act 1908 but is also has been filed in violation of provision of CPC 1908 regarding the Res judicata in view of the Judgment dated 26-01-2009 of this Honorable Tribunal in S/A No. 1087/2007 under the above said titled appeal.
- 7 **That** the cited Judgment dated 26-01-2009 has already been implemented by the Department vide Notification dated 31-10-2022, wherein, the issue of selection grade has been declined by the Department in view of afore said Judgment.

- **8 That** the appellant has already availed selection grade in BPS-17 vide Notification dated 13-05-2002 against the SET in BPS-17 personal post in the Department w.e.f 12-12-1996.
- **9 That** the titled case is bad for mis-joinder & non-joinder of the necessary parties to the case.
- **10That** the appellant is estopped by her own conduct to file the instant case against the Department.
- 11 **That** the matter is not maintainable in its present circumstances and even facts of the case rather the appellant is a habitual litigant against the Department for no good cause of action.
- **12That** the appellant is not entitled for the grant of Selection grade as she has already availed this benefits w.e.f 12-12-1996 vide Notification dated 13-05-2002 of the Respondent Department.

ON FACTS.

- 1. That Para-1 pertains to the service record of the appellant regarding his appointment as an untrained SET Science on fixed pay vide Notification dated 09-04-1990 & was then appointed on regular basis as SET on dated 04-05-1991 upon her acquiring the B.Ed Degree on 08-11-1990.
- 2. That Para-2 is correct to the extent of the award of graded pay w.e.f 08-11-1990 in compliance of the Judgment dated 16-07-1996 of this Honorable Tribunal in S/A No. 99/1996 under the above said case titled.
- 3. That para-3 is also correct to the extent of grant of seniority w.e.f 08-11-1990 in view of the Judgment dated 26-01-2009 of this Honorable Tribunal in S/A No. 1087/2007 case titled Shahnaz Begum VS Govt: vide Notification No. 4935-40 dated 31-10-2022, wherein, the issue for the grant of selection grade has been declined by the Department in view of the Notification dated 13-05-2002 of the Respondent Department, whereby, the same has already been awarded to the appellant w.e.f 12-12-1996, hence, the claim of the appellant regarding the grant of selection grade w.e.f 01-10-1997 in the titled appeal is in violation of the provision of Res Judicata of CPC 1908 (Copies of the Judgment dated 26-01-2009 & Notification dated 13-05-2002 are Annex-A & B).
- 4. That Para-4 is mis-leading on the grounds that as per Para-8 of the Judgment dated 26-01-2009 in S/A No. 1087/2007 Shahnaz Begem VS Govt: this Honorable tribunal has observed that "we therefore accept the present appeal & direct the official respondents to fix the seniority of the appellant as it was on 08-11-1990 with reference to the persons who qualified & were available in service on that date, without reference to the cases of the person who belong to the batch/year of

passing of B.Ed examination like the appellant but were not in service on 08-11-1990". (Copy of the Judgment is already attached as Annex-A)

- 5. That Para-5 is incorrect that the issue for the grant of selection grade has been declined by the Department in view of the Notification dated 13-05-2002 of the Respondent Department, because the same selection grade has already been awarded to the appellant w.e.f 12-12-1996, hence, the claim of the appellant regarding the grant of selection grade w.e.f 01-10-1997 in the titled appeal is in violation of the provision of Res Judicata of CPC 1908. (Copy of the Notification is already attached as Annex-B)
- **6. That** Para-6 is incorrect as the appellant is not an aggrieved person within the meaning of Section-4 of Khyber Pakhtunkhwa Service Tribunal Act-1974 read with Article 212 of the constitution of Islamic Republic of Pakistan 1973 furthermore, the appellant has got no cause of action to file instant appeal nor his filed any Departmental appeal for the grant of selection grade to the Department. therefore, the appeal in hand is liable to be dismissed on the following grounds inter alia: -

GROUNDS: -

- A. <u>Incorrect & not admitted</u>. The stand of the appellant is illegal and liable to be rejected in view of the above cited Notification; hence, the act of the Respondent Department with regard to the non-grant of double selection grade to the appellant is legally competent & liable to be maintained.
- **B.** <u>Incorrect & not admitted</u>. The plea of the appellant is against the facts & relevant provision/rules regarding the award of selection grade, hence, deserves rejection in favor of the Department.
- **C.** <u>Incorrect & not admitted.</u> The statement of the appellant is misconceiving and even against the facts as agitated in the foregoing paras of the reply on behalf of the Respondents.
- **D.** <u>Incorrect & not admitted.</u> The stance of the appellant is illegal & liable to be rejected in favor of the Department in view of the above made submissions by the replying Respondents in the titled appeal before this Honorable Tribunal.
- E. <u>Incorrect & not admitted</u>. The appellant has been treated as per law, rules & policy in vogue by the Department as the appellant has alredy availed the benefit of selection grade in BPS-17 w.e.f 12-12-1996 as evident from the Notification dated 13-05-2002. Therefore, the claim of the appellant is liable to be rejected with the prayer that the Respondents seek permission to raise additional grounds, record & case law at the time of arguments.

Therefore, in view of the above made submissions, the appeal in hand may kindly be rejected in favor of the Department in the interest of justice.

- JUDGMENT

JUSTICE (R) SALIM KHAN, CHAIRMAN: Contentions of the appellant are that she was appointed as SET in BPS-15 on fixed pay vide order dated 9.4.1990, her result of B.Ed course was declared on 8.11.1990, her name was enlisted on 25.11.1990 as B.Ed qualified teacher. She was appointed on merit on 4.5.1991 but on fixed pay. She was allowed BPS-16 on 23.5.1995, and she used to receive graded pay vide order dated 23.2.1993 w.e.f. 24.1.1991. Vide Service Appeal No. 99 of 1996, this Tribunal decided the case in her favour on 16.7.1996 and the August Supreme Court of Pakistan maintained the judgment of this Tribunal in C.P. No.228-P. of 1997 vide judgment/order dated 6.2.1998.

2. The appellant further contended that final seniority list of SETs(Science) Female, as it stood on 31.12.2006, was circulated on 25.1.2007. The name of the appellant was mentioned in that list at S.No. 758 instead of S.No. 390 above the name of Mst.Taslim-un-Nissa (respondent No.3). The appellant submitted departmental appeal on 19.7.2007 which was forwarded vide letters dated

- 21.7.2007 and 31.7.2007. But the same had not been finally decided till the filing of this appeal on 07.11.2007.
- 3. The official respondents contested the appeal and contended that the appellant was initially appointed purely on temporary and ad-hoc basis as stop-gap arrangement on fixed pay, and the appellant accepted the terms and conditions without any objection. It was further contended that the appellant was appointed on fixed pay, along with others, after acquiring the required qualification of B.Ed, and the appellant did not object to the terms and conditions of such appointment. They were of the view that the appellant was regularized with other candidates on her own batch-wise/year-wise turn which she accepted accordingly without any hesitation/resistance. They further contended that the judgment of the August Supreme Court of Pakistan was regarding the grant of graded pay from the date of acquiring the requisite qualification.
 - 4. We heard the arguments and perused the record.
- 5. The basic issues of temporary and ad-hoc appointment and graded pay have already been decided vide judgment in Service Appeal No. 99/1996 decided on 16.7.1996. It was held in that case that the contention that graded pay had been granted to her on her turn on merit did not hold ground because, according to August Supreme Court of Pakistan, if a person working on a post, was fully qualified, he/she was perfectly entitled to get the pay and other monetary benefits attached to that post. It was further held that the appellant was fully qualified, that she was B.Sc, B.Ed and had also passed M.Ed, so her educational qualifications were much more than the required qualification. She had got a spotless service record and had gained sufficient teaching experience at her credit. There was no hurdle for the grant of graded pay to the appellant. It was declared that she was perfectly entitled to grant of graded pay from the date of acquiring the requisite qualification.
- 6. That judgment, in the light of the judgment in C.P. No. 228-P of 1997, granted by the August Supreme Court of Pakistan, has attained finality. The Civil Petition against that judgment of this Tribunal was dismissed as time-barred because no sufficient cause had been shown for condoning the delay. In the light of the above, it has to be accepted that the services of the appellant were declared regular with effect from the date of her acquiring the higher qualification on 8.11.1990.
 - 7. The respondents contended that the appellant was regularized in

accordance with her batch-wise/year-wise merit. The appellant was entitled to the grant of seniority with effect from 8.11.1990 which is the date of her acquiring the higher qualification. The respondents do not have the right to keep her regularization pending till the appointment of other persons of the same batch. The appellant is entitled to seniority among the persons who were available in service on 8.11.1990. Her seniority cannot be delayed for the purposes of its fixation with reference to the persons who were not then recruited and were not available in service on 8.11.1990.

8. We, therefore, accept the present appeal, and direct the official respondents to fix the seniority of the appellant as it was on 8.11.1990 with reference to the persons who were qualified and were available in service on that date, without reference to the cases of the persons who belonged to the batch/year of passing of B.Ed examination like the appellant but were not in service on 8.11.1990. We leave the parties to bear their own costs.
