Islamabad the 15<sup>th</sup> December, 2023

No.F.2(1)/2023-Cord-Vol-IX.- In pursuance of Articles 218(3) & 220 of the Constitution of Islamic Republic of Pakistan, Section 5 and Section 230 (2) (f) of the Elections Act, 2017, the Election Commission of Pakistan hereby directs that:

- i. No Government, autonomous / semi-autonomous organization or any authority in the Federation and the Provinces shall post or transfer any officer / official, till the publication of the names of the Returned candidates in the official Gazette. In case of any exigency proposals of postings / transfers with cogent reasons, if in public interest, shall be sent to this Election Commission for consideration.
- ii. No Government Officer / Official shall be granted leaves till culmination of Election process, except maternity leaves or medical leave with the authentication of medical officer. During upcoming winter vacations, the Officers / Officials of Education department shall not leave their stations of posting and shall remain available at their respective work place to attend the training planned for polling personnel.

Subject: **POSTING/TRANSFER**


Consequent upon promotion of BS-19 officer to the post of BS-20 and BS-18 officers to the post of BS-19 of Agriculture Research wing of Agriculture Department (Annex-I & II), Agriculture Department submitted posting/transfer/adjustment proposals for approval of competent authority through Summary for Chief Minister, Khyber Pakhtunkhwa. The Hon'ble Chief Minister, Khyber Pakhtunkhwa has approved the proposals of Agriculture Department (Annex-III & IV).

02. However, Establishment Department vide letter dated 15.12.2023 (Annex-V) has forwarded Notification of Election Commission of Pakistan dated 15.12.2023 wherein, it has directed that "No government, autonomous/semi-autonomous organization or any authority in the Federation and the Provinces shall post or transfer any officer/official, till the publication of the names of the Returned candidates in the official Gazette. In case of any exigency proposals of postings/transfers with cogent reasons, if in public interest, shall be sent to this Election Commission for consideration" (Annex-VI).

03. Election Commission of Pakistan vide letter dated 25.07.2023 earlier conveyed that "no case should be sent directly by the departments to the commission rather should be sent through Establishment Department or S&GAD department" (Annex-VII).

04. Chief Secretary, Khyber Pakhtunkhwa may like to allow for obtaining/issuance of No Objection Certificate from Election Commission of Pakistan through Establishment Department in order to notify the already approved proposals at (Annex-III & IV ibid).





07. Note for Chief Secretary, Khyber Pakhtunkhwa moved by Agriculture Department regarding posting/transfer of BS-18 and BS-19 officers of Agriculture (Research) wing of Agriculture Department has been examined.

08. Consequent upon promotion of ten (10) officers of BS-18 to the post of BS-19 in Agriculture (Research) wing of Agriculture Department; the Administrative Department vide Para-02 of the Note has recommended posting / transfer in respect of the promoted officers.

09. Moreover, vide Para-03 of the instant Note posting / transfer of twelve (12) other officers have also been recommended. It is however, observed that the officers at Sr. No. 11, 13, 14, 17 & 19 of the proposal have not completed normal tenure at their current place of posting. Furthermore, since the instant case contains posting / transfer proposal of BS-19 officers, the Administrative Department was required to submit Summary for Chief Minister instead of Note for Chief Secretary. However, to avoid delay, the instant Note may be deemed as Summary for Chief Minister, Khyber Pakhtunkhwa.

10. Chief Minister, Khyber Pakhtunkhwa being Competent Authority in terms of Rule-17 read with Schedule-III of the Khyber Pakhtunkhwa Government Rules of Business, 1985 (Annex-VI) may like to approve proposal of the Administrative Department contained in Para-02 & 03 read with Para-09 ante.
