



After the detail scrutiny of the case it is submitted that the judgment dated: 10.07.2023 in Service Appeal No. 1571/2022 as well as Order Sheet dated: 21.12.2023 has been implemented in true letter and spirit by issuing the 2 Pension Rolls dated: 07.12.2022 with arrear of pension amounting to Rs. (9,01,963+2,64,439) total 11,66,402/- (Annex-A) for the period w.e.f: 15.01.2021 to 28.02.2022 and Pension Roll dated: 08.01.202 with arrears of pay and allowances in shape of arrear of Pension Amounting to Rs. 8,42,756/- for the above mentioned period(Annex-B) and the grievances of the appellant have been redressed.

It is pertinent to mention here that the amount of Rs. 11,66,402/- already paid to the appellant has been adjusted in term of arrears of pension as (Annex-A). That in the same period double benefit/payment cannot be granted under the rules.

Keeping in view the above mentioned facts it is therefore, humbly prayed that the amount of Rs. 17,44,719/-has been paid/adjusted to the appellant and nothing is outstanding on the part of respondent No. 3. Hence, the implementation Petition against respondent No. 3 may kindly be set aside and the salary of Accountant General KP may be released.
