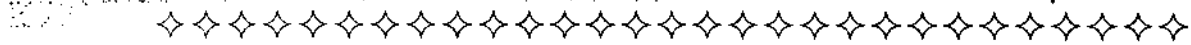

instant appeal their place of posting are unknown to the petitioner, for the reason, they are not arrayed in the panel of respondents. **Copy of list is attached.**


- 3. That the above noted respondents are necessary and proper party, hence need to be impleaded in the panel of respondents in the instant appeal.

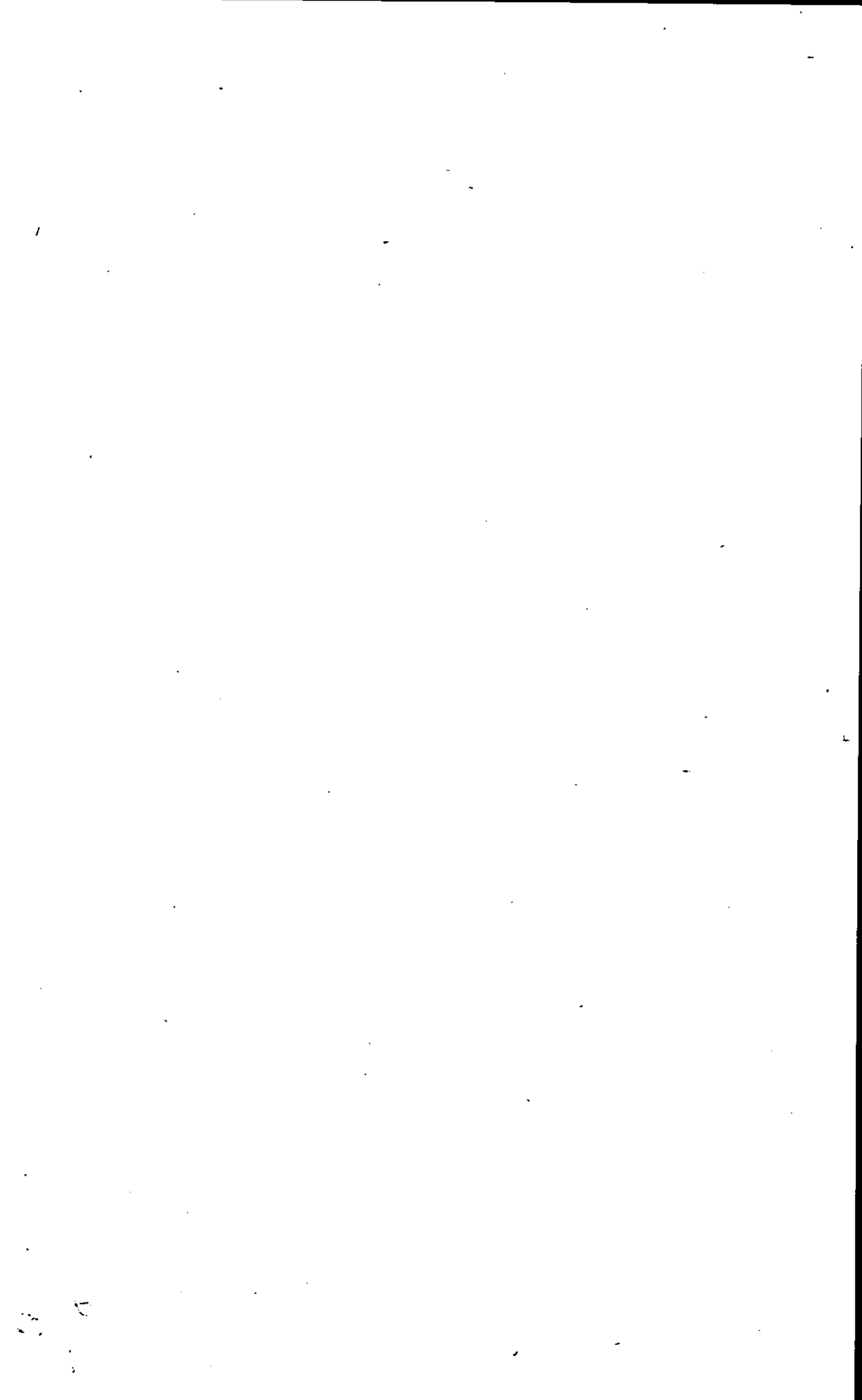
