Upon the directions of the Worthy Accountant General, the AG Inspection Team conducted a visit to the District Accounts Office Bajaur from September 8, 2020, to September 16, 2020. During the inspection, the AG Inspection Team discovered discrepancies in the records spanning over 8 years at this office. Specifically, it was found that 16 individuals had been fraudulently appointed as employees in the District Health Office Bajaur(Annexure A). Among these individuals is Mst Bushra Pervez, who was entered into the SAP system in 2015, despite her actual date of entry into government service being in 2013. Subsequently, the AG Inspection Team requested the Director General's Office vide letter No.Admin-II/Dis/A.G Office/2020-21/1041 dated: 07.06.2021(Annexure B), and Reminder-I,No.Admn-II/Dis/A.G Office/2020-21/08 dated: 16.06.2021(Annexure C) to initiate an inquiry at their level in order to further investigate the matter.

In response, the DG Health conducted an investigation and submitted a report(Annexure D), which revealed that the case of Bushra Pervez lacked supporting documents, except for the appointment order, medical fitness certificate, and arrival report. As a result, it was concluded that the appointment of Mst Bushra Pervez was illegal and fake. Considering these facts, the salary of Mst Bushra Pervez was stopped effective from June 1, 2022.

#### Para No. 05:

Accountant General's Office, through its letter No. Admin-II/2022-23/175 dated:24.10.2022(Annexure E) and Reminder-II No.Admin-II/2022-2023/326 13.05.2023(Annexure F) formally requested the Secretary to the Government of Khyber Pakhtunkhwa, Health Department, to conduct a detailed inquiry into the appointments of the 16 employees in the District Health Office Bajaur. However, as of the current date, no response or reply has been received by the Accountant General's Office regarding this matter. Consequently, the salary of Mst Bushra Pervez remains inactive at the District Accounts Office Bajaur.

# RE-ENAMINATION OF THE CASE OF MISS BURRA PERVEZ, LHV HEALTH DEPARTMENT

Main Title: Intimation of Disciplinary Proceedings against, Mr. Bakht Biland, Assistant Accounts Officer O/o the Accountant General KP, Peshawar.

Subtitle: Re-examination of a self explanatory report by Mian Siyyar Ahmad, Distt: Accounts Officer Bajaur in Case of Miss: Bushra Pervez, LHV Health Department.

Reference: Accounts officer (Admn) Letter on the subject vide No.Admn.II/DAO Bajaur/2022-23/08 dated 11.08.2022

### BACKGROUND:

The AG Inspection Team visited office of the District Accounts Officer Bajaur w.e.f 08.09.2020 to 16.09.2020 and inspected randomly various available record. The record checked on sampling basis. The AG Inspection Team examined the System and System data with regard to arrears of Pay & Allowances allowed by DAO Bajaur in the last Eight years.

During the course of inspection, AG Inspection team also pointed out some doubtful payments (under the Head of Adjustment of Pay and Allowances amounting to Rs. 89.41 (M), paid by staff of DAO Bajaur not only to their personal Bank Accounts but also to the various employees of other DDOs/Departments fall under their Audit Jurisdiction.

In the above context a detailed report, chalked out by the AG Inspection Team containing Twelve Paras in number (Including para 08----FAKE/UNJUSTIFIED Payments amounting to Rs.11.791 million made to 16 number fake employees including the name of Miss: Bushra Pervez, LHV Health Department, Hired in system by Health department Bajaur) and communicated to the DAO Bajaur vide letter No. A.G I Team/Inspection/DAO Bajaur/2020-21/509 dated 04.11.2020. Contents of the AGIT para 08 (In Verbatim) as under

"During the course of inspection, it pointed out that some 16 (sixteen) number employees of various Basic Pay Scales were hired in system from back date by the staff of DAO Bajaur. The Service Books of the employees were examined being duplicate and freshly prepared. The department had no convincing reply/justification of the said employees. Ironically some arrears of pay and allowances have been drawn as per Annexure-E whereas their intentions were ascertained that rest of the arrears for the seven to eight years will be claimed in future.

The DAO Bajaur and DDOs should justify the huge arrears allowed and persons hired from back dates i.e date of appointment have been shown in system as of 2012 & 2013 and after the express

But after perusal, the replies were found un-convincing & unjustifiable by the A.G Inspection Team and further audit comments offered by the AG-IT (In Verbatim) as under:

During the course of inspection, it pointed out that some 16 (sixteen) number employees of various Basic Pay Scales were hired in system from back date by the staff of DAO Bajaur. The Service Books of the employees were examined being duplicate and fresh prepared. The convincing department had no of the said reply/justification employees.

To probe further in to the matter, the competent authority vides Notification No. Admn-II/DIS/AG Office/2020-21/968 dated 04.05.2021 constituted facts finding committee, comprising of the following officers to conduct detail inquiry into fraudulent payments to the tune of Rs. 89.41 (Million) allowed by the staff of DAO Bajaur and submit report there on.

1. Muhammad Riaz.

Accounts Officer (Main Office)

2. Hameed Khan

Data Processing Officer (Main Office).

Consequent upon approval of the visit / Tour program, the committee visited DAO Bajaur w.e.f 02.06.2021 to 04.06.2021 and checked all the relevant record regarding the un-justified payments and reduced their comments in writing.

Final comments of the facts finding committee regarding para 08 wherein the name of Miss; Bushra pervez, LHV Health Department was also included, (In Verbatim) as under:

FAKE/UNJUSTIFIED PAYMENTS AMOUNTING TO RS. 11.791 MILLION MADE TO 16 NUMBER FAKE EMPLOYEES HIRED IN SYSTEM BY HEALTH DEPARTMENT BAJAUR.

The Accountant General Inspection Team, during its visit to Bajaur (08.09.2020 to 16.09.2020) observed some 16 number employees of various cadres of Health Department Bajaur as illegally appointed/hired into system (inducted in SAP system for starting of salarles Illegally) on the following grounds:-

- i. They were shown appointed somewhere in 2012, 2013 whereas their regular salaries started in system since 2018, the gape of almost 05 to 06 years were filled by drawing huge arrears/adjustment of pay and allowances from time to time since 2019.
- ii. Service books of the employees were shown to A.G Inspection Team as well as to the preliminary inquiry committee which were freshly prepared and the Service Book's ages were hardly of 2 years. The District Health Officer Bajaur was asked through District Accounts Officer Bajaur to reply cogently but failed. The inquiry committee requested Director General Health Services Bajaur to inquire the matter vide letter No. Admn-II/Dis/A.G Office/2020-21/1041 dated 07.05.2021 (Annex-12) and followed by a reminder vide No. Admn-II/Dis/A.G Office/2020-21/08 dated 16.06.2021. (Annex-13)
  - iii. In response, the Director General Health Services K.P stated vide letter No. 5418-20/DGHS dated 21.06.2021 (Annex-14) and requested to grant 02 weeks time for conducting detail inquiry as the reply of DHO Bajaur is ambiguous and doubtful which needs proper inquiry and nominated Dr. Sher Khan Director (HRM) DGHS Khyber Pakhtunkhwa who after conducting facts finding inquiry submitted his report on 02.07.2021 and received to this office on 05.07.2021 as (Annex-15) which is also not convincing on the following grounds.
    - a. It was previously claimed that the said 16 number employees were project employees which were later on regularized but ironically the inquiry officer/Director (HRM) shown in his report, the employees were appointed by DHO on initial appointment basis in light of an advertisement wherein last date for submission of applications was 30.04.2013 and 06.05.2013. Interestingly, Column-6 (Date of

appointment) revealed that the employees mostly appointed on 11.03.2013, 28.02.2013, 01.9.2010, 30.12.2004, 01.01.2009 and 26.03.2002.

- b. The Inquiry officer in his report has not given sufficient weight to the observation of this office that why the pay/salaries of the employees were not drawn well in time from the date of appointments of employees shown as 2002, 2004, 2009 and 2013 till 2018.
- O2. Taking into consideration the logical point of the Accountant General Inspection Team and the non convincing reply/findings of the Director (HRM) the inquiry committee headed by the undersigned confirmed the views of AG I Team that the 16 number employees shown in Para-08 are fake/and illegally appointed in back dates. Complete original file of the inquiry conducted by the Health Department is attached herewith.

### FINDINGS/FURTHER COMMENTS.

- 1. Miss: Bushra pervez was found appointed as LHV/BPS 09 vide office order No.1158-59/PF/C-11/BJR dated 28.05.2015 issued by the AGENCY SURGEON BAJAUR. She has written in the ARRIVAL REPORT appointment date as 30.05.2015 VICE 28.05.2015.
- 2. Usually date of Medical is written in the Medical certificate while no date has found available in the instant case there is no date under the signature of the MS concerned.

The post of LHV has been shown in BPS 12 in the sanctioned strength summary of Agency Surgeon Bajaur for the FY2013-14 while astonishing to note that she has been appointed in BPS 19 in the FY 2014-15.

4. Advertisement for the said post was made floated in the print media in April 2013 while her appointment was made in May 2015 i.e. after a period of approx: two years which has made the appointment as Doubtful. Such appointment is called pending recruitment which is found only in recruitment made through public service commission. No justification for procrastination in the recruitment in question has been highlighted in the self explanatory report of the DAO Bajaur.

5. In the inquiry report submitted by Director (HRM) Directorate General Health Services KP Vide No.9650/E-1/ Dated 02.07.2021, it has been mentioned that no document is available in r/o Bushra Pervez khan LHV except appointment order, Medical fitness certificate and arrival teport. Service book and other documents have found reported missing in the said report. In the said inquiry report(DG HEALTH KP) it was also revealed that in compliance to the honorable court judgment some employees(including Bushra Pervez)were adjusted in DHQ Hospital Khar Bajaur against newly created posts for Trauma centre and in 2016 their salaries along with arrears were granted while no such reference was found quoted in service book/appointment order of Miss.Bushra issued on 28.05.2015.So it's not clear whether she was appointed initially on contract/Adhoc basis and later on was got regularized in compliance to the honorable court judgment or otherwise. Furthermore her arrival was found reported on 28.5.2015(Health Inquiry Report) instead 30.05.2015 as communicated in the DAO Bajur report.

6. According to the system his entry date in to the Govt; job is 30.05.2013 contrarily to the entry made in the service book (30.05.2015) archived from the appointment order dated 28.05.2015. While her pay found started wef July 2015 ie after a period of 25 months. Some arrears have also been found paid in july 2015. Reason of delay in drawl of pay has not been recorded anywhere in the service documents.


