PARAWISE COMMENTS ON BEHALF OF RESPONDENTS NO. 1 & 2

RESPECTFULLY SHEWETH:

Preliminary Objections:-

1. That the instant service appeal is not maintainable under the law.
2. That the appeal is not based on facts.
3. That the appellant has got no cause of action and locus standi.
4. That the appellant has concealed the real facts from the honorable Tribunal.
5. That the appellant is estopped to file the service appeal by his own conduct.
6. That the appeal is barred by law & limitation.

REPLY ON FACTS:-

1. Para to the extent of appointment as Levy Sepoy is not related need, no comments while rest of the para is not plausible because every Police Officer is under obligation to perform his duty efficiently.
2. Correct to the extent that after 25th constitutional amendment, the erstwhile FATA was merged in the Khyber Pakhtunkhwa Province and accordingly after fulfillment of codal formalities, the Ex-Khasadars were absorbed in Khyber Pakhtunkhwa Police according to law/rules enacted / framed for the purpose.
3. Pertains to record, hence, needs no comments.
4. Correct to the extent that the appellant was serving as Havildar in Ex-Levy Force and he was absorbed as Head Constable (BPS-09) as under Schedule-I rule 3(b) of Levies/ Khasadar Absorption Rules 2019 vide notification dated 11.02.2020. **(Annexure-A)**
5. Plea taken by the appellant is not plausible because every Police officer is under obligation to perform his duty quite efficiently and up to the entire satisfaction of seniors because in this department no room lies for lethargy. Besides, non receipt of complaint does not mean a clean chit for future wrong deeds.

6. Incorrect. The order dated 28/11/2023 was not issued by Respondent No.1, in-fact the District Police Officer Mohmand forwarded a list of 44 notified ASIs to respondent No. 2 for confirmation in their ranks (**Anx "B"**). Hence Respondent No. 2 i.e. the Regional Police Officer, Mardan issued the confirmation order in accordance with rules/Policy of Government. (**Anx "C"**). Whereas the appellant was serving as Havildar in Ex-Levy Force and he was accordingly absorbed / confirmed as Head Constable BPS-09 (**Anx "D"**).

It is pertinent to mention here that after issuance of notification, some anomalies were found, which were sent to the Deputy Commissioner Mohmand and District Accounts Office Mohmand for re- verification vide letter No. 2639/DPO (Mohmand) dated: 31/10/2019 (**Anx "E"**). The Deputy Commissioner Mohmand vide letter No. 938/KC dated 09.03.2020 verified the designation of Respondent No. 4 namely Ajmal Khan s/o Ismail Khan as Naib Subedar. (**Anx "F"**). Similarly the District Accounts Officer Mohmand also verified his designation as Naib Subedar through his pay roll record. (**Anx "G"**). Hence, District Scrutiny Committee headed by the District Police Officer comprising of Deputy Commissioner Mohmand and District Account Officer Mohmand as members, entertained the request of respondent No.4 under Schedule-I rule 3(b) of Levies/ Khasadar Absorption Rules 2019 (**Anx "H"**).

His case for correction in the rank was sent to Home & Tribal Affairs Department vide letter No. 2013-16/OSI dated 20/04/2020 (**Anx "I"**). The Home & Tribal Affairs Department Peshawar accordingly issued corrigendum notifications vide No. SO (Police) HD/SMY 2019/ Merged Area/2649-58 dated 30.11.2020 (**Anx "J"**).

On the request of a group of Head Constables of District Police Mohmand (including the appellant) an enquiry regarding the actual rank of both the respondent was also initiated against them. In response the enquiry officer after fulfilling codal formalities submitted his report regarding the actual rank of respondent No. 4, which reveals that the private respondent 4 was initially reported by the District administration as Khasadars, hence he was absorbed as Constable vide notification. No. SO (Police) HD/SMY/2019 dated 11.02.2020. (**Anx "K"**).

The Inquiry proceeding initiated against the actual rank of respondent No. 4 namely Ajmal Khan duly re-verified by the above mentioned departments is enclosed as per (**Anx "L"**).

However, the enquiry regarding the ascertaining the actual rank of respondent No. 3 is still laying pending for want of verification, with the office of Deputy Commissioner Mohmand, District Account Officer Mohmand and Section Officer (Levy/ Khasadars) Home & Tribal Affairs Department Peshawar. (**Anx "M"**).

7. In correct. The appellant has not submitted departmental appeal before the respondent No.1 because no such information has been received to this office for seeking comments etc i.e. DPO/ Mohmand.
8. The orders are based on cogent reasons and in accordance with rules/Policy of Government hence, the appellant has got no cause of action, therefore, the instant appeal may kindly be dismissed on the following grounds.

REPLY ON GROUNDS:-


- A. Incorrect, the order dated 28/11/2023 is legal and according to law, facts and principles of natural justice, hence liable to be maintained as the reasons have already been mentioned in detail in Para No. 6 of the facts.
- B. Incorrect, as already explained in preceding paras, the private respondents No. 4 is not promoted, in fact due to clerical mistake in the list provided by District administration Mohmand, Government of Khyber Pakhtunkhwa Home & Tribal Affairs Department has absorbed No. 4 as Constable through notification dated 11/02/2020 and after proper re-scrutiny of credential Government of Khyber Pakhtunkhwa Home & Tribal Affairs Department has issued corrigendum notification No. SO(Police) HD/SMY 2019/ Merged Area/2649-58 dated 30.11.2020, wherein it is stated that the designation of Respondent No. 4 namely Ajmal Khan s/o Ismail Khan may be read as Assistant Sub Inspector instead of Constable. The orders passed by competent authority are legal and according to law, facts and principles of natural justice, hence liable to be maintained.
- C. Incorrect, the appellant has been treated by the respondent Department in accordance with law and rules on the subject noted above and the respondents did not violate Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- D. Incorrect, as already explained the appellant is not discriminated by the respondents and the respondents did not violate the principle of natural justice, rather he has been treated in accordance with law/ rules and policy on the subject.
- E. Incorrect, as already explained the appellant is not discriminated by the respondents and the respondents did not violate law/ rules and policy on the subject.
- F. Incorrect, already explained in preceding paras and respondents did not violate section 9 of the KP Civil Servant Act, 1973.
- G. Correct to the extent to Article 38 of the Constitution of Islamic Republic of Pakistan, 1973, the state is bound to reduce disparity in the income and earning of individuals including persons in the Service of the Federation. The Article referred by the appellant has no nexus with the instant matter, rather the stance taken by the appellant is totally bereft of any substance.
- H. The respondents department also seeks permission to raise additional grounds at the time of arguments.

PRAYERS:

Keeping in view the above stated facts it is humbly prayed that the appeal being not maintainable, barred by law/ rules may kindly be dismissed with costs, please.

2. The above absorption shall be subject to the following terms and conditions:

- (i) Their services shall be governed under the Khyber Pakhtunkhwa Police Act, 2017 and the rules made thereunder.
- (ii) A member shall not be entitled for absorption, if he has resigned from Levies Force Service or has been terminated from the Service ibid on account of misconduct, inefficiency or any other grounds or has been retired from Service under the Federal Levy Force (Amended) Service Rules 2013, before commencement of the Khyber Pakhtunkhwa Levies Force Act, 2019 (Khyber Pakhtunkhwa Act No. XXXV of 2019).
- (iii) Their services shall be considered regular and they shall be eligible for pension and deduction of General Provident fund in terms of the Khyber Pakhtunkhwa Civil Servant Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973).
- (iv) Their seniority shall be determined in accordance with rule 6 of the Levies Force (Absorption in Khyber Pakhtunkhwa Police) Rules 2019.
- (v) They shall undergo training as provided in rule 5 of Levies Force (Absorption in Khyber Pakhtunkhwa Police) Rules, 2019.

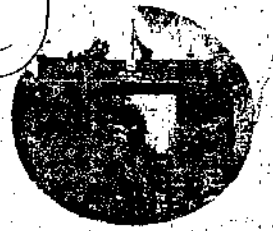



The Khasadar Force (Absorption in the Khyber Pakhtunkhwa Police) Rules, 2019.

1. Short title, application and commencement.—(1) These rules may be called the Khasadar Force (Absorption in the Khyber Pakhtunkhwa Police) Rules, 2019.

(2) These rules shall apply to all members of the Khasadar Force.

(3) These rules shall come into force at once.

2. Definitions.—(1) In these rules, unless there is anything repugnant in the subject or context, the following expressions shall have the meanings hereby respectively assigned to them, that is to say,—

(a) "absorption" means the process of permanent induction of the members of the Khasadar Force in the Police, in accordance with these rules;

(b) "Act" means the Khyber Pakhtunkhwa Khasadar Force Act, 2019 (Khyber Pakhtunkhwa Act No. XXXIV of 2019);

(c) "Provincial Police Officer" means the head of the Provincial Police, who is appointed under section 15

of the Police Act, 2017 (Khyber Pakhtunkhwa Act No. II of 2017); and

(d) "Schedule" means the Schedule, appended to these rules;

(2) Words and expressions used, but not defined in these rules shall have the same meanings as are respectively assigned to them in the Act.

3. Absorption.—The members of the Khasadar Force shall be permanently absorbed in the Police, against vacancies to be newly created in the Police Department for the purpose, in the following manner:

- (a) A Scrutiny Committee, headed by the Commandant, and having one member each from District Administration and District Account Officer of the district concern, shall prepare the lists of all the members of the Khasadar Force after personal appearance and scrutiny of record for submission to the Provincial Police Officer;
- (b) the lists, submitted to the Provincial Police Officer, under sub-rule (1), after proper sifting, shall be forwarded to Home and Tribal Affairs Department of Government with the recommendations for permanent absorption of members of the Khasadar Force in the Police into the respective ranks or cadres as per the Schedule; and
- (c) the Home and Tribal Affairs Department of Government, after receiving the lists of all the members of Khasadar Force, shall issue notification of absorption of the Khasadar Force in the Police after approval of the Cabinet.

4. Remuneration or incentives.—The Khasadar Force after absorption in the Police shall be entitled to the same benefits, remuneration and other incentives as are enjoyed by other members of the Police.

5. Training.—Special training modules shall be designed by the Training Wing of the Police for imparting requisite police training so that the members of the Khasadar Force are fully sensitized with all Police functions.

6. Seniority.—Members of the Khasadar Force, who are absorbed in the Police, in accordance with Government orders and instructions, shall take seniority in the Police from the date of the initial appointment upon recruitment in the Khasadar Force:

Provided that the officer inducted in one batch, upon induction, shall retain their inter se seniority as in the Khasadar Force:

7. Repeal and savings.—(1) All rules, orders or instructions, including the Federal Khasadar Force Service Rules, in force in respect of the Khasadar Force, immediately before the commencement of these rules, shall be deemed as repealed in so far those rules, orders or instructions are inconsistent with these rules.

(2) Notwithstanding the repeal of all rules, orders or instructions, including the Federal Khasadar Force Service Rules, mentioned in sub-rule (1)-

(a) affecting the seniority and promotion, all promotions done seniority determined and orders made shall be deemed to have been done, determined and made in accordance with law. The repeal, shall not affect any right, privilege, obligation or liability acquired, accrued or incurred under the repealed rules, orders and instructions;

(b) shall not affect any investigation or legal proceedings in any Court of Law and shall be continued in the same manner as if the laws and rules have not been repealed.

3. Removing of difficulties.--(1) If any difficulty arises in giving effect to any provisions of these rules and notifications made thereunder, a Technical Committee, comprising of three members of the Police Department, to be notified by the Provincial Police Officer, headed by an Officer of Police, who shall not be below the rank of Deputy Inspector General of Police and two other members of Police Department, whose ranks shall not be less than Senior Superintendent of Police, may recommend to Government for giving effects to the provisions of these rules.

(2) Government, after considering such recommendations, submitted by the Technical Committee, under sub-rule (1), may, by notification, make such orders, not inconsistent with the provisions of the Act or these rules, as may appear to it to be necessary for the purpose of removing such difficulty.
