

Reply on Behalf of Answering Respondent No 4,5 & 6

Respectfully Sheweth,

The answering Respondents humbly submits as under

Preliminary Objection:

1. That the Appellant has got no cause of action to file the instant appeal against the answering Respondents No 4, 5 & 6.
2. That the appeal of Appellant is not maintainable in its present form and is liable to be dismissed with cost throughout.
3. That the instant appeal is hit by principal of estoppel hence, being nullity in eye of law is liable to be dismissed.
4. That the Appellant has not come to this Hon'ble court with clean hands and has suppressed material facts from this Hon'ble Court for ill-gotten gains.
5. That the appellant and Respondent No. 4, 5 & 6 was appointed on the same day as PST teachers on 24/06/1997. Furthermore on 08/03/2013 appellant as well as Respondent No. 4,5 & 6 were promoted to the post of Senior primary School teachers BPS-14 (at serial No 458, 460, 464 and 465)
{Copies seniority list for the year 2012 and promotion notification of appellant and Respondents No. 4, 5 & 6 is annexed as R/1 & R/2}.
6. That later on (Respondent No. 4) was promoted to primary School Head Teacher BPS-15 vide Notification dated 12/06/2013. Consequently Sohrab Khan (Respondent No. 6) was also promoted to the post PSHT BPS-15, while appellant forgo the said promotion, while appellant did not availed the said promotion.

{Promotion orders of Respondent No. 4 & 6 and Notification dated 22/10/2011 & office order dated 21/09/2013 are annexed as R/3, R/4, R/5 & R/6}

7. That as per policy of 2012 Respondent No.4 & 5 were promoted to the post of Certified Teacher BPS-15 from Primary School Head Teacher (PSHT) BPS-15 by the Departmental Promotion Committee On 6-11-2014, while respondent No. 6 was promoted by the appellate committee on 09/12/2014 and later on the appellant was also promoted by the appellate committee to the post of CT BPS-15 on 10-01-2015. It is also a golden principal of law that law favors vigilant not indolent. The appellant never challenged the said promotions of the Answering Respondents well in time which is badly time bared.

{Copies of promotion orders of Answering Respondents as well as Appellant are annexed as R/7 and policy 2012 is R/8}

8. That That the Appellant through instant appeal badly failed to point any illegality in the promotion process conducted by the Departmental Promotion Committee hence, the instant appeal being frivolous and fruitless is liable to be dismissed at the very inception.

REPLY TO FACTS:

1. Para 01 is admitted correct hence, needs no reply
2. Para No 2 is admitted correct hence, needs no reply
3. Para No.3 of the appeal is wrong incorrect hence denied. Appellant and Respondent No. 4, 5 & 6 was appointed on the same day as PST on 24/06/1997. As per policy of 2012 Respondent No.4 & 5 were promoted to the post of Certified Teacher BPS-15 from Primary School Head Teacher BPS-15 by the Departmental Promotion Committee On 6-11-2014, while respondent No. 6 was promoted by the appellate committee on 09/12/2014 and later on the appellant was promoted by the appellate committee to the post of CT BPS-15 on 10-01-2015. It is pertinent to note that appellant forgo the promotion from SPST BPS-14 to PSHT BPS-15, hence departmental promotion committee had rightly promoted Respondents No. 4, 5 & 6 to the post of CT BPS-15. Hence no illegality has been made out.
4. Para No.4 is admitted to the extent of acceptance of appeal by the appellate committee with immediate effect.

5. Para No. 5 of the appeal is wrong incorrect hence, denied. The detail reply has already been given in above paras as well as in the preliminary objections.
6. Para No.6 too is pertaining to record, hence, needs no comment.
7. Para No. 7 of the appeal is wrong, illegal, fictitious, unfounded, misleading, against settled law and facts, hence, denied. Detail reply has already been given in above pars as well as in preliminary objection.
8. Para No.8 pertains to record hence, need no reply.
9. Para No.9 of the appeal needs no comments

REPLY TO GROUNDS:

- A. Incorrect hence denied. Respondent Department had followed the rules/policies. It is pertinent to mention here that Respondents have duly followed the law and policy on the subject matter. The detail reply is already been given in above paras.
- B. Para B of the ground is wrong, incorrect, misleading against fact, law and available record hence denied. Moreover department had followed the rules, policies on the subject matter hence, no question of violations of any of the article of constitution of the Islamic republic of Pakistan. Furthermore this is appellants who concealed material facts from this Hon'ble Court.
- C. Incorrect hence denied. The details reply has already been in preliminary objections.
- D. That Para D of the grounds of appeal is wrong, illegal, misleading, concocted and mere bald allegations without any support of documentary proof hence, denied. The detail reply is already been given in above para.
- E. That para E of the ground, is wrong, incorrect, misleading against fact, law and available record hence denied. Appellant never remained senior to the answering Respondents rather all are appointed on the same day i.e 24/06/1997. The detail reply has already been given in above pars as well as in preliminary objections
- F. That Para F is wrong, fabricated hence, denied. Detail reply has already been given in above paras.

G. The appeal of the Appellant is a house of play cards and nothing more, what to say about any other ground. Moreover the answering Respondent having strong arguable case seeks permission of this Hon'ble Court to raise any other ground during argument with prior permission of this Hon'ble Court.

In wake of above submissions, it is therefore, most humbly prayed that on acceptance of this reply the appeal of the appellant may kindly be dismissed with cost
