The Para -Wise comments are submitted as under:

PRELIMINARY OBJECTIONS:-

- a) That the appellant has got no cause of action to file the present appeal.
- b) That the appellant has got no locus standi.
- c) That the appeal is bad for mis-joinder and non-joinder of necessary parties.
- d) That the appeal is not maintainable in its present form.
- e) That the appellant is estopped by his own conduct to file the instant appeal.
- f) That the appellant has concealed Material facts from this Hon'able Tribunal.
- g) That appellant has not come to the Tribunal with clean hands.
- h) That the appeal is time barred.

<u>FÀCTS.</u>

- 1. Para is correct to the extent of Service of appellant in Levy Force and subsequent absorption as Constable in Khyber Pakhtunkhwa Police, however appellant after absorption in Police proved himself an inefficient official.
- 2. Pertains to Service record, hence need no Comments.
- 3. Para is correct to extent of issuance of charge sheet. Appellant while posted as Incharge of City Sadda, took a huge amount from drug dealers, allowed them, and helped them in their drug business. His this act of supporting drugs dealers and criminal's amounts to gross misconduct, rendering himself unfit for police service, besides tarnished the image of police department.

On account of such misconduct appellant was served with the Charge sheet and proper Disciplinary proceedings were initiated against him, for which Mr. Mazhar Jehan SP Investigation, Kurram was nominated as Enquiry Officer and proper departmental Enquiry proceeding was initiated against him. (Copies of Charge Sheet and Disciplinary Action are attached as Annex "A" & "B").

4. Incorrect: Proper disciplinary proceeding was initiated against appellant, through Mr.Mazhar Jan SP Investigation, Kurram. During proceeding appellant was associated, and provided opportunity of cross examination, but he failed to prove himself innocent. During enquiry appellant was found guilty for the misconduct. Appellant has been found involved in contacts with drug dealers, hence the enquiry officer recommends him for

major punishment. Consequent upon receipt of recommendation of enquiry Officer, appellant was served with Final Show Cause Notice the reply of which was found unsatisfactory, however, before passing any final Order appellant was heard in person in Orderly Room, but he failed to advance any cogent reason in support of his innocent, hence he was dismissed from Service in accordance with the rules. (Copies of Enquiry/Finding Report, Final Show Cause Notice and Dismissal Order are attached as Annex "C", "D" & "E").

- 5. Para is incorrect and misleading. Reply already given in para-4 above.
- 6. Correct to the extent of filing of departmental appeal, however, the same was examined by the appellate authority and rejected the same being devoid of merit, through speaking Order, after providing him an opportunity of personal hearing. (Copy of Rejection Order is attached as "F").

GROUNDS

- A. Incorrect: The Orders of respondents are quite legal and accordance with rules/laws.
- B. The appellant was served with proper Charge Sheet vide No. 08/PA dated 26.10.2023.
- C. Incorrect: Proper charge sheet was issued against appellant and after proper enquiry during which he was found guilty.
- D. Incorrect: Proper departmental enquiry initiated against the appellant through enquiry Officer Mr. Mazhar Jehan SP Investigation. During enquiry appellant was associated with the enquiry proceedings and proper opportunity of cross exanimation was provided to the appellant.
- E. Incorrect: The appellant was issued Final Show Cause Notice his reply was received but the same has been found unsatisfactory, hence dismissed from service.
- F. Incorrect: Appellant was provided the relevant documents.
- G. Incorrect. Reply already given vide paras above.
- H. The charges against appellant stands proved during departmental enquiry beyond any shadow of doubt. Appellant was associated with the enquiry proceedings, but he failed to prove himself innocent.
- I. As already explained above in proceedings paras.
- J. Not relevant to the case of appellant, the charges against appellant has already stands proved during enquiry.
- K. Pertains to record, hence need no comments.
- L. Pertains to record, hence need no comments.





ORDER:

This order is hereby issued to dispose of departmental enquiry initiated against the delinquent constable Naqeeb Ullah 950/km, vide this office No. 09/PA dated 26/10/2023, having Mr. Mazhar Jehan SP Investigation, Kurram as enquiry Officer, with following allegations.

"Reportedly you while posted as Incharge City Sadda as close connivance SHO PS Sadda in with while posted as took huge money from drug dealers, allowed them and helped them in their drug business. Your act of mixing with drug dealers and criminal's amounts to gross misconduct on your part rendering you are unfit for police service".

2. On 02.11.2023, Enquiry Officer finalized his enquiry against constable Naqeeb Ullah 950/km vide letter No.1061/SP/INV/Kurram dated 24.11.2023 with following findings and recommended him for major punishment.

3. On 03.11.2023, Constable Naqeeb Ullah 950/km was issued Final Show Cause Notice vide this office letter No. 33/PA dated 25.11.2023 His reply has been received to this office and has been found unsatisfactory.

4. On 05.12.2023, he was summoned in orderly room and was heard in person at length. His written as well as verbal explanation has been considered and found un-satisfactory. He could not produce any convincing explanation in his defence.

5. I have gone through the contents of enquiry report. I have also got information from discreet as well as open sources and personal service file of the delinquent officers. He was posted as Incharge Sadda City. He got mixed up with criminals/drug mafia; got huge money and destroyed already weak fabric of newly born police department in Kurram. Corruption begets corruption, injustice crime and social unrest. Ignoring such acts of corruption is akin to promoting corruption. Mixing up with drug mafia and criminals is bane for police Officer. In

order to break this ignominious circle of corruption, strict and exemplary action is dire need of the hour.

6. After perusal of enquiry file, findings of the enquiry officer, and service record of the delinquent police personnel I, the undersigned have reached the conclusion that delinquent officer Naqeeb Ullah 950/KM has been found involved in mixing up with drug dealers took month wise bribe from drug dealers. Such grievous misconduct has earned bad name for the police department and must not go unattended.

Therefore, I **Muhammad Imran (PSP)** District Police officer Kurram, being a competent authority, agreeing with the findings of enquiry officer, hereby award Constable Naqeeb Ullah 950/km major punishment of **Dismissal From Service** with immediate effect under Khyber Pakhtunkhwa Police E&D Rules 1975 (amended 2014).

ORDER.

This order will dispose of the appeal preferred by Ex- Constable Nageeb Ullah No.950 of District Kurram, against the punishment order passed by District Police Officer, Kurram vide OB No.729, dated 12.12.2023 whereby he was awarded major punishment of Dismissal from service.

Ament

Brief facts of the case are that the appellant was posted as Incharge City Sadda where he, in connivance with SHO P.S Sadda had cultivated a close relation with narcotics sellers/ drug peddlers. He was also found involved in taking money from drug dealers in order to allow them to run their illegal narcotic business. This act on the part of delinquent officer amounted to gross misconduct.

District Police Officer, Kurram initiated proper departmental enquiry proceedings against him and Superintendent of Police, Investigation, Kurram was appointed as Enquiry Officer. The Enquiry Officer after fulfillment of codal formalities, submitted his findings wherein the appellant was found guilty of the charges leveled against him. On recommendation of the enquiry officer, the District Police Officer, Kurrm issued Final Show Cause Notice to him vide No.33 dated 25.11.2023 but his reply to the Final Show Cause Notice was found unsatisfactory.

Keeping in view the recommendations of the Enquiry Officer and the above cited circumstances, the delinquent officer was awarded major punishment of dismissal from service vide District Police Officer, Kurram OB No.729 dated 12.12.2024.

Feeling aggrieved from the order of District Police Officer, Kurram, the appellant preferred the instant appeal. He was summoned and heard in person in Orderly Room held in the office of the undersigned on 07.05.2024. During personal hearing, the appellant could not advance any plausible justification in his defense to prove his innocence

Foregoing in view, I, Sher Akbar, PSP, S.St, Regional Police Officer, Kohat, being the appellate authority, am of considered opinion that the charges leveled against the delinquent officer have been fully established. The punishment of dismissal from service awarded by District Police Officer, Kurram to the delinquent officer is justified and, therefore, warrants no interference. Hence, appeal of Ex Constable Naqeeb Ullah No.950 is hereby rejected, being devoid of substance and merit.
