JOINT PARA-WISE COMMENTS ON BEHALF OF RESPONDANTS NO. 1 & 2.

PRELIMINARY OBJECTIONS:

- 1. That the appellant has no cause of action / locus standi.
- 2. That the appellant has not come to this Honorable Tribunal with clean hands.
- 3. That the present appeal in hand is not maintainable in its present form and also in the present circumstances of the issue.
- 4. That the present appeal is liable to be dismissed with cost for miss joinder / non joinder of necessary parties.
- 5. That the appellant has filed the instant appeal on malafide motives.
- 6. That the instant appeal is against the prevailing laws and rules.
- 7. That the appellant is estopped by his own conduct to file the present appeal.

RESPECTFULLY SHEWETH,

FACTS:

- Pertains to record. Hence no comment.
- 2. Incorrect and misconceived. Hence denied. It is clarified that the appellant has been performing his duty since 01.04.2012 in PHE Division Mardan as Junior Clerk and upon his promotion on 01.12.2023 as Senior Clerk (BPS-14) was posted in PHE Circle Mardan with the remarks that salary would draw against the post of Junior Scale Stenographer (Copy promotion/posting order is attached as Annexure-A).

3. Incorrect and misconceived. The appellant is misleading this honorable Tribunal and concealed material facts as the appellant has been working in PHE Circle Mardan as Senior Clerk and withdraw his salary against the post of Senior Scale stenographer. The service history in light of service book of appellant reveals that the appellant was working as Junior Clerk in PHE Division/Circle Mardan since 01.04.2012 and after his promotion there was no original cadre post of the appellant, however, he was allowed to withdraw against the post of Junior scale Stenographer.

The appellant completed his normal tenure in PHE Division/Circle Mardan and the Chief Engineer (Center) being the competent authority transferred the appellant from PHE Mardan to PHE Division Bajaur in the best public interest vide office order No.13/CE-9/PHE dated 30.05.2024. However, due to status quo granted by this honorable Tribunal on 11.06.2024 the appellant did not act upon his posting orders and is still occupying the post in PHE Mardan.

- 4. Incorrect and misconceived, hence denied. The appellant has completed his normal tenure in PHE Division/Circle Mardan. In view of Section-10 of Khyber Pakhtunkhwa Civil Servant Act, 1973 the appellant is bound to serve anywhere in the province (updated version of Khyber Pakhtunkhwa posting / transfer policy is attached as Annexure-B), therefore, the appeal being devoid of any merit may be dismissed with cost. The posting and transfer of the subordinate is the exclusive domain of the competent authority under Section of the Act ibid, which is to be made in the public interest. It is also the prerogative of the authority to assign any duty to the subordinate for better service delivery. It is also worth to mention here that the post of the appellant is clerical in nature and he is not dealing with any administrative power.

- H. Incorrect and misconceived. In view of Section-10 of Khyber Pakhtunkhwa Civil Servant Act, 1973 the appellant is bound to serve anywhere in the province, therefore, the appeal being devoid of any merit may be dismissed with cost, as the employees of this department who are resident of other district are working outside their districts. The ground of the appellant is not justified and is liable to be dismissed.

PRAYERS: -





(UPTO 31.1.2018)

gatutory Provision.

section 10 of the Khyber Pakhtunkhwa Civil Servants Act, 1973.

posting and Transfer. Every civil servant shall be liable to serve anywhere within or enable the Province, in any post under the Federal Government, or any Provincial Government or Local authority, or a Corporation or body set up or established by any such Government:-

Provided that nothing contained in this section shall apply to a civil servant recruited specifically to serve in a particular area or region;

Provided further that, where a civil servant is required to serve in a post outside a service or cadre, his terms and conditions of service as to his pay shall not be less favourable than those to which he would have been entitled if he had not been so required to serve.

Posting/transfer policy of the Provincial Government.

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- Existing tenure of posting/transfer of three (03) years for settled areas and two (02) years for unattractive/hard areas shall be reduced to two (02) years for settled areas, 01½ years for unattractive areas and one year for hard areas.
