PARAWISE COMMENTS ON BEHALF OF RESPONDENTSRespectfully Sheweth,Preliminary Objections;

1. That the appellant has ~~got~~ no cause of action.
2. That the appeal is not within time.
3. That the appellant has ~~got~~ no locus standi.
4. That the appeal is not maintainable in its present form.
5. That the appellant has not come to Tribunal with clean hands.
6. That the present appeal is bad for misjoinder & non-joinder of parties.
7. That this Tribunal has got no jurisdiction to entertain and adjudicate upon the instant appeal.
8. That the appeal is without substance, hence liable to be dismissed summarily.

FACTS

1. Para No.1 pertains to record.
2. Para No.2 pertains to record.
3. Para No.3 needs no comments.
4. Para No.4 is not correct, hence denied. The appellant was promoted to Assistant Excise & Taxation Officer vide notification SO(ADMIN)/E&T/1-12/2021/7947-54 dated December 22,2021 WHEREAS the respondents 3,4,6,7 and 8 were promoted to the post of Assistant Excise & Taxation Officer vide notification 10082/Estb/XXXVD-5 dated 03.11.2017. The Departmental Promotion Committee (DPC) unanimously agreed upon promotion of Respondent No.05 from Inspector to post of Assistant Excise & Taxation Officer in DPC meeting held on 20.12.2017. The Respondent No.09 was promoted from Inspector to AETO vide order SO (ADMN) E&T/1-12/2018 dated 23.02.2018. The respondent No.10 was promoted from Inspector to AETO vide order SO (Admn) E&T/1-26/2020

dated 26.01.2021. Hence the appellant and the respondents belonged to different batches and promoted to the post of AETO in different years, but the appellant neither challenged nor raised any objection on any forum. The seniority is fixed and circulated as per law, which attained finality and the appeal is meritless.

5. Para No.05 is correct to the extent that a service appeal has been filed by Respondent 10 which has its own facts and merits. The appellant can't take any benefit from that litigation.
6. Para No.6 needs no comments.
7. Para No.7 is sternly denied. The aforesaid respondents are most senior to the appellant, hence placed senior to the appellant as per their seniority.
8. Para No.8 is wrong, incorrect hence denied. The meeting and promotion would be held/made as per law and the eligible and qualified employees would be considered and promoted.
9. Para No.9 is wrong and incorrect, hence sternly denied. As replied above.
10. In reply to para No.10 it is submitted that the departmental appeal of the appellant was time barred and was based on self-engineered grounds, that is why not considered by the competent authority.
11. In reply to para No.11 it is submitted that the appellant is not an aggrieved person and has no cause of action to file the instant appeal.

GROUNDS

- A. Denied. The seniority list is made as per Section 8 of Khyber Pakhtunkhwa Civil Servant Act,1973 read with Rule 17 of Khyber Pakhtunkhwa of Civil Servants (Appointment, Promotion & Transfer) Rules 1989.
- B. Denied. No illegality has been done by respondent department in fact the appellant has been dealt in accordance to rules.
- C. Denied. The appellant and respondent 3-10 belonged to different batches. The respondents are senior to the appellant hence places senior in seniority list.
- D. Denied. The appellant is made in accordance with law and as per rules.
- E. Denied. The instant appeal is against law and rules. Hence not maintainable.
- F. That this Hon'ble tribunal got no jurisdiction to entertain instant appeal.
- G. The respondents seek leave to raise additional grounds at the time of arguments.

PRAYER:

It is therefore prayed that the instant appeal may kindly be dismissed with costs.







A meeting of the Departmental Promotion Committee (DPC) was held on 20.12.2017 at 1500 hours under the Chairmanship of Secretary Excise, Taxation & Narcotics Control Department in his office to discuss/consider various promotion cases of Excise, Taxation & Narcotics Control, Khyber Pakhtunkhwa. The following officers/members of the Departmental Promotion Committee (DPC) attended the meeting:

Khyber Pakhtunkhwa.

- 5) Laqat Ali,
Section Officer (SR-III), Finance Department.

2. The Secretary Excise, Taxation & Narcotics Control Department welcomed the participants and asked the Director General Excise, Taxation & Narcotics Control, Khyber Pakhtunkhwa to present the instant promotion cases to the committee. The Director General Excise, Taxation & Narcotics Control, Khyber Pakhtunkhwa informed that the following promotion cases are required to be examined by the committee:

- i. Promotion of one Inspector to the post of Assistant Excise & Taxation Officer.
- ii. Promotion of one Senior Scale Stenographer to the post of Superintendent.
- iii. Promotion of one Junior Scale Stenographer to the post of Senior Scale Stenographer

Promotion of one Excise Inspector to the post of Assistant Excise & Taxation Officer.

3. The forum was informed that the case of [REDACTED] Inspector was placed before the DPC in its meeting held on 30.10.2017 and was deferred due to Ehtehab Commission inquiry and regular bail granted by the Peshawar High Court, Peshawar wherein clarification of the Law Department was required. The Director General informed that the requisite clarification of the Law Department as well as Establishment Department was obtained and placed before the forum for consideration.

Keeping in view the clarification of Law and Establishment Departments and threadbare discussion held during the meeting, the forum unanimously agreed upon the suitability of Muhammad Khalid Inspector to the post of Assistant Excise & Taxation Officer on regular basis. The officer will be on one year probation period.

Promotion of one Senior Scale Steno to the post of Superintendent.

5. The Director General informed that one Mr. Pervez Akhtar was promoted as regular Senior Scale Stenographer on 16.05.2017 in compliance of the Kyber Pakhtunkhwa Service Tribunal judgment with a probation period of one year under rule 15(1) of the Kyber Pakhtunkhwa Civil Servants (APT) Rules, 1989.



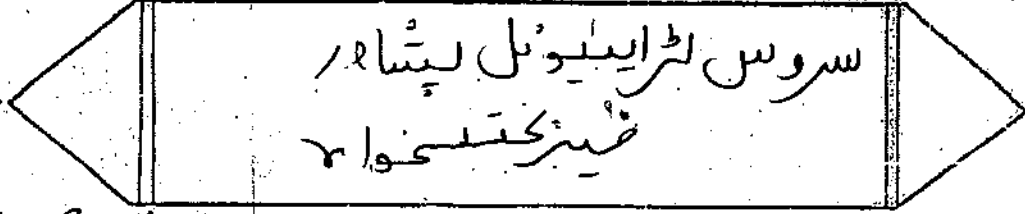
