*Respectfully Sheweth:*


1. That the above titled appeal is pending adjudication before this Hon'ble court and is fixed for 01.07.2024.
2. That PSB of Provincial government of Khyber Pakhtunkhwa for promotion of different employees of different department to higher post was scheduled on 26.06.2024 but was postponed on 25.06.2024 and in the said PSB, promotion of Assistant Engineer BPS-17 to Executive Engineer BPS-18 in Irrigation Department was also scheduled but due to the postponement of PSB, the promotion was not granted to private respondents etc against 05 vacant seats in BPS-18 and now the said PSB is going to be held in the present or in the second week of July, 2024. (Copy of Notification dated 25.06.2024 are attached as Annexure A & B).

3. That the applicant has challenged the seniority of the private respondents and seniority is one of the determining factor for promotion to BPS-18 and if the PSB is held in this week or in the second week of July, then the private respondents would be promoted on the basis of their disputed seniority and thus, the applicant would be deprived from his excepted promotion to PBS-18 and thus the present appeal would become infructuous being appointed much more earlier than the promotion of private respondents and grant of back dated seniority to them in violation of law.
4. That the applicant/ appellant has good prima facie case in his favour and balance of convenience also lies in his favour and if the relief as prayed for in the heading of this application has not been granted then applicant would suffer irreparable loss for which the applicant would not be compensated.

*It is, therefore, humbly prayed that on acceptance of this application, relief as prayed for in the heading of this application may kindly be granted in favour of applicant/ appellant till the final decision of instant appeal.*

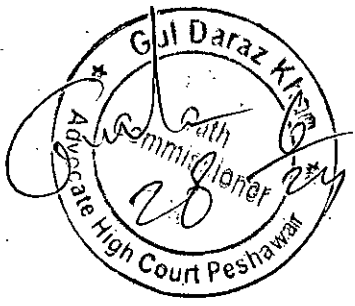
