APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 FOR ANTE-DATION OF NOTIFICATION DATED 30-03-2023 AGAINST WHICH DEPARTMENTAL APPEAL OF THE APPELLANT HAS BEEN NOT RESPONDED SO FOR DESPITE THE LAPS OF STATUTARY PERIOD OF NINTY DAYS.

PRAYER:-

On acceptance of this appeal, the Notification dated 30-03-2023 may kindly be given effect from 19-10-2017 to the extent of the appellant thereby confirming the appellant as Inspector with further seniority/promotion with his colleagues with all back benefits.

Respectfully Submitted:

- 1. That the appellant was initially appointed as Assistant Sub Inspector in Shuhada son's Quota on 29-09-2007 and since appointment he performed his duties with honesty and full devotion and to the entire satisfaction of his high ups.
- 2. That the appellant was then promoted to List "E" and also promoted as Officiating Sub Inspector and later on his promotion to List "E" and promotion to the rank of Officiating Sub Inspector was revised with effect from 27-09-2011 instead of 12-11-2013 vide Notification dated 22-02-2019 and subsequent to the Judgment of the honorable Peshawar High Court, Peshawar, the "E" List seniority of the appellant was revised w.e.f. 21-09-2007 instead of 27-09-2011 vide Notification dated 20-10-2020. (Copy of Notification dated 22-02-2019 & Notification dated 20-10-2020 are enclosed as Annexure A & B).
- **3.** That the Seniority of the appellant as Sub Inspector was not revised for which the appellant requested respondents and which



was recommended by the Deputy Commandant Elite Force vide Letter dated 11-01-2021, which was also recommended by the Departmental Selection Committee in its meeting held on 06-08-2021 and finally the Sub Inspector confirmation was revised w.e.f. 25-08-2014 instead of 29-09-2017 vide Notification dated 16-08-2021. (Copy of Letter dated 11-01-2021, Minutes of DPC meeting dated \$6-08-2021 & Notification dated 16-08-2021 are enclosed as Annexure C & D).

- 4. That the colleagues rather juniors to the appellant were promoted as officiating inspectors on 19-10-2015 and subsequently were confirmed as inspectors on 29-09-2017 while the appellant was promoted as officiating inspector on 28-12-2020 for no fault and was confirmed as inspector vide Notification dated 30-03-2023 w.e.f from 20-12-2022. (Copy of Notification dated 29-09-2017 & 30-03-2023 are enclosed as Annexure E & F).
- 5. That the appellant is entitled to be confirmed as Inspector w.e.f from 19-10-2017, as he has been deprived for no fault from his due right and has been discriminated due to late confirmation the appellant was not promoted as DSP while junior to him were promoted as DSPs though the appellant had qualified the requisite training/course mandatory for promotion to the rank of DSP.
- 6. That the appellant filed departmental appeal on 15-03-2024 for ante-dation of Notification dated 30-03-2023 which was not responded so far despite the lapse of statutory period of ninety days.(Copy of Departmental appeal is enclosed as Annexure G).
- **7.** That the impugned Notification dated 30-03-2023 is against the law, facts and principles of natural justice on the grounds inter alia as Follows.

GROUNDS:

- **A.** That the impugned Notification dated 30-03-2023, is illegal, unconstitutional, and unlawful, without lawful authority and of no legal effect, therefore need the interference of this honorable Tribunal.
- **B.** That the appellant is denied treatment in accordance with law and rules which being his fundamental right as per Article 4 and 25 of the Constitution and law of the land.



- **C.** That the appellant perfectly fit, eligible, senior and coming up to the criteria, is entitled to be confirmed as Inspector with his colleagues.
- **D.** That in order to deprive the appellant of his due right of promotion and favor nears and dears, juniors to the appellant have been promoted, ignoring the appellant.
- **E.** That the seniority and confirmation in the rank of Sub Inspector of the appellant was revised and if his seniority in the rank of Inspector and List "F" is not revised, the same fault could not be attributed to the appellant.
- **F.** That the appellant is the senior, honest and dutiful officer with unblemished record but has not been confirmed as Inspector along with his colleagues. Though he is perfectly fit, eligible and coming up to the criteria as per law & rules.
- **G.** That the appellant seeks the permission of this honorable Tribunal for further/additional grounds at the time of arguments.

It is therefore prayed that appeal of the appellant s may kindly be accepted, as prayed for.

Any other relief not specifically asked for and deemed appropriate in the circumstances of the case, may also be granted in favor of the appellant.





<u>Subject:- Appeal for Ante-dation of Notification dated 30-03-2023</u>

Respectfully Submitted:-

That the appellant was initially appointed as Assistant Sub Inspector on 29-09-2007, was promoted to List "E" and then promoted as Officiating Sub Inspector and later on his Promotion to List "E" and promotion as Officiating Sub Inspector was revised w.e.f. 27-9-2011 instead of 12-11-2013 vide Notification dated 22-02-2019 and subsequent to the Judgment of Peshawar High Court his List "E" Seniority was revised w. e.f. 21-09-2007 instead of 27-09-2011. Upon request seniority as Sub Inspector was revised w.e.f 25-08-2014 instead of 29-09-2017 vide Notification dated 16-08-2021. The colleagues rather juniors to the appellant were promoted as Officiating Inspectors on 19-10-2015 and were confirmed as Inspectors on 19-10-2017 while the appellant was promoted as Officiating Inspector on 28-12-2020 for no fault and was confirmed as Inspector vide Notification dated 30-03-2023 w.e.f. 20-12-2022. The appellant is entitled to be confirmed as inspector w.e.f. 19-10-2017, as he has been deprived for no fault from his due right and has been discriminated. Due to late confirmation the appellant was not promoted as DSP (BPS-17) while juniors to him were promoted as DSP,s, though the appellant had qualified the requisite training/course mandatory for promotion to the rank of DSP.

That the appellant being perfectly fit, eligible, senior and coming up to the criteria is entitled to be confirmed as Inspector with his colleagues and the appellant could not be deprived of his seniority and promotion for no fault, as per plethora of Judgments of the Apex Court, High Court as well as of the honorable KP Service Tribunal.

It is therefore requested that on acceptance of this appeal, the Notification dated 30-03-2023 may kindly be given effect from 19-10-2017 to the extent of the appellant thereby confirming the



appellant as inspector with further seniority/promotion with his colleagues, with all back benefits.
