Respectfully Sheweth:

- (1) That, the appellant is permanent resident of District Bannu and serving in Police Department Bannu as Assistant Sub-Inspector.
- (2) That, complainant of case FIR #718 dated 30/9/2023 u/sec. 324/427/109/114/34 PPC Police Station Township Bannu levelled allegations against the appellant that he has malafidely registered case FIR #888 dated 27/9/2023 u/sec. 15-A.A Police Station Cantt: Bannu, just to cultivate relation with accused party. (Copy FIR #718 and 888 are annexed "A & B").
- (3) That, under the aforesaid allegations, the respondent #2, initiated departmental inquiry against the appellant and issued Show Cause Notice #9-10 dated 19/01/2024 to appellant whereby reply was submitted and the appellant very vividly clarified his position. (Copy of Show Cause Notice #9-10 and reply are annexed "C & D").
- (4) That, the respondent #2, after having perused reply of appellant and findings/report of inquiry officer, vide order #816-17/EC dated 16/02/2024, was pleased to dismiss the appellant from service with immediate effect. (Copy of order #816-17/EC dated 16/02/2024 is annexed "E").

- (5) That, the appellant having no efficacious remedy, submitted mercy petition before the respondent #1, which was marked to respondent #4 for de-novo inquiry. The respondent #4, initiated de-novo inquiry whereby he recorded statements of different police officers and officials and submitted report vide letter #53 dated 05/4/2024. (Copy of letter #53 dated 05/4/2024 is annexed "F").
- (6) That, the respondent #1, after de-novo inquiry, vide order #1163-68 dated 17/5/2024, was pleased to modify the major punishment of appellant of dismissal from service into minor punishment of forfeiture of two years confirmed/approved service. (Copy of order #1163-68 dated 17/5/24 is annexed "G")
- (7) Feeling aggrieved, the appellant having no other remedy but to invoke the jurisdiction of this Homble Tribunal, inter-alia on the following grounds:

GROUNDS:

- (1) That, censure of appellant in shape of forfeiture of two years confirmed/approved service awarded by the respondents, is against the law, facts, and natural justice and as such the same is not sustainable in the eyes of law.
- (2) That, in fact, on 27/9/2023, the appellant along police contingents were on patrol duty and received information that a suspected person was present at Sukari Karim Khan armed with Kalashnikov. On such information the appellant and police party

reached the said place and overpowered the accused with Kalashnikov who disclosed his name as Muzzamil Shah. The accused was arrested and was produced before Court. After three days of the occurrence, the aforesaid accused was also charged in a criminal case u/se. 324 PPC regarding same the appellant has no knowledge nor facilitated him in the commission of the offence.

- (3) That, the statements of witnesses recorded after de-novo inquiry, fully support the appellant version. It is also admitted on record that the allegations against the appellant have been found baseless, therefore, the appellant is entitled to be reinstated in service with immediate effect without forfeiture of his two years confirmed service.
- (4) That, the appellant has been continuously ignored on superficial grounds which act of responden's is *prima-facie* encroachment upon the fundamental and constitutional rights of appellant and against the law.

(5) That, in light of above, the act of respondents is totally unwarranted and against the law and as such the same is liable to be set at naught.

(6) That, the appellant's counsel respectfully seeks permission of this Hon'ble Tribunal to advance and rely on additional grounds at the time of hearing of instant appeal.

For the abovementioned reasons, it is therefore, respectfully prayed that this appeal may graciously be allowed as prayed for just to meet the ends of justice.



ORDER:

This order will dispose of departmental enquiry conducted against ASI Sifatullah Khan No.286/B of District Police Bannu, who while posted at PS Canti: Bannu committed the following irregularity. As such a Show Cause Notice was served against him vide this office No.09-10/PA under rule 5(3) of the Khyber Pakhtunkhwa Police Rules 1975:-

That he registered FIR No.888 dated 27/09/2023 u/s 15AA PS Cantt: Bannu with malatide intention by cultivating relations with the accused party to favour them in the criminal case FIR No.718 dated 30/09/2023 u/s 32/1/427/109/114/34 PPC PS Township Bannu which speaks highly adverse on his part and amounts to gross misconduct / disloyalty.

An enquiry into the allegation was received from SP Investigation Bannu vide his letter No.204/Inv: dated 16/01/2024. The E.O conducted inquiry into the allegations and submitted his findings, where, the E.O concluded that both the ASIx Suhaib KLhan and Sifat Ullah, who registered cases vide FIRs No.888 and 889 with mala-fide intention by cultivating relations with the accused party to favour them in the criminal case registered vide FIR No.718 at PS Township Banu. The delinquent officer was served with Show Cause Notice. Reply to the SCN was received unsatisfactory. He was also heard in person in orderly room held in RPO Office Bannu on 15.02.2024. His plea was not found convincing.

He committed a serious violation. His conduct was highly unbecoming and brought a bad name for the department.

Therefore, I, Qasim Ali Khan, PSP, Regional Police Officer, Bannu Region Bannu, in exercise of the powers vested in me under Khyber Pakhtunkhwa Police Rules, 1975 (amended in 2014) hereby dismiss ASI Sifutullah Khan No. 286/B of District Police Bannu from service with immediate effect.

Kindly refer to your office Endst: No.58/1%, dated 29:03.2024, on the subject noted above.

It is submitted that Ex-PASI Sohaib Khan Personal # 1010727 of sub Division Bhetumi, while posted at PS Cantt: Bannu, show cause notice was issued on the basis of commission of the following misconduct vide your good office No.11-12/PA under Rule 5(3) of the Khyber pakhtunkhwa police Lule 1975:-.

That he registered FIR No.889, dated 27.09.2023 u/s 15AA PS Cantt: Bannu with malafide intention by cultivating relations with the accused party to favor them in the criminal case vide FIR No.718, dated 30.09.2023 u/s 324/427/109/114/34PPC PS Town Ship

In this regard, an enquiry conducted through SP/Inv: Bannu, who submit his report vide letter No.204/Inv: dated 16.01.2024. As per n port of SP/Inv: Bannu, the leveled of allegations as mentioned above has been proved. Furthermore, reply of show cause notice was found unsatisfactory, resultantly the delinquent officer was dismissed from service vide order Endst: No.814-15/EC, dated 16.02.2024 later on dismissed officer preferred mercy petition to your good self, which was marked to the undersigned for the purpose of De-novo enquiry.

As per your kind directions, the undersigned probe into the allegations. During the enquiry proceeding, Ex-PASI Schaib Khan was called upon, appeared and recorded his statement, wherein, he stated that on eventful day, I was on routine patrolling duty. I received call from SHO, Raza Khan with the direction to contact with PASI Sife. Khan and facilitate him. As per direction of SHO PS Cantt: I communicated and rushed to the shot. At a few distances, two persons duly armed were arrested and FIRs has been registered under Arms Act. During cross-examination, he disclosed that Sifut Khan PASI have the subject information as I was completely unknown / having no knowledge about it. Statement is attached at F/A.

SHO Ruza Khan PS Township (the then SHO PS Cantt) was summoned and record his statement, wherein he stated that on the day of occurrence, Sifut Khan PASI informed me about the persons duly armed in the area of Sokari Zabta Khin. I made contact with PASI Sohaib Khan to facilitate PASI Sifut Khan and also directed to be careful. After that two persons duly armed with kalashinkove and repeator 12 bore and FIRs has been registered. According to my information, Sohaib Khan is intocent as he has performed his obligatory duty and obeys my order. Statement is attached at F/R.


Zabia Khan was summoned, wherein he disclosed that we have bloomerable among which complainant of Case FIR No.718, dated 30.09.2023 u/s 324/427/109 11-32 PF he had killed my brother and abandoned/ gave up residing from here. Constant some relation with me and know that I have enmity with complainant Ghidan: a amount 7 lucs were paid. As per pre-planning, we were arrested and sent to Central further stated that we have only paid total amount of Table rupees to constant arrangement of assassin/ a hire killer was the responsibility of Constable Shuis attached at F/C.

FINDINGS:-

After perusal of record available in hand, recorded statements and her received to the undersigned reached to the conclusion that on the day of occurrence, So-(then PASI PS Cantt) was on routine gusht duty, received call and was directed to cost Khan PASI and facilitate him. As per directions received from SHO PS Cantt: PASI Solucommunicated with PASI Sifat and rushed to the spot along with Sifat Khan PASI and two persons duly armed with Kalshinkoeve and repeator. Proper case vide FIRs NO.58 have been registered against them and were sent to Central Jail Bannu. It was provedstatement of accused Israr Khan that it was an arranged plan of Constable Shuhab , who received Seven lac rupee as taking responsibility to arrange assassing hire killer for the complainant Ghulam Razaq. As per information, the arrest of accused, sending to con-Bannu and then attempt of murder of complainant Ghulam Razaq was pre-planning of the Shuhab. The undersigned, agree with the remarks passed by SP/Inv: Bannu in the late above that the cases vide FIRs Mo.888 & 889 has been registered with malatale attacultivating relations with the accessed party to favor them in the criminal case in the part. Sitat instead of Sohaib Khan, Ex-PASI Sohaib Khan (the then PASI PS Cumus is abinnocence. He just performed his obligatory duty within the orbit of law having no lation the abve arranged plan. During enquiry proceedings, no cogeni reason was observed with to stand /prove the allegations against Sohaib Khan (the then PASI PS Cantr). Submitted for further order please.

ORDER

This order is hereby passed to dispose of Revision Petition under Rule 11-A of Khyber Pakhumkhwa Police Rule-1975 (amended 2014) submitted by Ex-ASI Sifat Ullah No. 286/B (hereinafter referred to as petitioner).

He was issued Show Carise Notice by RPO Bangu on the allegations that he registered FIR No. 888, dated 27.09.2023 u/s 15-AA PS Cantt: Bangu with malafide intention by cultivating relations with the accreted party to favour them in the criminal case FIR No. 718, dated 30.09.2023 u/s 324/427/109/114/34 PPC PS Township Bannu.

RPO/Bannu also heard the appellant in OR. His written reply to the Show Cause Notice was found unsatisfactory. He was awarded major punishment of dismissal from service vide order Endst: No. 816 17/1-1, dated 16.02.2024.

A meeting of Appellate Board was held on 10.05.2024 in CPO under the chairmanship of DiG Hendquarters. Ex-ASI Sifat Ullah was present.

The petitioner was heard in person.
