
Respected Madam,



Prayer in appeal:-

On acceptance of this appeal, both the impugned seniority list of Forester Forests Department District Orakzai dated 08/05/2024 & 29/05/2024 issued by respondent No 3 may kindly be set aside and correct/clarified seniority list may please be issued and the appellant be placed senior then respondent No 4 in accordance with law to meet the ends of justice.

Respectfully Sheweth:-

1. That the appellant upon the recommendation of Departmental Selection Committee alongwith other candidates appointed as stipendiary Forester (BPS-06) against the scheme Afforestation in Orakzai District the then Agency under the ADP/SDP vide Office Order No 16 dated 22/09/1990 of respondent No 4, later on the basic pay scale has been upgraded from BPS-6 to BPS-10 since his appointment he was performing his duties with full devotion and honesty and rendered about 33 years unblemished service to the department. (Copies of appointment order, arrival report & service book are attached as annexure "A")
2. That respondent No 3 was appointed as Forester in BPS-07 under the scheme titled Watershed Management in Orakzai Agency vide Office Order No 32 dated 06/12/1994 of

respondent No 3 (Copy of appointment order is attached as annexure "B")

3. That due to project/scheme employee, the services of the appellant alongwith others were terminated and later on restored, but lastly on the decision of this Honourable Tribunal the services of development staff were converted to normal budget vide Office Order No 3509-11 dated 14/01/2003 of respondent No 2 and their appeals were allowed and they are entitled for the pay for the break period on the ground that there should be no break in their service. Therefore, in the light of said decision, the appellant and others are entitled to be granted seniority with retrospective effect both in service and pay. (Copy of Order No 3509-11 dated 14/01/2003 is attached as annexure "C").
4. That the respondents issued tentative seniority lists of Foresters in respect of FATA Circle dated 30/04/2018 whereby appellant was placed at Serial No 23 & respondent No 4 was shown at Serial No 43 in the whole FATA seniority list, against the same the respondent No 4 has not been submitted any objection or appeal. (Copy of seniority list dated 30/04/2018 is attached as annexure "D").
5. That the respondent No 3 issued seniority list of Forester in respect of Orakzai Forest Division Hangu dated 31/03/2020,

30/06/2020, 30/09/2022, 31/10/2023, 30/11/2023 & 31/03/2024, whereby the appellant was shown and placed as senior then respondent No 4, against the above seniority lists, no objection or appeal has been filed by the respondent No 5. (Copies of seniority lists are attached as annexure "E")

6. That the meeting of Departmental Promotion Committee (DPC) was held on 03/05/2024 for promotion of Forester to the post of Deputy Ranger, the appellant being senior consider for promotion, but later on the respondent No 3 issued the impugned seniority list dated 08/05/2024, whereby the appellant was placed/shown junior then respondent No 4, due to which the promotion process to the extent of appellant was deferred/postponed, despite the fact that other colleagues of the appellant were promoted to the post of Deputy Ranger. (Copies of impugned seniority list dated 08/05/2024 & promotion order dated 14/05/2024 of other colleagues of appellant are attached as annexure "F" & "G").
7. That the appellant is aggrieved from the impugned seniority list dated 08/05/2024, filed departmental appeal to the respondent No 2 on 09/05/2024, after appeal, the impugned seniority list dated 29/05/2024 has been issued by the respondent No 3 and maintained the previous position of the

appellant. (Copies of departmental appeal and impugned seniority list dated 29/05/2024 are attached as annexure "H" & "I").

8. That the appellant is highly aggrieved from both the impugned seniority list dated 08/05/2024 and after appeal impugned seniority list 29/05/2024 issued by respondent No 3, filed the instant Service Appeal inter alia on the following grounds:-

Grounds:-

- A. That both the impugned seniority lists dated 08/05/2024 & 29/05/2024 issued by respondent No 3 in respect of Forester of District Orakzai is illegal, unlawful, and against law, because no tentative seniority list has been issued by the respondent No 3 for objection nor the respondents provide opportunity for objection on the seniority, hence needs clarification.
- B. That the appellant was appointed on 22/09/1990 while respondent No 4, was appointed on 06/12/1994 under development scheme and later on adjusted to normal SNE post, on 01/07/2000, the previous service of the appellant alongwith other development scheme employee were counted to pay, pension, seniority and other benefits in light of decision of this Honourable Tribunal in Service Appeal No 1147/2000 titled as 'Syed Tasdiq Hussain...Versus....DFO

FATA-II, Forest Division Hangu dated 23/12/2002 in this respect the respondent No 2 issued a letter/circular to all DFOs (FATA) in South FATA Circle vide Office Order No 3509-11 dated 14/01/2003 already annexed as annexure "C" with this appeal, thus in the above facts and circumstances, the appellant is senior then respondent No 5, hence the impugned seniority lists dated 08/05/2024 & 29/05/2024 needs to be clarified.

- C. That the appellant is senior in the light of the above facts then respondent No 4, the respondent No 3 are under obligation to prepared the correct and clarified seniority list of Forester in respect of District Orakzai for the promotion of Deputy Ranger Forest.*
- D. That the impugned seniority list is violation of Section 24-A of the General Clauses Act as the competent authority has failed to cite any reason or justification in the said seniority list.*
- E. That each and every citizen of Pakistan shall be treated equally under Articles 4, 8 & 25 of the Constitution of Islamic Republic of Pakistan, 1973.*
- F. That fundamental rights of the appellant has blatantly violated by the respondents and the appellant has been*

discriminated and has been denied his due right which is protected by the Constitution of Islamic Republic of Pakistan, 1973.


- G. *That the instant appeal is within time and this Honourable Tribunal has the jurisdiction to entertain the instant Service Appeal.*
- H. *That any other grounds will be raised at the time of arguments with the prior permission of this Honourable Tribunal.*


3. *That on the face of it, the applicant/ appellant has got strong arguable case and is sanguine about its success.*
