
IMPLEMENTATION REPORT

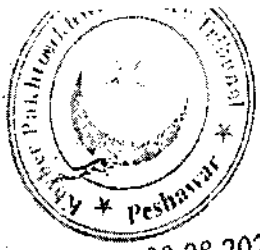
Respondent No. 06 Submit as under:
