

Respectfully Sheweth;

1. That appellant was initially appointed / recruited as Probationer Assistant Sub-Inspector on 01-04-2010 with his colleagues on the recommendation of Public Service Commission dated 17-12-2009. (Copy as annex "A")
2. That on 16-04-2014, appellant was promoted to the rank of Officiating Sub-Inspector and was confirmed as such on 16-04-2016 with his colleagues. His name was brought on List "F" on 24-08-2021.

3. That on 24-01-2024, R. No. 01 issued seniority list wherein name of appellant was placed at S. No. 185 instead of his colleagues at S. No. 136-149. (Copy as annex "B")
4. That on one hand, seniority position was disputed, while on the other hand, juniors were promoted to the rank of Officiating Inspectors B-16 vide order dated 25-01-2024. (Copy as annex "C")
5. That in former seniority lists, appellant was shown senior as is evident from the same.
6. That on 21-02-2024, appellant submitted representation before R. No. 01 for correction of the seniority list and to place his name with his colleagues but in vain. (Copy as annex "D")

Hence this appeal, Inter Alia, on the following grounds:-

GROUND S

- a. That appellant was appointed with his colleagues, he was confirmed with his colleagues. His name was brought in the former seniority lists with his colleagues but in the impugned seniority list, it was not known as to why his name was placed much below than with his colleagues.
- b. That as and when already allocated seniority position the same cannot be changed without giving notice for the purpose by giving reason of the changed.
- c. That the impugned seniority list was not properly framed and junior was shown senior to him.
- d. That appellant was confirmed as Sub-Inspector with his colleagues on 16-04-2016, his name was brought on list "F" with his colleagues on 24-08-2021 but astonishingly why his name was placed at S. No. 185 instead of with his colleagues at S. No. 136-149.

- e. That the impugned seniority list dated 24-01-2024 was not mandated as per law and rules and was not finalized properly. Juniors were made senior, while seniors as juniors. The same is based on favoritism and not per law.

It is, therefore, most humbly prayed that on acceptance of the appeal, that the impugned seniority list dated 24-01-2024 of R. No. 01 be set aside / modified / altered and name of appellant be placed with his colleagues at S. No. 136-149 with all service benefits, with further request to promote appellant to the rank of Officiating Inspector B-16 from the promotion date of colleagues, such other relief as may be deemed proper.

Note: In compliance with Order Sheet of Hon'ble Supreme Court of Pakistan dated 26.01.2023 in suo moto Contempt proceedings vide Cr.O. Petition No. 38/2021 against Chief Secretary Khyber Pakhtunkhwa and Inspector General of Police Khyber Pakhtunkhwa initiated for not having carried out demotions of Police Officers of Khyber Pakhtunkhwa Police in Out of Turn Promotions cases, Khyber Pakhtunkhwa Police issued Demotions/Repatriations Orders in respect of Police Officers/Officials falling under Out of Turn categories. In response to such demotion/repatriation Orders, the affected Police officers/officials sought relief from Peshawar High Court by filing different Writ Petitions against their demotion/repatriation Orders issued by Khyber Pakhtunkhwa Police as Out of Turn Promotion beneficiaries. The Peshawar High Court suspended such demotions Orders so issued in Out of Turn Promotion cases and granted relief to officers who were beneficiary of Cadetship Scheme, who got absorbed in KP Police from Other Provinces. Officials got absorbed from executive cadre to Telecommunication Cadre within KP Police through a consolidated judgment dated 29.08.2023 in Writ Petition No. 1587 -P/2022 titled "Shah Muntaz and Others Vs Govt of Khyber Pakhtunkhwa and Others". The Police Department Khyber Pakhtunkhwa has moved CPLAs in the Honorable Supreme Court of Pakistan. Therefore, the Officers who are beneficiary of Cadetship Scheme and the officers who got absorbed from other Provinces to KP Police are placed in the seniority list as per relief

Other Provinces to KP Police are placed in the seniority list as per relief already granted by Peshawar High Court in above mentioned judgment in Out of Turn Promotion cases subject to outcome of CPLAs which have already been instituted with Supreme Court of Pakistan against the judgment dated 29.08.2023 of Peshawar High Court.
