**SERVICE APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE FINAL SENORITY LIST ISSUED VIDE NOTIFICATION DATED 12.01.2021 OF CROP REPORTER, CROP REPORTING SERVICES, DEPARTMENT OF KHYBER PAKHTUNKHWA, IGNORING/ DEPRIVING THE 23 CROP REPORTERS DETACHED FROM AGRICULTURE EXTENSION DEPARTMENT FATA TO CROP REPORTING SERVICES DEPARTMENT OF KHYBER PAKHTUNKHWA.**

**Respectfully Sheweth;**

The Appellant humbly submits as under.


1. That the Appellant was employed on 16-01-83 as crop reporter in Agriculture Extension Department FATA and has been working since employment as crop reporter.
2. That the appellant along with other Crop Reporter were detached from Agriculture Extension Department to Crop Reporter Services Agriculture Department vide Office Order/ Letter No. 3059/DGA(NMAs) dated 22/07/2022 whereby Crop Reporters were relieved and detached from Agriculture Extension department (Tribal Districts) to the Office Crop Reporting Services (CRS) with effect from 30.06.2022. (Attached as annexure "A")
3. That after detachment of crop reporters affected the seniority of all the staff working under different districts of agriculture extension departments.
4. That Final Seniority List of Crop Reporter, Crop Reporting Services, Department of Khyber Pakhtunkhwa as stood on 12.01.2021 was notified/ Circulated which is not applicable on the petitioner and other 22 crop reporters detached from Agriculture Extension Department to Crop Reporting Services (CRS). (Attached as annexure "B")
5. That appellant time and again approached the Respondent No. 1 for issuance of proper seniority list to enable 23 crop reporters, from the merged districts to Crop Reporting Services Khyber Pakhtunkhwa, for promotion and other service and retirement benefits.
6. That the letter No. 506/ DG.CRS dated 15-01-2024 from Directorate General Crop Reporting Services Agriculture department is attached. (Annexure "C")
7. That the Seniority List dated 12.01.2021 is based on error and is an outcome of improper reckoning due to misreading of records. A blatant proof of erroneous reckoning of Seniority in the impugned list is that even those induced in the service much later than the petitioner are placed much above the appellant though all of them are much junior to the appellant.

- 8. That as per rule 17(2) of the KPK Civil Servant (Appointment, Promotion and Transfer) Rules, 1989, "Seniority in the various cadres of the Civil Servants appointment by initial recruitment vis a vis those appointed otherwise shall be determined with reference to their dates of regular appointment to a post in that cadre.
- 9. That according to section 8(4) of the KPK Civil Servant Act, 1973, "Seniority is the post service or cadre to which a civil servant is promoted shall take effect from date of regular (initial) appointment.
- 10. That the appellant is entitled for equal treatment as per Article-25 of the Constitution of Islamic Republic of Pakistan, 1973 and his seniority may be considered from the date of his initial appointment as per the dictum laid down by the superior Courts.
- 11. That the appellant being aggrieved of the final Seniority List preferred a departmental appeal/ Representation to Respondent No. 2 on 26.12 23 forwarded through proper channel to competent authority to entertain the same. (copy annexed as "D")

**GROUNDS**


- 1. That the appellant has not been provided equal treatment when there is no express inhibition against him under the law and has also not been given equal protection of law, which is discriminatory instance of arbitrariness and is against the principle enshrined in Article-4 and Article-25 of the Constitution of Islamic Republic of Pakistan.
- 2. That the appellant has been subjected to injustice and the case of appellant has not been dealt with under the principle of the fair play.
- 3. That the impugned seniority list is against the settle laws and rules of seniority in service and no legal footings hence ineffective upon the rights of the appellant.
- 4. That the impugned seniority list is in violation of rules and statutory provisions as well as dicta of superior courts pronounced in a number of judgements, hence the same needs to be corrected.
- 5. That this Hon'ble Tribunal is competent and has ample power to adjudge the matter under the appeal.
- 6. That the counsel for appellant may be allowed to argue additional grounds at the time of the argument.

It is, therefore, humbly prayed that on gracious acceptance of this service appeal, the impugned Seniority List may be set aside and respondent No. 2 may please be directed for issuance of proper seniority list to enable to appellant to be placed at proper cadre and also to enable appellant for other service/ retirement benefits in accordance with seniority rules as envisaged in Estta Code and Civil Service Regulations.

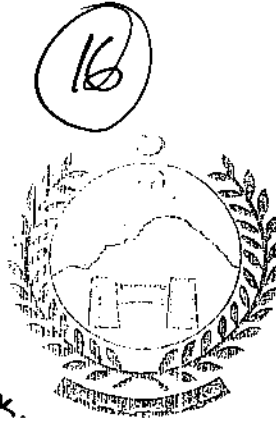


