

Respectfully Sheweth;

Appellant humbly submits and request as under:-

- 1) That appellant was inducted into service on 26/12/2019 as Junior Clerk BPS-11 vide officer Order No. 619-24 and served at DDHO Office Jandola District Tank and made arrival report on 01/01/2020 after observing all the codel formalities. Copies of appointment, medical, service book are annexed as Annexure-A.
- 2) That appellant served in challenging areas of the district Tank, demonstrating his commitment to the Health department's mission and goals.
- 3) That the appellant was transferred to Deputy District Health Officer Darazinda by Director General Health Services Khyber Pakhtunkhwa vide Office Order bearing No. 2633-36/ Personnel, Dated 18/04/2023 (Annexure-B).
- 4) That the appellant was relieved by the then DDHO SD Jandola vide Office Order No. 106, Dated 19/04/2023, the appellant has made arrival there which was acknowledged by DDHO SD Darazinda vide Letter No. 206-09, Dated 20/04/2023 (Annexure-C).
- 5) That the appellant has performed regular duties there but due to technical issues, i.e. non availability of post, my salary was not actualized.
- 6) That later on, transfer order to DDHO SD Darazinda was cancelled by Director General Health Services Khyber Pakhtunkhwa vide Office Order No. 4634-37/ Personnel, Dated 31/08/2023 (Annexure-D).
- 7) That the DDHO SD Darazinda has relieved me vide Office Order No. 685/Admin/DDHO/Darazinda, Dated 31/08/2023 (Annexure E).
- 8) That appellant join duty at DDHO SD Jandola on 01/09/2023.
- 9) That the DDHO SD Darazinda has also granted the appellant Duty Performance Certificate vide Letter No. 686/Admin/DDHO/Darazinda, Dated 31/08/2023 (Annexure-F).

- 10) That meanwhile during the period of appellant's transfer one Junior Clerk (private respondent) has been appointed at DDHO office SD Jandola in my place.
- 11) That the respected Director General Health Services Khyber Pakhtunkhwa has issued letter for appellant's adjustment against the vacant post of Junior Clerk, vacated due to the promotion of Mr. Munir Khan, Junior Clerk vide Letter No. 2370/Personnel, Dated 21/09/2023 in which appellant was also assigned the duty of Accountant of DDHO Office SD Jandola (Annexure-G).
- 12) That in compliance, District Health Officer Tank has Issued Office Order vide No. 3083-88/E-2 Dated 25/09/2023 and detailed appellant as Accountant of DDHO Office SD Jandola (Annexure-H).
- 13) That the DHO Tank has also wrote letter vide No. 3089 Dated 25/09/2023 to DAO Tank for adjustment and release of appellant's salaries as well as appellant's authority as Accountant (Annexure-I).
- 14) That DHO Tank has directed DDHO SD Jandola to hand over the charge of Accountants to appellant vide Letter No. 3090, Dated 25/09/2023 (Annexure J).
- 15) That the District Health Officer Tank appointed another Junior Clerk against the said post of the Junior Clerk which was vacated by Mr. Munir Khan also was promoted as Senior Clerk vide No.2965/70 dated 15/09/2023 (Annexure K).
- 16) That the Director General Health Services Khyber Pakhtunkhwa has again withdrawn mentioned letter vide Office Order No.5167-70/Personnel, Dated 28/09/2023 regarding appellant's adjustment on vacant post of Junior Clerk (Annexure L).
- 17) That later on, appellant's transfer from DDHO Darazinda to DDHO SD Jandola was cancelled vide Office Order No.871-77/Personnel, Dated 22/01/2024 (Annexure M).
- 18) That in compliance, appellant has reported to District Health Officer DIKhan, who didn't accept appellant's arrival and wrote letter to Director General Health Services Khyber Pakhtunkhwa

vide No. 1636-38/E-9, Dated 26/02/2024 regarding non availability of vacant post of Junior Clerk (**Annexure N**).

19) That thereafter the appellant preferred a departmental appeal to the respondent #1 but the same is not decided within stipulated period. Copy of departmental appeal is annexed as **Annexure-O**.

20) That feeling aggrieved by the impugned orders of the respondents the appellant submits the instant appeal, inter alia, the following grounds.

Ground:-

- i. That the Impugned orders worthy Director Health Services Khyber Pakhtunkhwa are pre-mature, illegal, against service laws and policy, hence, liable to be cancelled.
- ii. That appellant always served in challenging areas of the district Tank and Dera Ismail Khan, demonstrating his commitment to the health department's mission and goals but unfortunately the authorities transferred him and made him rolling stone upon the directions of political God fathers, hence, the impugned orders are liable to be set aside being political victimization.
- iii. That the impugned orders violate the rights of appellant as an employee and undermine the principles of fairness and impartiality. Hence, the same is not tenable in the eye of law.
- iv. That one Amin Ullah is appointed as Junior Clerk vide Office Order No: 2965-70 dated 15/09/2023.
- v. That the appellant was previously transferred from SD Jandola to SD Darazinda on 18/04/2023. Upon arrival at SD Darazinda, the District Accounts Officer raised concerns about the absence of a designated Junior Clerk position in SD Jandola. Following this observation, I submitted several requests to higher authorities, and consequently, the transfer order was withdrawn.
- vi. That the appellant deeply concerned about the recent re-issuance of appellant's transfer order to SD Jandola, particularly considering the previous resolution and the lack of a designated

Junior Clerk position there. This transfer would cause undue hardship and disruption to appellant's work and personal life.

- vii. That the counsel for appellant may kindly be allowed to raise additional grounds at the time of arguments.

It is therefore, humbly prayed that on acceptance of this Service Appeal the Order No. 2633-36 dated 18/04/2023 as well as appointment order No. 2965-70 dated 15/09/2023 of private respondent (Amin Ullah) may kindly be set aside and the respondents may kindly be directed to act upon the order no. 4634-37 dated 31/08/2023, the appellant may kindly be retransfer for the post of Junior Clerk at DDHO Office, Sub Division Jandola District Tank.





4. That if the salaries of appellant is stopped and interim relief is not granted to the Appellant then Appellant will suffer irreparable loss and his writ petition will become in fractious.



10. Respected Director General Health Services Khyber Pakhtunkhwa has issued letter for my adjustment against the vacant post of Junior Clerk, vacated due to the

- promotion of Mr. Munir Khan, Junior Clerk vide Letter No. 2370/Personnel, Dated 21/09/2023 in which I was also assigned the duty of Accountant, DDHO Office SD Jandola (Annexure-G).
11. In compliance, District Health Officer Tank has issued Office Order vide No. 3083-88/E-2 Dated 25/09/2023 and detailed me as Accountant of DDHO Office SD Jandola (Annexure-H).
12. Moreover DHO Tank has also wrote letter vide No. 3089 Dated 25/09/2023 to DAO Tank for adjustment and release of my salaries as well as my authority as Accountant (Annexure-I).
13. DHO Tank has directed DDHO SD Jandola to hand over the charge of Accounts to me vide Letter No. 3090, Dated 25/09/2023 (Annexure-J).
14. The District Health Officer Tank appointed another Junior Clerk against the said post of the Junior Clerk which was Vacated by Mr. Munir Khan who was promoted as Senior Clerk vide No. 2965-70/ dated: 15/09/2023 (Annexure-K).
15. Director General Health Services Khyber Pakhtunkhwa has again withdrawn mentioned letter vide Office Order No. 5167-70/Personnel, Dated 28/09/2023 regarding my adjustment on vacant post of Junior Clerk (Annexure-L).
16. Later on, my transfer from DDHO Darazinda to DDHO SD Jandola was cancelled vide Office Order No. 871-77/Personnel Dated 22/01/2024 (Annexure-M).
17. In compliance, I have reported to District Health Officer DI Khan, who didn't accept my arrival and wrote letter to Director General Health Services Khyber Pakhtunkhwa vide No. 1636-38/E-9, Dated 26/02/2024 regarding non availability of vacant post of Junior Clerk (Annexure-N).

I have an average family background, moreover I am a disabled person, I have suffered psychologically as well as due to multiple times transfers/postings and salaries issues, i am in severe financial crisis. 

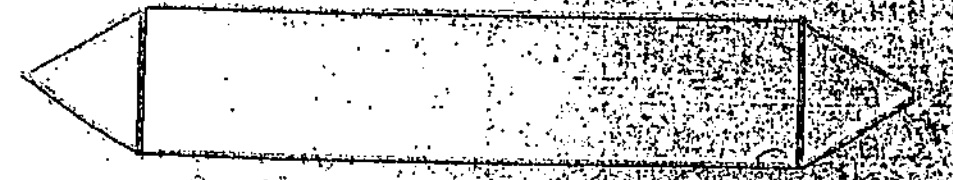
