

APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION / ORDER DATED 05.03.2024 WHEREBY THE APPELLANT HAS BEEN TRANSFER FROM THE POST OF ADEO HARIPUR TO SST GOVERNMENT HIGH SCHOOL HALI.

Prayer:

On acceptance of instant appeal the impugned order dated 05.03.2024 may please be set aside by transferring appellant to Government High School Karwala as SST or to his previous position as ADEO (M) Haripur.

Respectfully Sheweth,

1. That the appellant was appointed as DM against the vacant post vide Endst: No. 13109-16/DM/NTS dated 05.11.2014 and was promoted as SST vide Endst: No. 2927-32/File No.1 / promotion dated 08.12.2020. (Copy of appointment letter and notification dated 08.12.2020 are attached as Annexure A & B)

2. That the appellant performed his duties mostly in the backward/faraway/hilly areas and during entire period of service appellant performed his duties up to his utmost abilities and had never given any chance of complaint to his high ups or to the general public community.
3. That on 14-04-2023 Vide notification No. 2751-57/F.NO 22-26/EB/Transfer appellant was transferred to Government High School Karwala as SST, then after three months only the appellant was again transferred to the post of ADEO (Estab: M) Secondary Haripur on dated 30-07-2023. (Copy of notifications are attached as Annexure C & D).
4. That after 07 months vide notification No. 6168-72H-1/ADEOs dated 05-03-2024 the appellant was again transferred to Government High School Halli Haripur as SST which is also very faraway/hilly area. (Copy of notification is attached as Annexure E).
5. That the appellant submitted a Departmental Appeal before the Appellate Authority dated 06-03-2024 by which plea of appellant was admitted to some extent and notifications ~~30-5-2024 & 13-6-24~~ were issued however, proper remedy was not granted to the appellant till filing of this appeal before Honorable Service Tribunal. (Copy of departmental appeal along with notifications are respectively Annexure F, G & H).
6. That there is no other adequate/ efficacious remedy available and this Honorable Service Tribunal being a proper forum for the appellant, so is hereby submitting the instant appeal inter-alia on the following.


GROUND S :

- a) That the order dated 05-03-2024 is illegal, unlawful, without having lawful authority without jurisdiction and being based on malafide intentions of the respondent (department). Hence, liable to set aside.
- b) That prior to the impugned order dated 30-07-2024, the appellant was appointed as ADEO(Male) Haripur till the arrival of Management Cadre person but vide impugned order the person appointed on the said post is also not from management cadre, which shows the malafide on part of respondent.
- c) That transferred order is illegal, is based on malafide political victimization, nepotism hence, liable to be set aside.



- d) That during last passed year appellant was transferred for number of times to different stations which is sheer violation of basic fundamental rights and departmental rules.
- e) That the order of transfer of appellant is against the basic law that no one should be condemned unheard, hence, liable to be set-aside.
- f) That the appellant has never been given any chance to produce his stance in the above noted matter.
- g) That appellant is the only male member of his family whose father is paralyzed and his entire family is fully dependent upon him. (Copies of medical record are Annexure I).

It is, therefore, humbly prayed that On acceptance of instant appeal the impugned order dated 05-03-2024 may please be set aside by transferring appellant to Government High School Karwala as SST or to his previous position as ADEO (M) Haripur any other relief deemed fit and which this has not been prayed may also be granted to the appellant very graciously.


10. He will be governed by the such rules and regulations as may be issued from time to time by the Govt.
