CREATION OF 05 SUPERNUMERARY POSTS OF SUBEDAR BPS-14 IN DIR UPPER LEVY (PROVINCIAL)


The Government of Khyber Pakhtunkhwa Finance Department has advised the Home & Tribal Affairs Department that a Summary be moved for the Hon'ble Chief Minister, Khyber Pakhtunkhwa for creation of 5 x Supernumerary posts of Subedar BPS-14 in Dir Upper Levy (Provincial) (Annex-I).


The background of the case is as under:

- (a) Mr. Shah Rafi Uddin, Subedar, BS-14; Mr. Lal Bahadar, Subedar, BS-14; Mr. Mahid Ullah, Subedar, BS-14; Mr. Zafar Khan, Subedar, BS-14; and, Mr. Shah Faisal, Subedar, BS-14 of Provincial Levy Force had been retired by Commandant Dir Levies / Deputy Commissioner, Dir Upper, separately, on 27.02.2019 and 12.11.2019;
- (b) Aggrieved with the Order of Commandant Dir Levies / Deputy Commissioner, Dir Upper, they instituted a Service Appeal No. 1026/2018 in the Service Tribunal, Khyber Pakhtunkhwa. Consequently, the Service Tribunal vide judgement in the said Service Appeal had reinstated these Subedars; the operative part of the judgement is reproduced below (Annex-II):

'[...] the instant appeals are accepted. The appellants as well as other similarly placed employees stand reinstated in service, who will retire on attaining the age of 60 years or they may opt for retirement after completion of 25 years regular service.'

- (c) In pursuance of the judgment of the Tribunal, the above 05 x Subedars, BS-14 were conditionally re-instated on 01.07.2022 (Annex-III) subject to the final decision of Supreme Court of Pakistan in the Civil Petition for Leave to Appeal (CPLA);
- (d) However, as a consequence of retirement order mentioned above, the 5 x posts of Subedar became vacant that were filled by promotions. And, now, no vacant post of Subedar, BS-14 is available to adjust the above mentioned 5 x Subedars, as per Service Tribunal judgement;
- (e) Owing to the non-availability of vacant posts of Subedar, BS-14 for the adjustment of the said Subedar, the the Commandant Dir Levies / Deputy Commissioner, Dir Upper has requested for creation of 05 x posts of Subedars, BS-14 in Dir Provincial Levy Force (Annex-IV);





(f) In the same vein, it is important to mention here that the Service Tribunal in the Execution Petition for the above mentioned Service Appeal has passed an order dated 05.09.2023 to the extent of creation of posts, which is reproduced ad verbatim et. seq (Annex-V):

"Respondents are directed, assign post. If post is not available then respondent are directed to create new post within fortnight positively and accept petitioner arrival on newly created post and submit arrival of the applicant as well order of creation on 20.09.2023,"

(g) Previously, on 28.09.2023, case for creation of the required posts along with financial implication was taken up with the Finance Department, Khyber Pakhtunkhwa (Annex-VI).

3-In the light of above, the following proposals are submitted for perusal and approval of Chief Minister, Khyber Pakhtunkhwa, please:

> (a) To allow creation of 05 x supernumerary posts of Subedars, BS-14 in ł Dir Upper Levies; and,

(b) To relax ban for the said creation in light of Finance Department's instructions dated 03.07.2024 (Annex-VII),

4-Proposals contained in para 3 ante are submitted for approval of Chief Minister, Khyber Pakhtunkhwa, please.


