

**APPEAL U/S 4 OF THE KHYBER
PAKHTUNKHWA SERVICE TRIBUNAL ACT
1974 AGAINST THE ORDER,
COMMUNICATED TO THE APPELLANT**

**VIDE LETTTER05-07-2024, WHEREBY
DEPARTMENTAL APPEAL OF THE
APPELLANT FILED AGAINST THE
SENIORITY LIST OF DECEMBER 2023,
HAS BEEN REGRETTEED.**

PRAYER:-

On acceptance of this appeal the impugned Order communicated to the appellant vide Letter dated 07-05-2024 and the Final Seniority List of Senior Secretaries of Local Govt. & Rural Development Department Mardan dated Nil issued in December 2023, to the extent of respondents No 4 to 6, may kindly be set aside and official respondents be directed to place the name of the appellant above the name of Abdul Wajid, with all back benefits including promotion.

Respectfully Submitted:-

1. That the appellant was appointed as Secretary Union Council on 30-04-1988, however his name was written as Shahid Ur Rehman S/O Muhammad Zafar Khan, which was subsequently corrected vide Corrigendum dated 05-05-1988. It is pertinent to mention that the appellant being high in merit while respondent No 4 to 6 were low in merit than the appellant. (Copies of Orders are enclosed as annexure A)
2. That initially Tentative Seniority List of Secretaries, Union Council was issued on 17-09-1989, wherein the appellant was placed at Serial No 34 while the stated Qasim Khan

was placed at Serial No ~~30~~²⁹ and his other colleagues namely Ijaz Ahmad was placed at Serial No 36 and Muntazir Shah was placed at Serial No 40. Similarly on 04-03-2015, Final Seniority List of Secretaries, of District Mardan was issued wherein, the stated Ijaz Ahmad and Qasim Khan were placed senior to the appellant while the mentioned Muntazir Shah was placed junior to the appellant. It is pertinent to mention that the date of appointment of the stated Ijaz Ahmad was incorrectly mentioned as 08-05-1986 which in fact is 30-04-1988. Another Final Seniority List was issued in the year 2015, wherein again the date of appointment of stated Ijaz Ahmad was mentioned as 08-05-1986 instead of 30-04-1988, thus placed senior to the appellant, similarly the stated Qasim Khan was also placed senior to the appellant while the mentioned Muntazir Shah was placed senior to the appellant. **(Copies of Seniority Lists are enclosed as Annexure B, C & D)**

3. That since appointment the issue of Seniority List has been the bone of contention and dispute. Appeals were filed against the Seniority List and finally respondent No 1, issued Circular dated 24-10-2022 for information and compliance to all concerned with directions that the Seniority Lists be prepared on the basis of merit. Similarly on appeal of two Village Secretaries, it was decided that the Seniority List of Village/Neighborhood Councils, Secretary, shall be in the order of merit vide Order dated 15-11-2022. **(Copy of Circular dated 24-10-2022 & Order dated 15-11-2022 are enclosed as Annexure E & F)**

4. That strangely Final Seniority List dated 23-03-2023 of Senior Secretaries (BPS 11) of District Mardan was prepared in violation of Circular dated 24-10-2022 besides in violation of Rule 17 (1) of the KP Civil Servants (Appointment, Promotion and Appointment), Rules 1989, and illegally the stated Qasim Khan, Ijaz Ahmad & Muntazir Shah were placed senior to the appellant and in December 2023 another Final Seniority List of Senior Secretaries of District Mardan was issued in December 2023, wherein again the stated Ijaz Ahmad & Muntazir Shah were placed senior to the appellant. **(Copy of Final Seniority List dated 23-03-2023 & Final Seniority List of December 2023 is enclosed as Annexure G & H)**

5. That objections were raised over the Seniority List and a Committee was constituted with mandate to address the objections vide Notification dated 18-12-2023. **(Copy of Notification dated 18-12-2023 is enclosed as Annexure I)**

6. That strangely respondent No 4 was promoted as Supervisor (BPS-14) vide Office Order dated 24-04-2024 while respondent No 5 was promoted on the recommendation of DPC meeting dated 14-03-2024, as Supervisor (BPS-14) vide Office Order dated 23-07-2024. **(Copy of Office Order dated 24-04-2024 & Office Order dated 23-07-2024 is enclosed as Annexure J & K)**

7. That the appellant submitted objections against the Seniority List on 22-05-2024 and the meeting of the committee for the purpose was held on 12-06-2024, the

committee unanimously decided that the Seniority List has been prepared on the basis of age the seniority list has been issued 15 years ago but no objection was raised and that the appellant as such is rejected being time barred vide its minutes dated 12-06-2024 which was issued vide Letter dated 05-07-2024. (Copy of Appeal 22-05-2024, minutes of Committee dated 12-06-2024 & Letter dated 05-07-2024 are enclosed as Annexure L M & N)

8. That after promoting blue eyed ones who were junior to the appellant, updated Tentative Seniority List of Village Secretaries was issued on the basis of merit vide Office Order dated 09-07-2024. (Copy of Office Order dated 09-07-2024 and Tentative Seniority List is enclosed as annexure D)

9. Copy of Judgement date 25-3-2024 as annexure P.

10. That the impugned Order communicated to the appellant vide Letter dated 05-07-2024 and Seniority List dated Nil issued in December 2023, is s against the law, facts and principles of justice on grounds inter-alia as follows:-

GROUND S:

A. That impugned Order communicated to the appellant vide Letter dated 05-07-2024 and Seniority List dated Nil issued in December 2023, are illegal, unconstitutional, and unlawful, without lawful authority and of no legal effect, therefore need the interference of this honorable Court.

B. That the appellant is denied treatment in accordance with law and rules which being his fundamental right

as per Article 4, 10-A and 25 of the Constitution and law of the land.

C. That the appellant and respondents No 4 to 6 were appointed vide the same order and the appellant being high in merit was placed at Serial No 21 while respondents No 4 to 6 being low in merit were placed at Serial No 23, 25 and 27 of the appointment Order, hence, the appellant was required to have been placed senior to respondents No 4 to 6.

D. That Section 8 of the Civil Servants Act, 1973 as well as KP Civil Servants (Appointment, Promotion and Transfer) Rules are very much clear on the point according to which seniority is to determine in the order of merit.

E. That the impugned rejection Order and the impugned Seniority List are also in violation of the Circular dated 24-10-2022 issued by respondent No 1 and Order dated 15-11-2022, hence liable to be set at naught.

F. That it is also worth to mention that in the Seniority List the date of appointment of respondent No 5 was also mentioned incorrect for reasons best known to them and which smacks malice.

G. That the malice is verily floating on surface of record, as after promoting nears and dears, again the official respondents directed for determining the seniority on the basis of merit assigned by the DPC, which is

sufficient to prove that the impugned Order and Seniority are not in accordance with law and rules.

H. That even exactly in the same case, this honorable Tribunal has held that Seniority is to be determined on the basis of merit rendered in Service Appeal No 1645/2023 vide Judgment dated 25-03-2024. (Copy of Judgment dated 25-03-2024 is enclosed as Annexure p)

I. That it is worth to mention that on the basis of illegal Seniority Lists, private respondents have been promoted as Supervisors depriving the appellant of his due right of promotion.

J. That since seniority being recurring cause of action and issuing fresh Seniority List gives fresh cause of action, hence too the impugned Order and Seniority List is liable to set aside.

K. That the appellant has been deprived of due seniority in violation of Article 10-A of the Constitution, in violation of the principles of natural justice besides providing him any opportunity of hearing.

L. That there is no omission and commission on part of the appellant and the appellant could not be punished for the fault of others if any.

M. That the appellant seeks the permission of this honorable Tribunal for further/additional grounds at the time of arguments.

It is therefore prayed that Service Appeal of the appellant may kindly be accepted, as prayed for.

Any other relief not specifically asked for and deemed appropriate in the circumstances of the case, may also be granted in favor of the appellant.



Foregoing in view, it is circulated for information and compliance of all concerned that seniority list be formulated on the basis of merit irrespective of variation in the issuance of appointment orders.

The Comptent Authority has directed that the Appointment, Promotion and Transfer Rules, 1989 shall strictly be adhered to while formulating seniority lists and a compliance report as per the rules and instructions mentioned above be submitted to this office within a month period.



No. Director (LG) 3-1/Establishment/2022. The Appellate Authority i.e. Director General LG&RDD heard the appeal of Muhammad Waqar and Muhammad Akmal, Village Council Secretaries Haripur on 5th October, 2022 at 2:00 pm and the appellants were personally heard.

2. In the appeal the appellants have stated that:

- a. They were appointed as Village Council Secretaries in D/S-07 on 21.09.2015 and at that time there was no service structure of Senior/Junior Village Council Secretaries and their seniority at that time was according to date of birth and date of charge assumption and which was intact for four years and there were no objection of any VC/NC Secretary on the seniority list.
- b. They have objection over the final seniority list of Village/Neighborhood Council Secretaries issued vide letter No.AD(LG-11/1-15/VCs-NCs/2018/3928-32 dated 30-08-2019 which has been made as per the aggregate marks assigned by the District Selection and Recruitment Committee.
- c. Junior Village/Neighborhood Council Secretaries have been promoted on fake Seniority list in December, 2019.
- d. They have requested that the Seniority list may be revised and the promotion order of Junior VC/NC Secretaries made in December 2019 may be cancelled.

3. According to Section 17 (a) of the Appointment, Promotion & Transfer Rules 1989:

17. Seniority (a) the seniority inter se of civil servants (appointed to a service, cadre or post) shall be determined by in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission for as the case may be, the Departmental Selection Committee; provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection.

After examination of the record, personal hearing of the appellants, the appeal of the appellant is dismissed and the Assistant Director LG&RDD Haripur shall issue the seniority list of Village/Neighborhood Council Secretaries on the order of merit as per section 17 (1) (a) of the Appointment, Promotion & Transfer Rules 1989.



JUDGMENT

RASHIDA BANO, MEMBER (J): The instant service appeal has been instituted under section 4 of the Khyber Pakhtunkhwa Service Tribunal, Act 1974 with the prayer copied as below:

“On acceptance of this appeal, the respondent may kindly be directed to grant seniority to the appellant against the post of Village Secretary w.e.f 14.01.2016 with all consequential back benefits. Any other remedy which this Tribunal deems fit that may also be awarded in favour of appellant.

2. Brief facts of the case are that respondent department advertised posts of Secretary, Village/Neighbor Hood Council (BPS-07) and appellant being eligible applied for the same and after appearing in the written test, secured high marks, but despite better merit position, he was ignored. Feeling aggrieved, he filed writ petition No.589-P/2016 before Peshawar High Court, which was accepted vide judgment dated 21.02.2018. Respondents in compliance of judgment issued appointment order of the appellant on 31.07.2018, but with immediate effect and not from the date when his colleagues were appointed i.e. 14.01.2016. Feeling aggrieved, he filed departmental appeal which was not responded, hence the instant service appeal.

3. Respondents were put on notice, who submitted written replies/comments on the appeal. We have heard the learned counsel for the appellant as well as the learned Deputy District Attorney for the respondents and perused the case file with connected documents in detail.

4. Learned counsel for the appellant argued that the appellant has not been treated in accordance with law and rules and respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973. He further argued that inaction of the respondents by not granting seniority to the appellant w.e.f 14.01.2016 i.e. the date of appointment of other colleagues is against the law, facts, norms of natural justice and material on record hence not tenable and liable to be set aside; that the act of respondents by not granting seniority to the appellant at par with his colleagues is also against the spirit of judgment dated 16.10.2017.

5. Conversely, learned Deputy District Attorney contended that appellant has been treated in accordance with law and rules. He further contended that the appellant was appointed as per judgment of Peshawar High Court and there was

no mention of any back benefits including seniority etc hence appointment of the appellant was made with immediate effect.

6. Perusal of record reveals that respondent advertised certain posts of secretary village neighborhood/council in newspaper in-response of which appellant along with others applied for it, who appeared in test and secured high marks but appellant despite better merit position was ignored. Respondent department issued appointment orders of other candidates on 14.01.2016 by ignoring appellant. Appellant feeling aggrieved from inaction of the respondent by not appointing him despite being on top of the merit list, filed writ petition No.589-P/2016 before the Peshawar High Court, which was allowed vide order dated 21.02.2018. The private respondent in the ibid writ petition filed review petition No.56-P/2018 against the supra Judgment dated 21.02.2018 but same was dismissed in limine vide order dated 03.05.2018. The respondent department issued appointment order dated 31.07.2018 by implementing judgment of Peshawar High Court dated 21.02.2018, but same with immediate effect and not from the date when the other colleagues were issued appointment order dated 14.01.2016. Appellant feeling aggrieved and filed departmental appeal which was not responded.

7. Perusal of the worthy Peshawar high court dated 21/2/2018 reveals that appellant secured high marks than respondent no.5 of writ petition namely Safdar Ali Shah, therefore, respondents were directed to appoint appellant instead of safdar ali shah, who was appointed vide order dated 14.01.2016, having high merit position than said Safdar Ali Shah. Moreover other candidates of the process initiated as a consequence of advertisement of the respondent /department published in Daily newspaper, were appointed vide order dated 14/1/2016. Appellant was wrongly ignored by the respondent department and there was no fault on his part. In accordance with (Appointment, Promotion &

Transfer) Rules, seniority of a civil servant will have to be determined in accordance with Rule 17 Sub-Clause 1(a) which provide that

"17. Seniority :- (1) the seniority inter se of civil servants (appointed to a service, cadre or post) shall be determined:-

(a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission [or as the case may be, the Departmental Selection Committee;]

provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection;

8. The appellant had been initially appointed, therefore, the official respondents were bound to determine his seniority by following the provisions of section 8 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 and Rule 17 (1) (a) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, which, as the record reflects or/and the facts and circumstances brought before us, was never done. From every stretch of imagination, the appellant was selected in the same selection process having appeared in the examination and interviewed in response to the advertisement of 2015, wherein the other recommendees of merit list of said advertisement of 2015, therefore, under the above provisions of law and rules, his seniority had to be determined accordingly as the determination and fixation of seniority other than the above two provisions would be totally contrary to the law & rules as well as against this long and well settled principle and doing that would also be a self-designed novel introduction of determination of seniority on initial appointment. Such an exercise having no place in the law cannot sustain. We are fortified by the following pronouncements.

- i. **2002 SCMR 889 titled "Government of NWFP through Secretary Irrigation and 4 others", wherein the august Supreme Court of Pakistan was pleased to have observed**

that Appointments made as a result of selection in one combined competitive examination would be deemed to be belonging to the same batch and notwithstanding recommendation made by the Public Service Commission in parts, the seniority inter se, the appointees, of the same batch, would be determined in the light of merit assigned to them by the Public Service Commission.


ii. 2002 PLC(CS) 780 titled "Shafiq Ahmad and others versus the Registrar Lahore High Court and others" wherein it was found that the If the civil servants despite having been declared successful earlier by the Commission, were not appointed at relevant time they could not be made to suffer - Appointment and seniority were entirely two different things and delayed appointment of the civil servants could not affect their right to seniority in accordance with the rules."

iii. PLC 1993 (CS) 116 titled M. Tahir Rasheed Establishment Secretary Division, Islamabad and others, wherein the Federal Service Tribunal held that Inter se seniority of candidates at one selection was to be determined on the basis of merit assigned to the candidates by the Public Service Commission/Selection Committee in pursuance of general principles of seniority and not the dates of joining duty.

9. For what has been discussed above, we are unison to accept this appeal with direction to respondent to place appellant along with appointee of order dated 16.01.2016 in order of merit being selected of same selection process.

Costs shall follow the event. Consign.
