

ORDER DATED 08.04.2024 ISSUED BY  
RESPONDENT NO.2 MAY GRACIOUSLY BE  
ORDER TO SET ASIDE AND THE APPELLANT  
ADJUSTMENT POSTING ORDER DATED  
19.2.2024 AT GOVT GIRLS HIGH SECONDARY  
SCHOOL HAVELIAN ABBOTTABAD TO THE  
EXTENT OF THE APPELLANT MAY PLEASE  
BE RETAIN IN FAVOR OF THE APPELLANT  
ALONG WITH ALL BACK BENEFITS.

ANY OTHER RELIEF DEEMED  
APPROPRIATE IN THE CIRCUMSTANCES  
OF THE CASE NOT SPECIFICALLY ASKED  
FOR, MAY ALSO BE GRANTED TO THE  
APPELLANT.



Respectfully Sheweth.

1. That the appellant is the bonafide resident of district Abbottabad and was appointed in the respondent department since long time and after appointment performing her official duty with full devotion and hard work and no complaint whatsoever has been made against her.
2. That while the appellant was serving as a subject specialist economics at Govt girls High School Kakul Abbottabad she was promoted from BPS-17 to BPS-18 to the post of senior subject specialist economic vide order dated 8.11.2023,. (Copy of promotion order is attached as annexure "A").
3. That after promotion from BPS-17 to BPS-18 the respondent No.2 adjusted the appellant at Govt Girls High Secondary School Havilian Abbottabad on 19.2.2024 along with respondent no.4 who was also adjusted at the same station on the same post. (Copy of notification No.SO(S/F)/E&SED/4-16/2023/posting/ Transfer / BPS-17 to BS-18 dated 19.2.2024 is attached as annexure "B").
4. That the appellant on the very next day i.e 20.2.2024 submitted her arrival report to respondent No.3 but the charge of the said post against which the appellant was adjusted was not handed over to the appellant, as such the post was wrongly occupied by SS economics BS-

17 who was relieved on 28.3.2024 (Copy of arrival report dated 20.2.2024 is attached as annexure "C").

5. That the appellant submitted an application to respondent No.2 on 21.2.2024 for adjustment posting of appellant will within time against the vacant post of senior subject specialist economics BPS-18 at Govt Girls High Secondary School Havelian (Copy of application is attached as annexure "D").
6. That after submitting her arrival report the appellant perform her official duty regularly at Govt Girls High Secondary School Havelian w.e.f 20.2.2024 to 30.3.2024. (Copy of the duty certificate is attached as annexure "E").
7. That the respondent No.3 has illegally and unlawfully handed over the charge of post of senior subject specialist (Economics) to the respondent No.4 on 28.3.2024 on political influence. While the appellant submitted her arrival report on 20.02.2024 prior to the private respondent No.4 as well as the appellant perform her official duty w.e.f 20.02.2024 to 30.03.2024 at the Govt Girls High Secondary School Havelian Abbottabad.
8. That appellant approached to the office of respondent No.2 and requested to redress the grievances of appellant by adjusting the respondent No.4 to any other station the additional secretary elementary and secondary education Khyber Pakhtunkhwa directed the

section officer (Female) to readjust the respondent No.4 to any other school by retaining the appellant at Govt Girls High Secondary School Havelian. (Copy of letter is attached as annexure "F").

9. That the respondent No.2 issue impugned corrigendum posting transfer dated 8.4.2024 and place the service of the appellant at the disposal of the Directorate Elementary and Secondary Education KPK which was communicated to the appellant through whatsapp by Mr. Tayyab dealing assistant office of the section officer female on 24.4.2024 (Copy of impugned corrigendum posting transfer order dated 8.4.2024 is attached as annexure "G").
10. That the appellant filed departmental appeal / representation on 25.04.2024 against the corrigendum transfer order dated 8.4.2024 before the respondent NO.1 for redressal of her grievances which was not responded within statutory period of 90-days. (Copy of departmental appeal is attached as annexure "H").
11. That appellant file W.P No.490-A/2024 before the Hon'ble Peshawar High Court Abbottabad bench which was dispose of on 3.6.2024 on the ground of lack of jurisdiction. (Copy of W.P is attached as annexure "I").

12. That feeling aggrieved the Appellant prefers the instant service appeal before this Hon'ble Tribunal on the following grounds inter alia:-

**GRUNDS:-**

- A. That the appellant has not been treated in accordance with law and rules hence her rights secured and guaranteed under the constitution of 1973 were badly violated.
- B. That the impugned corrigendum transfer order dated 8.4.2024 is illegal, unlawful, unconstitutional and was passed on political victimization hence may be liable for setting aside.
- C. That the appellant was prematurely transfer before completion of her normal tenure while impugned transfer order dated 8.4.2024 which is violative of clause 1, IV and XIII of the transfer posting of Govt Khyber Pakhtunkhwa as the appellant was transferred prematurely from her current post.
- D. That the impugned corrigendum order dated 8.4.2024 issued by respondent No.2 placing the service of appellant at the disposal of directorate elementary and secondary education KPK is illegal, unlawful without lawful authority arbitrary, perverse, discriminatory, malafide, result of political influence and consequently of no legal effects upon the rights of the appellant.

- E. That the appellant was not treated by the respondents in accordance with law and rules on the subjected noted above and as such the respondents violated article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- F. That the treatment method out to the appellant is a clear violation of the fundamental rights of the appellant as enshrined in the constitution of Pakistan 1973.
- G. That there is no illegality on part of the appellant.
- H. That as such the appellant submitted her arrival report on 20.02.2024 prior to the private respondent No.4 and the appellant regularly perform her official duty w.e.f 20.02.2024 to 30.03.2024. That sole ground is enough for setting aside the impugned corrigendum transfer order dated 08.04.2024. It is pertinent to mentioned here that the appellant belongs to District Abbottabad while the Private respondent No.4 belongs to District Mansehra.
- I. That any other ground not raised here may graciously be allowed to be raised at the time of arguments on the instant service appeal.

*by accepting this appeal the impugned corrigendum transferred order dated 08.04.2024 issued by respondent no.2 may graciously be order to set aside and the appellant adjustment posting order dated 19.2.2024 at Govt. Girls High Secondary School Havelian Abbottabad to the extent of the appellant may please be retain in favor of the appellant along with all back benefits.*

*Any other relief not specifically asked for may also graciously be extended in favour of the Appellant in the circumstances of the case.*



GROUNDS:

3. Being local female candidate and permanent resident of District Abbottabad I deserved preferential treatment under the KPK Appointment, Deputation, Posting and Transfer Rules 2011. This entitles me to be adjusted first at GGHSS Havelian.
4. That in the light of the Principle of locus poenitentiae " first come first serve" appellant is entitled to retain in its own domiciled district first against her own post at GGHSS Havelian rather than other candidate having domicile of District Mansehra adjusted illegally in Abbottabad which is unlawful may kindly me cancelled in my favor.



JUDGMENT

IJAZ ANWAR. J. Through the instant petition under Article 199 of *The Constitution of Islamic Republic of Pakistan, 1973*, the petitioner has invoked the jurisdiction of this Court with the following prayer:-

*"Under the circumstances, it is respectfully prayed that on acceptance of the instant writ petition, the impugned*





*corrigendum order No. SO (S/F)  
E&SED/ 4-16/2023/ posting/  
transfer dated: 08.04.2024  
issued by respondent No.1 may  
graciously be ordered to be  
cancelled and the petitioner's  
adjustment/posting order dated:  
19.02.2024 at Govt. Girls  
Higher Secondary Scholl  
Havelian District, Abbottabad  
may please be retained and the  
respondents may kindly be  
directed to adjust the  
respondent No. 4 at any suitable  
post in her district of domicile  
in the interest of justice. "*

2. Facts of the case in brief are that after the promotion of petitioner as *Senior Subject Specialist (Economic)* BPS-18, she was adjusted at Government Girls Higher Secondary School Havelian vide notification dated: 19.02.2024 alongwith respondent No. 4, however, she was not allowed by the respondent No. 3 to assume the charge at the said school. Later-on vide corrigendum order dated: 08.04.2024, the services of the

petitioner were placed at the disposal of Directorate Elementary & Secondary Education, Khyber Pakhtunkhwa and later-on, salary of petitioner was also stopped. The petitioner being aggrieved of the said corrigendum order has filed a departmental appeal before respondent No. 2 (Chief Secretary Khyber Pakhtunkhwa) but in vain, hence, the instant constitutional petition.

3. Admittedly, the position and status of the petitioner is of a civil servant, thus, the grievance of the petitioner directly relates to the terms & conditions of her service, which is not amenable to the writ jurisdiction of this Court under Article 199 of *The Constitution of Islamic Republic of Pakistan, 1973 (The Constitution)*, in view of the bar contained in Article 212 of *The Constitution*. Reliance is placed on case titled '*Pir Muhammad Vs. Government of Baluchistan through Chief Secretary and others*' (2007 SCMR 54), thus, where, a civil servant is aggrieved of violation of any of the terms & conditions of his/her service, then

he/she can approach to the Service Tribunal for the redressal of his/her grievance but on no count he/she could agitate such issue before this Court.

4. For what has been discussed above, this petition is hereby dismissed, being not maintainable.
