PRELIMINARY OBJECTIONS:-

- 1. That the appeal is badly barred by law & limitation.
- That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- That the appellant has no cause of action and locus stand to file the instant appeal.
- 4. That the appellant has not come to this Honorable Tribunal with clean hands.
- 5. That the appellant is estopped due to his own conduct to file the instant Service Appeal.
- 6. That the appellant is trying to conceal the material facts from this Honorable Tribunal.

FACTS:-

- 1. Pertain to the appellant service record needs no comments.
- 2. Admitted as correct.
- 3. Incorrect. The appellant is found inefficient, irresponsible and a habitual absentee as perusal of his service record reveals that he was remained absent from lawful duty on different occasions for a long period of 66 days, which he was awarded different punishment i.e confinement to quarter guard, extra drill, and censure.(copy of previous punishment order attached herewith as annexure "A"). Besides , the appellant being a member of disciplined force involved himself in moral turpitude nature offence in the smuggling of heroin, for which he was arrested from the spot vide FIR No. 815, dated 24.05.2019 U/S 9-CNSA/15AA, Police Station MRS, District Kohat. (Copy of FIR attached herewith as annexure "B").
- 4. Incorrect. The appellant being involved in the above stated criminal case was proceeded against proper departmentally as he was placed under suspension and closed to line. He was issued Charge Sheet alongwith Summary of Allegations and DSP Zahoor Ud Din of FRP DI Khan Range was nominated as enquiry officer to conduct proper enquiry into the matter. The Charge Sheet was served upon him on 19.06.2019 in Central Jail Kohat through Jail Superintendent vide office memo No.966/FRP, dated 17.06.2019, but he failed to submit his reply within stipulated period of 07 days of its receipt. (Copy of office letter dated 17.06.2019 is attached as annexure "C"). After completion of enquiry, the enquiry officer submitted his finding report, wherein he reported that the appellant is found a drug peddler, having no

good reputation in the department vis-à-vis in the society. Upon the finding of enquiry officer, the appellant was served with Final Show Cause Notice to which he again failed to submit his reply within stipulated period. However, the enquiry file was again entrusted to the above named enquiry officer for further enquiry and report. In this regard, the enquiry officer reported that the Show Cause Notice was served upon him in person, but he deliberately failed to submit his reply despite the was already released on bail from the judicial lockup. The enquiry officer further reported that the appellant was also remained absent from duty with effect from 24.05.2019 to 06.08.2019 and 13.8.2019 to 21.08.2019 for a total period of 82 days, without any leave or prior permission of his seniors. Finally the enquiry Officer found him guilty of the charges leveled against him and recommended for major punishment. Thereafter, he was called in orderly room and heard in person but he failed to present any justification before the competent authority. (Copies of enquiry reports, Final Show Cause Notice & orderly room proceedings are attached as annexure "D, E,F & G").

- Incorrect. As explained in the preceding para above the appellant was proceeded against proper departmentally under relevant law/rules. The Charge Sheet was served upon him Jail through Superintendent Jail, which his thumb impression was obtained as token of it receipt, but he deliberately failed to submit his reply within stipulated period. (Copy of Charge Sheet attached herewith as annexure "H). It is worth to mention here that the appellant submitted an application on 08.08.2019 for obtaining of the copies of enquiry proceedings, which was allowed by the competent authority accordingly. (Copy of his application is attached as annexure "I").
- 6. Incorrect. The allegations are false and baseless. In fact the appellant was absolutely treated in accordance to law/rules within the meaning of constitution by giving him sufficient and proper opportunity at every level of defense and that the entire proceedings were carried out with existing law/rules. After fulfillment of all codal formalities the appellant was awarded major punishment of removal from service as per law/rules.
- 7. Incorrect. As the appellant was heard in person in orderly room, which he failed to convince the competent authority, hence the order of punishment was announced in the presence of appellant accordingly. Moreover, the judicial and departmental proceedings are two different entities and can run side by side. Furthermore, prior to involvement in criminal case the appellant has also been remained absent from lawful duty with effect from 24.05.2019 to 06.08.2019 and 13.08.2019 to 21.08.2019 for a total period of 82 days, without any valid leave or prior permission of his seniors, which he failed to present any justification before the appellate authority. Hence, departmental appeal submitted by the appellant was entertained and examined by the appellate authority in accordance to law/rules and rejected on merit. The copy of rejection order has already been conveyed to the appellant on his home address vide

- order Endst; No. 1173/EC, dated 09.12.2019, hence the instant service appeal is barred by law and limitation.
- 8. Incorrect. The revision petition submitted by the appellant before the respondent No. 01 was examined and rejected on the ground of time barred. Hence, the appellant has no cause of action to file the instant appeal.

GROUNDS:-

- 1) Incorrect. The orders passed by the respondent in the case of appellant are legally justified and in accordance with law/rules.
- Incorrect. The appellant being a member of disciplined force involved himself in illegal business of the smuggling of heroin, which he arrested with red handed from the spot by local police vide FIR quoted above. On the allegations of his involvement in the above criminal case, proper departmental enquiry was initiated against him under the relevant law/rules and the allegations leveled against him were fully established by the enquiry officer during the course of enquiry. Besides, it has also been pointed out that the appellant has also remained absent from his lawful duty for a long period of 82 days without any leave or prior permission of the competent authority. A proper and sufficient opportunity of defense in the shape of personal hearing has already been offered to the appellant, which he avail too, but he failed to prove himself innocent.
- Incorrect. The allegations are false and baseless. In fact, during the course of enquiry, the appellant was found guilty of the charges leveled against him otherwise the respondents have no any personal grudges with him. However, on departmental appeal the appellant was called in orderly room and heard in person by the appellate authority i.e respondent No. 02, but he failed to advance any cogent reason regarding his innocence.
- Incorrect. As explained in the preceding Paras above, that the appellant being involved in a moral turpitude nature offence was proceeded against proper departmentally in accordance to law/rules and the allegations leveled against him were fully established. Besides, during the course of enquiry a sufficient and proper opportunity at every level of defense in the light of natural justice has also been provided to the appellant, but he failed to present any justification regarding his innocence. The departmental appeal and mercy petition submitted by the appellant were thoroughly examined and rejected on sound grounds.
- Incorrect. The appellant being a member of disciplined force was found an irresponsible and indiscipline person as he involved himself in a moral turpitude nature activities i.e in the smuggling of drugs. However, he was proceeded against proper departmentally under the existence/relevant law/rules and awarded the penalty of removal from service in accordance to law/rules otherwise the respondents have no personal grudges with him.

- 6) Incorrect. As explained in the preceding paras above the competent authority i.e. respondent No. 03 was absolutely treated the appellant in accordance to law/rules as he was issued Charge Sheet alongwith Summary of Allegations and Enquiry Officer was nominated to probe into the matter, and after completion of enquiry a suitable and speaking order was passed by the competent authority in accordance with law/rules. Moreover the departmental appeal and revision petition submitted by the appellant were thoroughly examined and rejected on sound grounds. Hence, the respondents did not deprive the appellant from his legal rights.
- 7) Incorrect. The Para has already been explained in the preceding Para 06 above. However, all the orders passed by the respondents in the case of appellant are legally justified and in accordance with law/rules. Hence, the instant appeal may kindly be dismissed being devoid of merits.
- Incorrect. The appellant is not come to this Honorable Tribunal with clean hands. 8)
- 9) Incorrect. Each are decided on its own facts and merits.
- The respondents may also be permitted to raise additional grounds at the time of 10) arguments.

PRAYERS:-

Keeping in view the above facts and circumstances, it is most humbly prayed that the instant service appeal being not maintainable may kindly be dismissed with costs please.
