

**PARA WISE COMMENTS ON & FOR BEHALF OF
RESPONDENTS No.1 & 2.**

Respectfully Sheweth:-

PRELIMINARY OBJECTIONS.

1. That the Appellant is not the "aggrieved" person with the meaning of Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974.
2. That the Appellant has got no cause of action /locus standi to file this service appeal because the Appellant did not come on merit.
3. That the Appellant has not come to this Honorable court with clean hands rather than the instant service appeal is mainly based on malafide intentions just to put pressure on the respondent department for illegal promotion.
4. That the Appellant is estopped by his own conduct.
5. That the instant service appeal suffers from laches, hence not maintainable in the present form.
6. That the service appeal in hand is badly barred by the relevant provision of Law/Rules/Policy in Field.
7. That the instant appeal is liable to be dismissed for mis-joinder of unnecessary and non-joinder of necessary parties.
8. That the appellant was not fit for promotion due to lack of degree of B.Ed. which is pre requisite for promotion.

ON FACTS.

- 1) Para-1 of the facts pertains to appellant service records hence need no comments.
- 2) Para-2 of the facts pertains to record, need no comments.
- 3) Para-3 of the facts is accurate insofar as it pertains to the service of the appellant as a C.T. teacher. However, the remaining part of the para relates to the official record, specifically concerning the entry of the appellant's B.Ed. degree into the service book in the year 2023, subsequent to the issuance of the promotion order dated 01-12-2022.
- 4) Para- 4 of the facts pertains to record.
- 5) Para-5 of the facts is accurate, stating that the appellant was not eligible for promotion due to the absence of a B.Ed. qualification; consequently, he was not considered for promotion in 2022. The final seniority list has been duly published by the competent authority under notification No-6922-26, dated 7/03/2022 in accordance with established rules. Following official correspondence, this office is unable to make any modifications to the final seniority list. However, subsequently, the appellant submitted an appeal dated 27-12-2022, requesting the entry of his B.Ed. qualification. This appeal was accepted, and upon the provision of his B.Ed. transcript in the year 2023, the entry was duly made in his service book dated 6/01/2023. As a result, the appellant's name was included in the working papers and will be considered for promotion based on seniority-cum-fitness.


GROUND
