Reply to Grounds:


- A. Para No. A is incorrect, Respondent No. 1 being Settlement Officer always treats his sub ordinate equally.

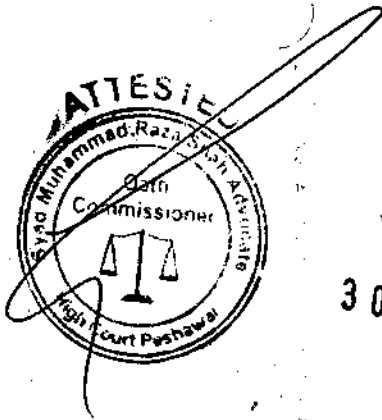
