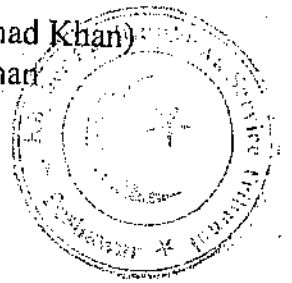

1. Learned counsel for the appellant present.
2. The learned counsel submitted that in the seniority list of 2017, the appellant was shown at Serial No.1086 while private respondent No.7 was shown at Serial No.1721 but in the provisional seniority list issued on 01.01.2023 the appellant was relegated in seniority and shown at Serial No.1006, whereas, private respondent was shown at Serial No.917. That the provisional list was challenged by the appellant by making representation and she then filed appeal before the Tribunal. That during the pendency of appeal, the official respondents issued final seniority list on 01.09.2023, circulated vide letter dated 03.10.2023, copy of the same had been placed on file. The learned counsel when confronted with the situation as to whether the appellant was aggrieved only from the private respondent No.7 or from others also, to which he sought time to check it with the appellant as well as with the record. To come up for preliminary hearing on 23.01.2024 before S.B. P.P given to the learned counsel.
