1. FACTS OF THE COMPLAINT:

- i. Brief facts of the case are that a citizen/ complainant namely Mr. Khadim Hussain sought information from the Irrigation Department, Peshawar as below:
 - 1) Nawab Ali , Chowkidar
 - 2) Said Ali Shah, Driver (ex-boiler)
 - 3) Amjad Ali (retired), Peon
 - 4) Sahib Shah (Retd), Peon,
 - 5) Wadood Patwari (Retrd)
 - 6) Esa Khan, Patwari (Retrd)
 - 7) Gul Muhammad, Driver (Retrd)

- i. The complaint was examined by the Commission vis-à-vis the various provisions/sections of the KP RTI Act 2013, and decided to direct the Public Body to submit the requisite information to the Commission. A series of correspondence were made between the Commission and the Public Body for the provision of information however, the Public Body failed to provide the requisite information which warranted personal hearing in the instant case. Thus; the Commission issued personal hearing notice to the Deputy Secretary (Technical)/PIO to explain the factual position.

- ii. Incompliance SDO attended the Commission and stated that the remaining information has been submitted to the Commission.
