### Comments On Behalf Of Respondents No.1 to 4.

#### RESPÉCTFULLY SHEWETH:

#### **PRELIMINARY OBJECTIONS:**

- 1. That the instant Service Appeal is not maintainable in the eyes of law.
- 2. That the Appellant has got no Cause of Action.
- 3. That the appellant has concealed the material facts from this Honourable Tribunal.
- 4. The Appellant has challenged the Promotion Order dated 08.08.2023, with unrealistic grounds.
- 5. That the Appellant is estopped by his own conduct to bring the present appeal before this honourable Tribunal.

#### **REPLY ON FACTS:**

- 1. Pertains to record.
- 2. Incorrect. It is clarified that vide order dated 30.05.2018 (Annex-I), 15 numbers of Assistants (BS-16) were promoted to the post of Superintendent (BS-17) on Acting Charge Basis (A.C.B) for which Senior Clerks (BS-14) were to be promoted on A.C.B to the post of Assistants (BS-16). The promotion Notification dated 11.02.2019 (on regular basis) was issued in line with decision of Departmental Promotion Committee (DPC) taken in its meeting dated 28.12.2018 (Annex-II). In the said meeting, the DPC was to consider promotion of seventeen (17) Senior Clerks (BS-14) to the post of Office Assistant (BS-16) on Acting Charge Basis. The DPC determined that Sub-Rule-2 of Rule-9 of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 (herein after referred as "APT rules") had been deleted hence instead of promotion on Acting Charge Basis; the Senior Clerks were promoted on Regular Basis.

- Incorrect. It is clarified that one, Mr. Ismail Khan, was directly recruited, on the 3. recommendation of Khyber Pakhtunkhwa Public Service Commission, in the Directorate of Prosecution, vide order dated 15.03.2019 (Annex-III) as Assistant on 15.03.2019 i.e. after the above mentioned promotion. He filed a Departmental Representation and objected over the above mentioned Promotion of Senior Clerks on Regular basis having adversely affected his Seniority. Home & Tribal Affairs Department vide letter dated 13.12.2022 (Annex-IV) sought opinion of Establishment Department upon the decision of DPC meeting dated 28.12.2018 regarding deletion of Rule 9(2) of APT Rules. The Establishment Department vide its letter dated 13.03.2023 (Annex-V) conveyed that DPC had mis-interpreted Rule 9(2) of APT Rules and advised that the promotion case may be re-submitted to DPC for resolving the issue. The matter was again placed before DPC, which, in its meeting dated 25.09.2023 (Annex-VI) reconsidered the matter and in light of the opinion of Establishment Department, recommended that 14 senior clerks, including the Appellant, be promoted on Acting Charge Basis, with effect from 11.02.2019 and thereby the impugned order dated 08.08.2023 was issued. It is pertinent to mention here that vide a recent Promotion order dated 18.10.2023 (Annex-VII), the Appellant alongwith some other Senior Clerks, have been promoted on Regular Basis, due to availability of vacant posts of Office Assistant BS-16.
- 4. The Departmental Appeals of the Appellant could not be concluded as the matter was under consideration before the DPC. In this regard a letter of Home & Tribal Affairs Department dated 19.09.2023 is (Annex-VIII).
- 5. Incorrect, hence denied. Reply of each ground given below.

#### **GROUNDS**

- i. Incorrect. Hence denied. Detailed reply already provided vide Para-02 and 03 of the para-wise reply.
- ii. As replied above.
- iii. Incorrect, the eligibility of the Appellant for Regular Promotion was not a valid ground for promotion at that time because of want of vacant posts of Assistants (BS-16) in the Directorate of Prosecution. Detailed reply already provided vide Para-02 and 03 of the Para-wise reply.
- iv. Incorrect hence denied. No right of Appellant is made out because the previous promotion, notified vide Order dated 11.02.2019, was overturned by DPC in its subsequent meeting.
- v. As replied above.
- vi. As already stated, the matter was under consideration before DPC.
- vii. The seniority lists were prepared in light of previous Order dated 11.02.2019. Fresh seniority lists were prepared in light of Order dated 08.08.2023 and DPC meeting dated 25.07.2023.
- viii. Incorrect, hence denied. Detailed reply already provided vide Para-02 and 03 of the Para-wise reply.
  - ix. As replied above.
  - x. As replied above.
  - xi. Incorrect hence denied.
- xii. The replying Respondents also seek permission to raise other grounds at time of arguments.

#### PRAYER:

In light of the above facts and circumstances of the case, the Service Appeal is devoid of any merit and legal substance; therefore, the same may kindly be dismissed, please.

#### RECOMMENDATIONS

5. The Departmental Promotion Committee recommended the above mentioned (28) acting charge Assistant (BPS-16) for promotion as Assistants on regular basis with immediate effect i.e. date of notification.

#### AGENDA ITEM NO.2: (Promotion of (01) acting charge Senior Scale Stenographer-BPS-16) on regular basis)

6. The forum was informed that there are two sanctioned posts of Serior Scale Stenographer (BPS-16) in the Directorate of Prosecution. However, only one post has been filled through appointment of Mr. Muhammad Zahid, Junior Scale Stenographer (BPS-14) on acting charge basis due to less tength of service. As per Service Rule, the post of Senior Scale Stenographer (BPS-16) is required to be filled by promotion from amongst the holder of the post of Junior Scale Stenographer (BPS-14) with at-least five years' service as such.

Mr. Muhammad Zahid, Junior Scale Stenographer (BPS-14) was initially appointed on 07.08.2018 in the Public Safety Commission of Home and Tribal Affairs Department He was appointed as Junior Scale Stenographer (BPS-14) in the Directorate of Prosecution on 17 12:2018 through proper channel. The required length of service for regular promotion to the post of Senior Scale Stenographer is five years as Junior Scale Stenographer.

> The representative of Establishment Department was of the view that the incumbent has not completed the required length of service as he has joined the present post on 18.12.2018. His previous service rendered in Public Safety Commission could not be counted for the purpose of seniority. Therefore, his case for regular promotion to the post of Senior Scale Stenographer is required to be dropped due to less length of service.
